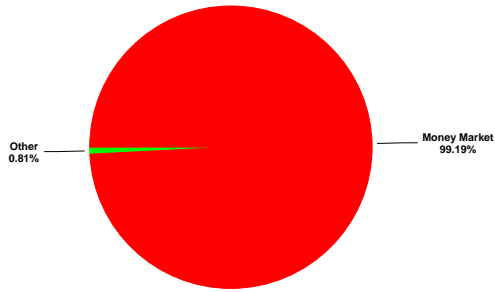

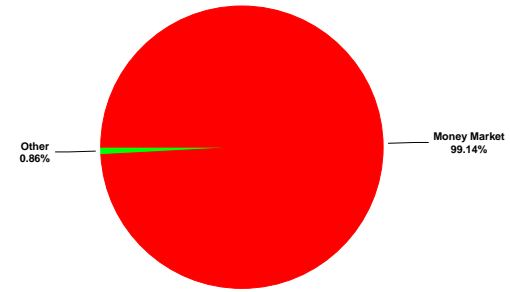

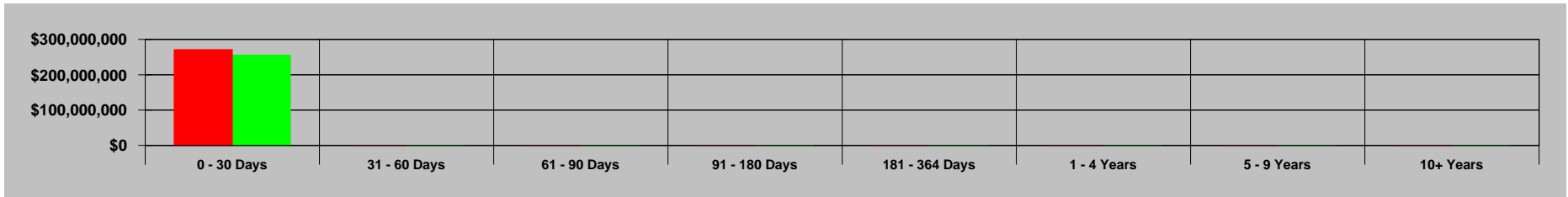
Portfolio Composition - 03/31/11



Portfolio Composition - 04/30/11

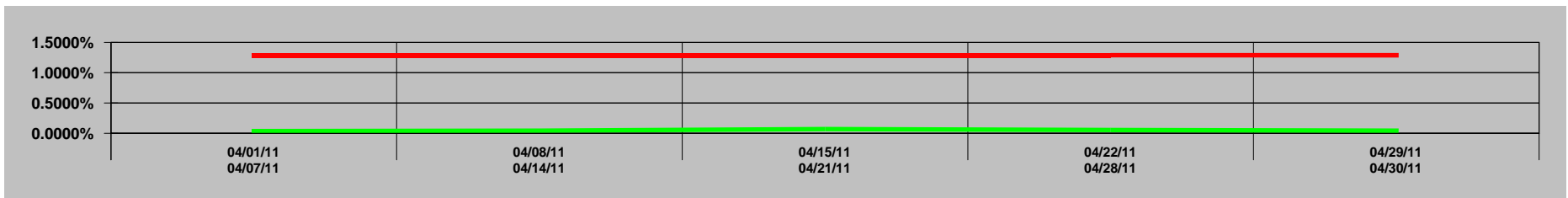


Maturity Aging - 03/31/11 vs 04/30/11

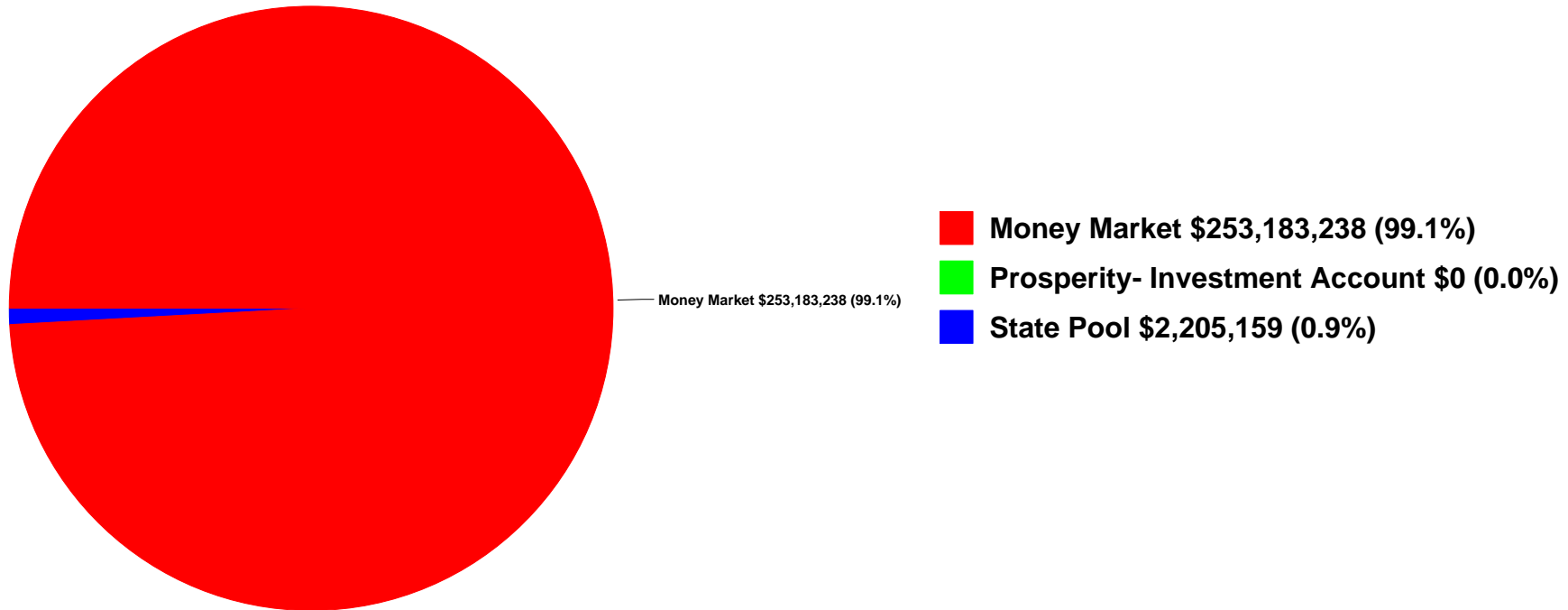

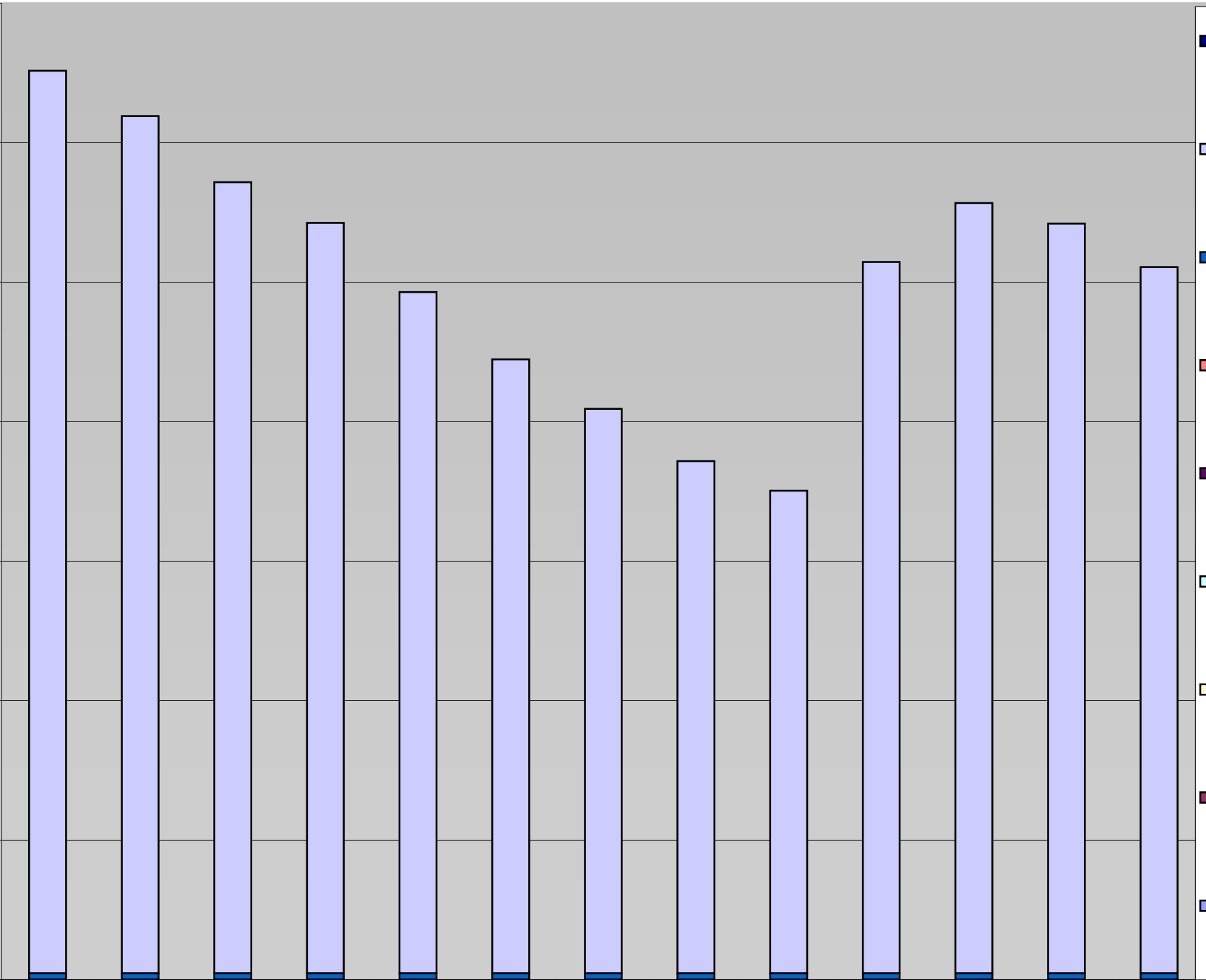

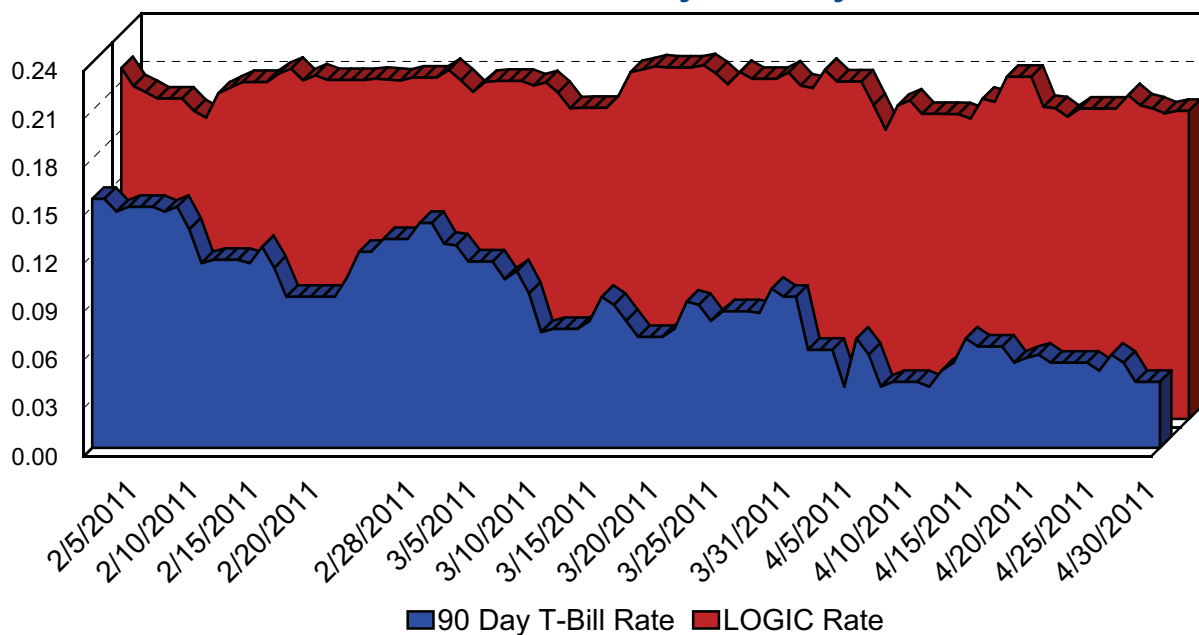
