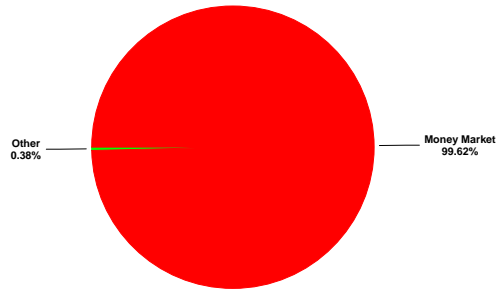

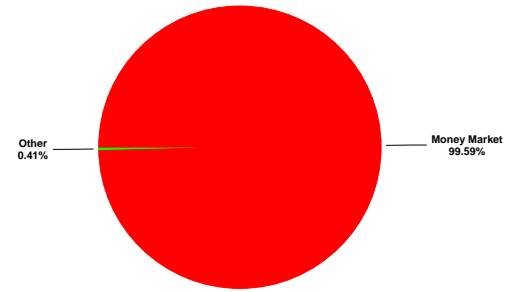

Portfolio Composition - 08/31/13

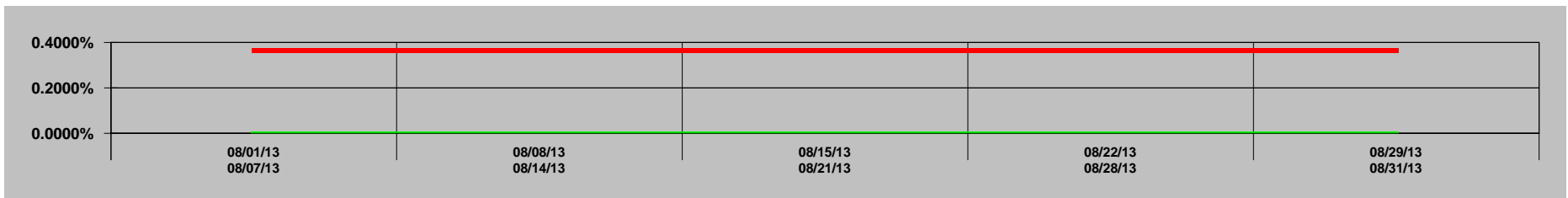


Maturity Aging - 07/31/13 vs 08/31/13

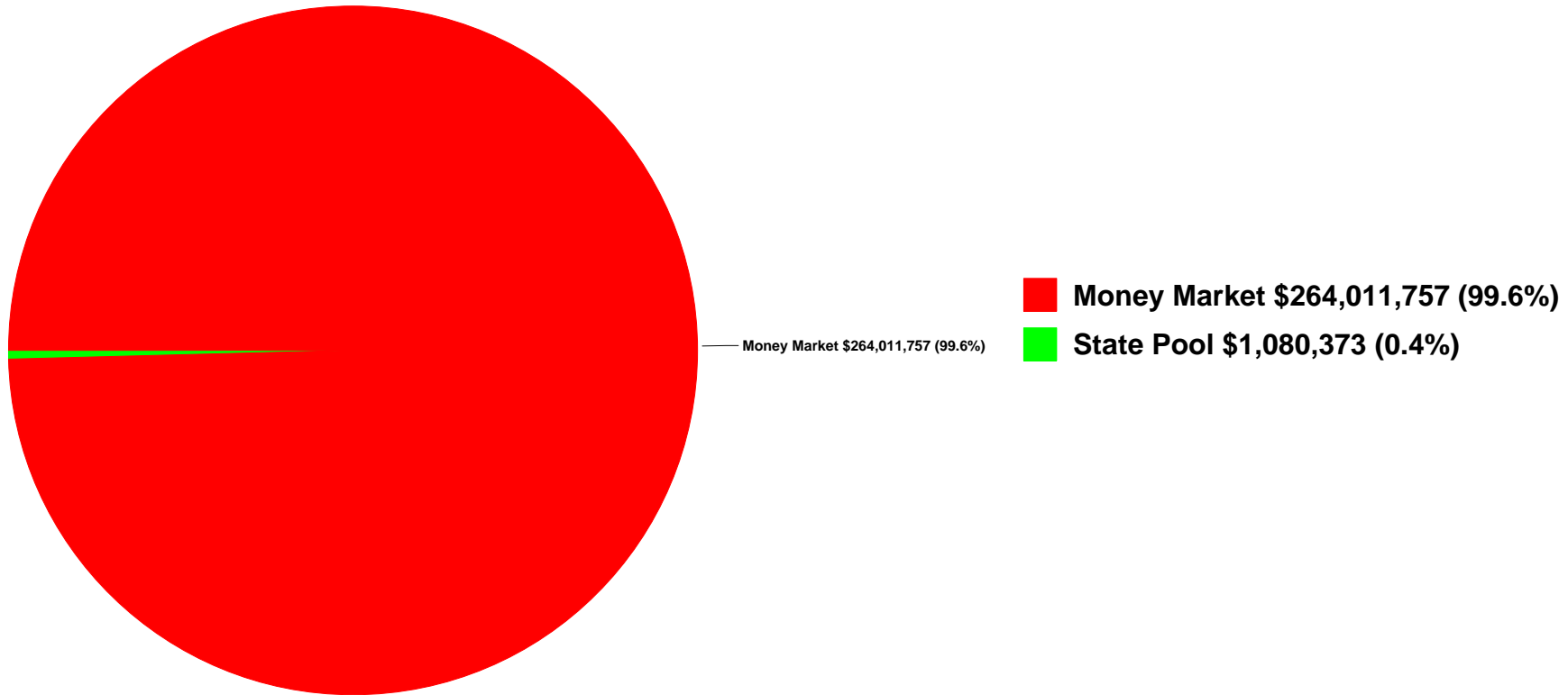

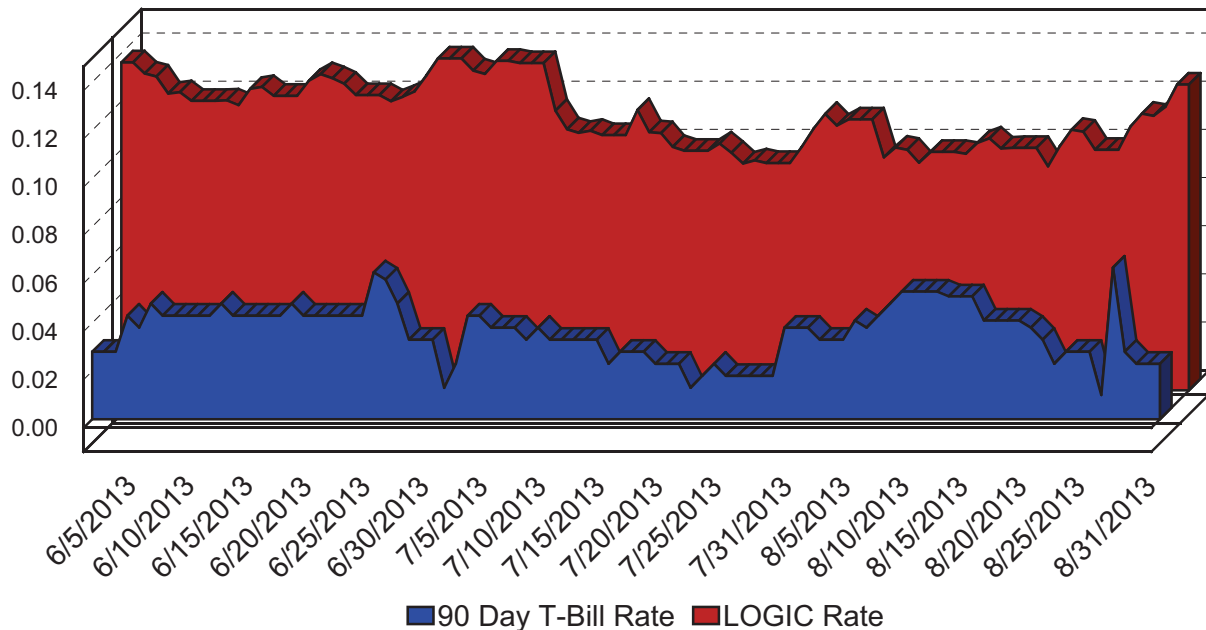
