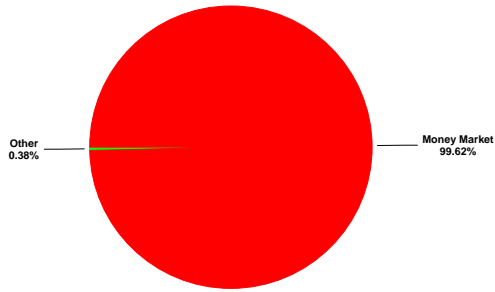

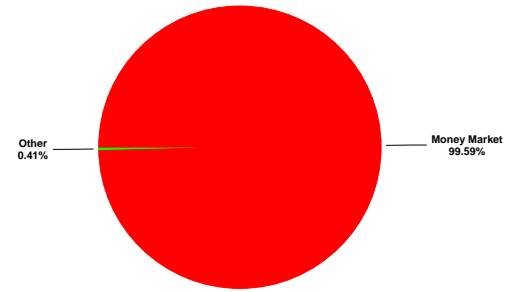

Portfolio Composition - 04/30/14

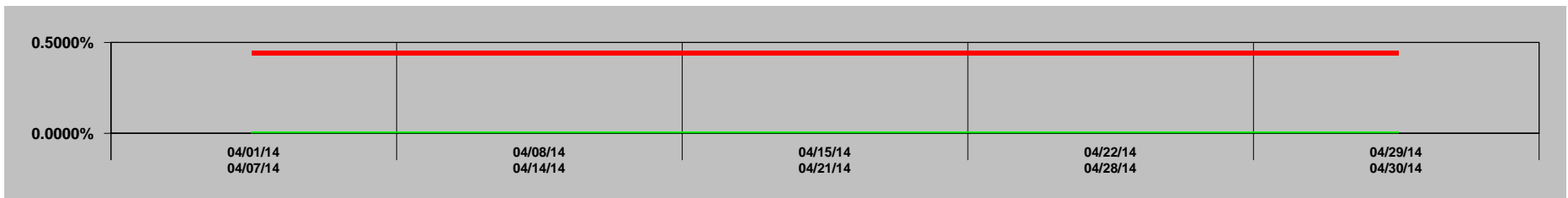


Maturity Aging - 03/31/14 vs 04/30/14

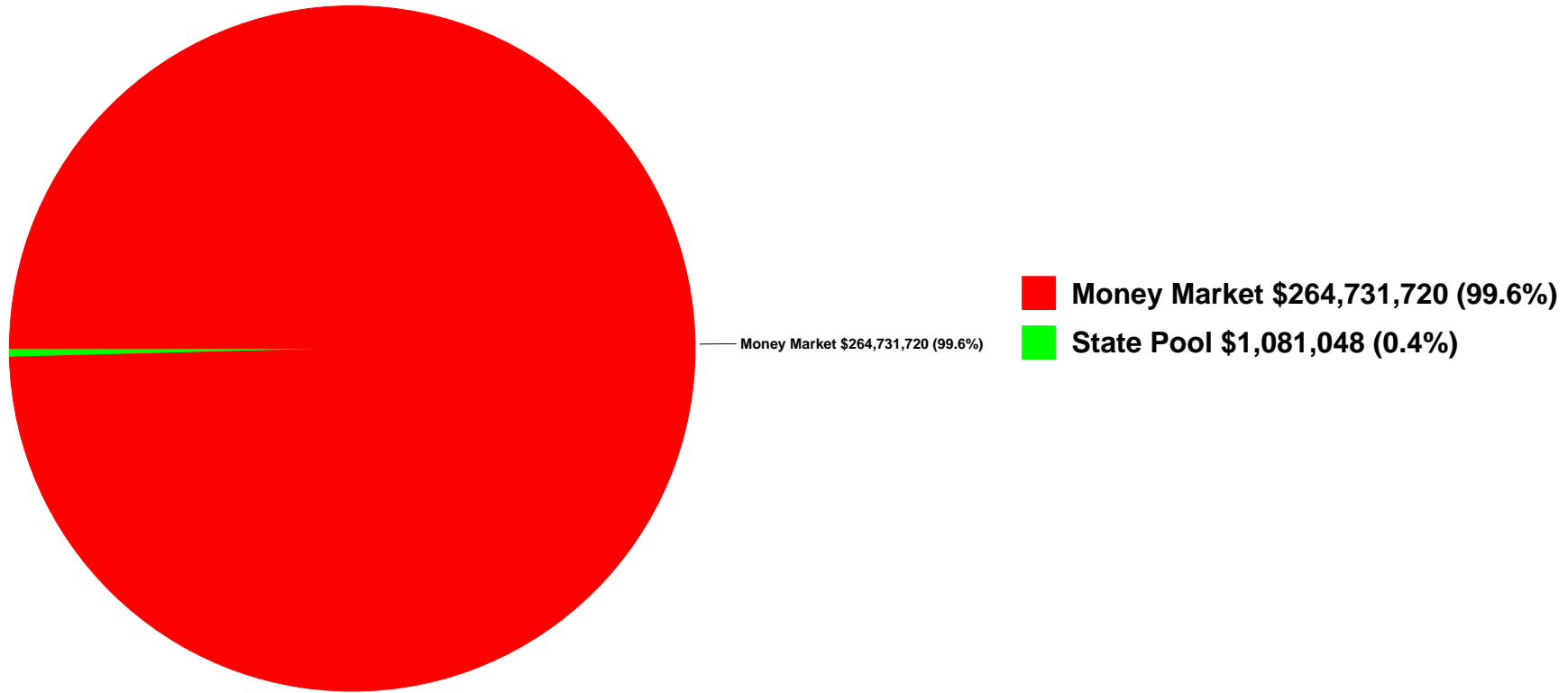

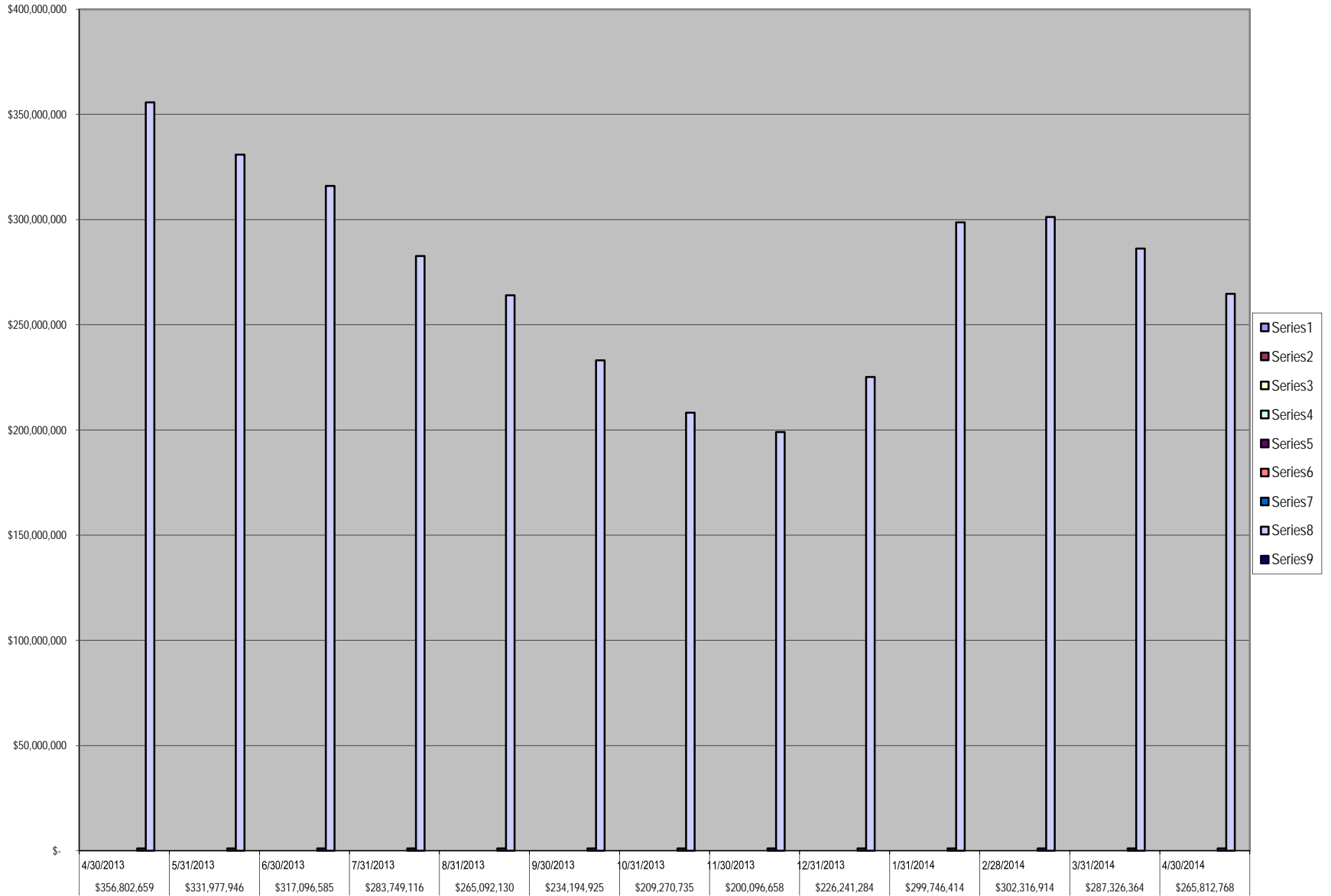

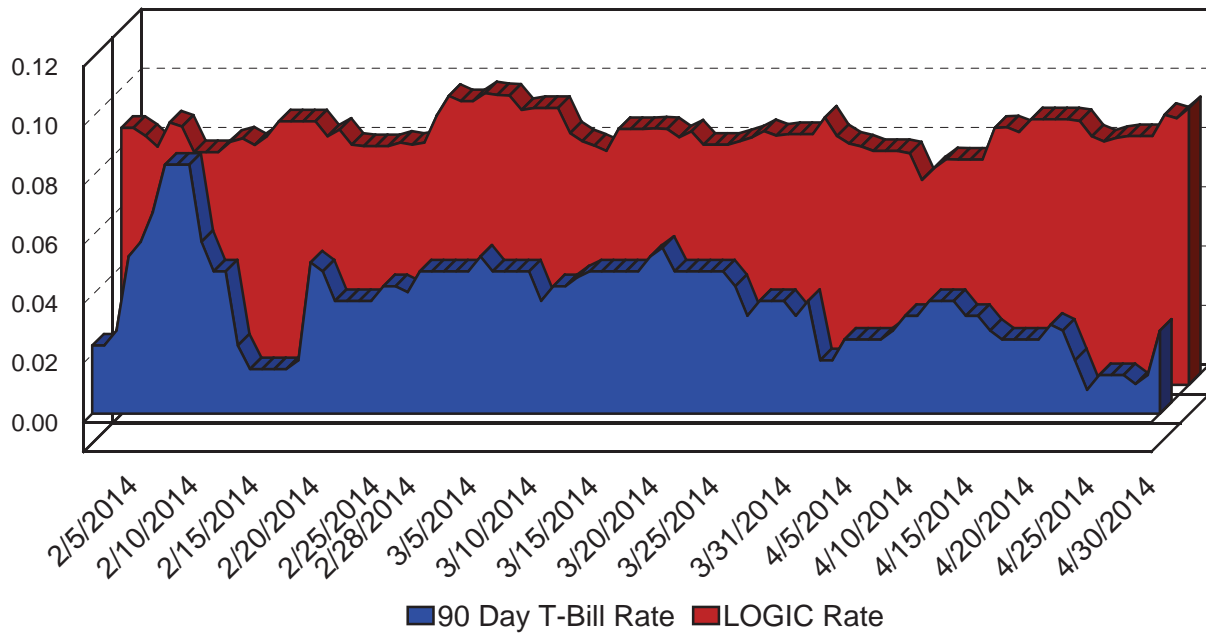
