BY ORDER OF LOCAL ADMINISTRATIVE JUDGE OF FORT BEND COUNTY:

IN ACCORDANCE WITH THE FORTIETH EMERGENCY ORDER REGARDING THE COVID -19 STATE OF DISASTER, AND PURSUANT TO SECTION 22.0035(b) OF THE TEXAS GOVERNMENT CODE, IT IS ORDERED THAT:

Pursuant to the Supreme Court Order Forty, issued July 19, 2021, The OCA's Best Practices Guidelines issued March 17, 2021, Guidance from the Centers for Disease Control and Prevention, and Local Guidance from Fort Bend County Health and Human Services, and subject to Constitutional limitations:

This Order readopts previously adopted local plans and extends the Minimum Standard Health Protocols in place. In-person proceedings are allowed when the Minimum Standard Health Protocols are followed. All courts will have the authority to modify or suspend any and all deadlines and procedures for a stated period ending no later than October 1, 2021.

Appropriate Face covering is defined as:

- *Medical procedure masks;
- *Masks made with tightly woven fabrics (cotton and / or cotton blends);
- *A piece of fabric fashioned to fit snugly upon the face, covering the mouth and the nose of the wearer;
- *Any mask must be sufficient to snugly cover the mouth and nose of the wearer.

ALL FORT BEND COUNTY COURTS shall act in ALL cases, and **MUST**, to avoid risk to staff, parties, attorneys, jurors, and the public require the wearing of masks / face coverings that provide coverage of the nose and mouth of ALL persons within their Courtrooms and facilities, except within the Judge's private chambers.

ALL PERSONS upon entering Fort Bend County Justice Center, or **ANY** facility under the Jurisdiction of this Local Administrative Order, including all Justice of The Peace Courts, **MUST** wear appropriate face covering.

ALL PERSONS including, County Employees, vendors, and visitors, **SHALL** wear appropriate face coverings continuously and at all times while inside these facilities, except where the person is within a private office, secured by a closed door, not open to the public, or general staff, or other Fort Bend County employees.

Consistent with the Fortieth Supreme Court Emergency Order,

All Fort Bend County Courts shall, or may require any person involved in a proceeding to participate remotely, by teleconference, video conference, or other means;

Without a participant's consent, require or allow remote hearings, consider sworn statements made out of court or sworn testimony given remotely, conduct proceedings away from the court, require participants to provide certain COVID-related information to the court, **and take any other reasonable action to avoid exposing court proceedings and participants to the threat of COVID-19;**

Modify certain procedures and deadlines in CPS cases for certain stated periods of time;

Require remote jury trials without consent, except inailable criminal cases where consent is required;

Fort Bend County has employed Healthcare Screeners, assigned to the Justice Center. These Screeners will be positioned at points of entry to greet visitors, staff, and all other persons. Upon entry and at the point nearest the entrance into facilities subject to this Local Administrative Order, every person shall be required to answer whether the participant / person seeking entry:

- * has Covid-19, or knows of another participant / person seeking entry, who has Covid-19;
- * has a fever, chills,
- * has a persistent cough,
- * has shortness of breath,
- * Is fatigued,
- * has muscle or body ache,
- * has an unusual headache,
- * has loss of taste or smell,
- * has vomiting, nausea, diarrhea,
- * has had any recent close contact with any person currently known to have tested positive for Covid-19 within the past fourteen (14) days.

ANY PERSON exhibiting or reporting Covid-19 symptoms will be turned away and instructed to contact the applicable court, or work department.

ANY PERSON with a temperature higher than 99.5 will not be allowed in **ANY** Fort Bend Court buildings.

JUDGES AND COURT STAFF SHALL NOT enter the Courthouse if they may have COVID-19 or have been exposed.

ALL COURTS AND STAFF are urged to work remotely whenever possible and feasible.

ALL COURTS shall limit the number of individuals on in-person dockets to twenty-four (24) per docket.

ALL JUDGES shall ensure social distancing guidelines are adhered to through-out the courthouse.

ALL COURTS shall ensure that hand sanitizer is readily available for visitors, jurors, and staff.

The following criteria have been set forth by the Center for Disease Control and Prevention in schools and it is hereby adopted for all Fort Bend County Courts, pursuant to guidance from the OCA, regarding opening the Courts to in-person proceedings:

This Order conforms to and adopts the protocols and procedures, as Ordered by the Fortieth Emergency Order regarding the COVID -19 State of Disaster, and pursuant to section 22.0035(b) of the Texas Government Code.
