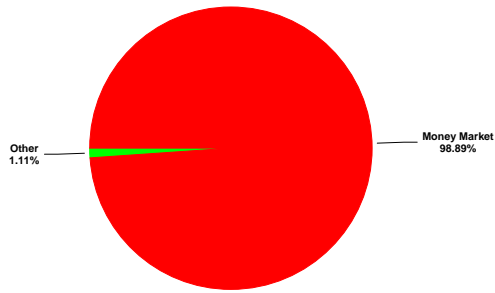

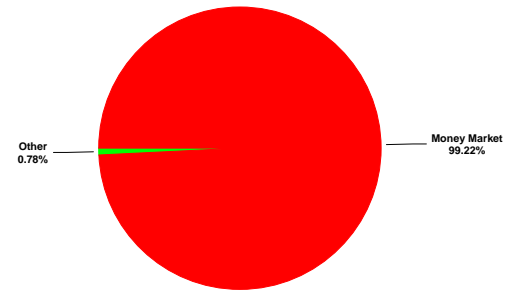

### Portfolio Composition - 05/31/12

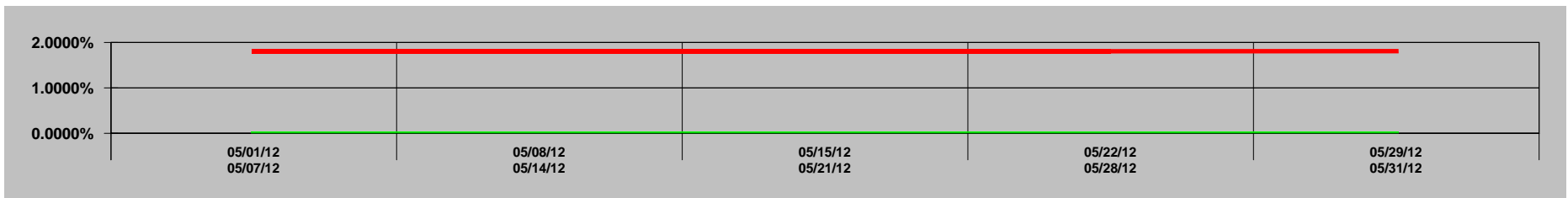


### Maturity Aging - 04/30/12 vs 05/31/12

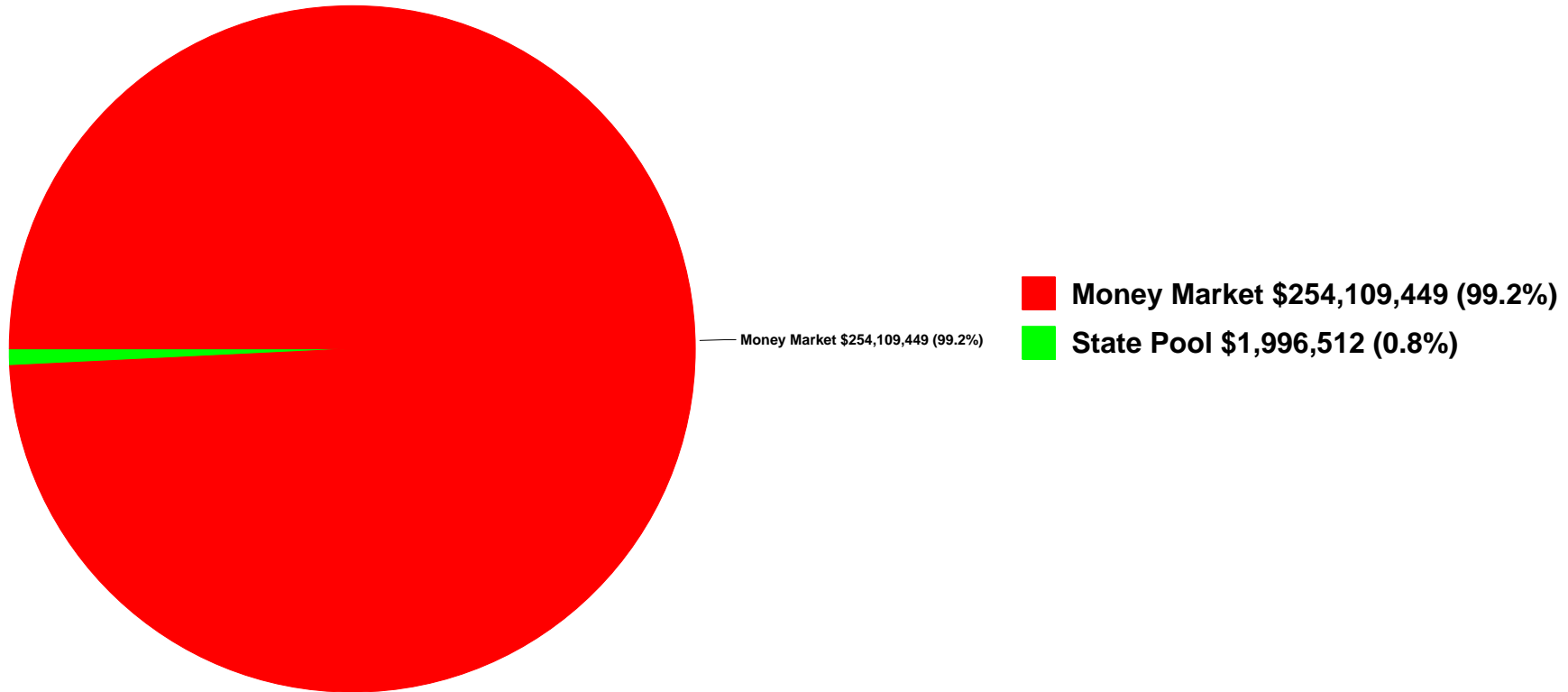

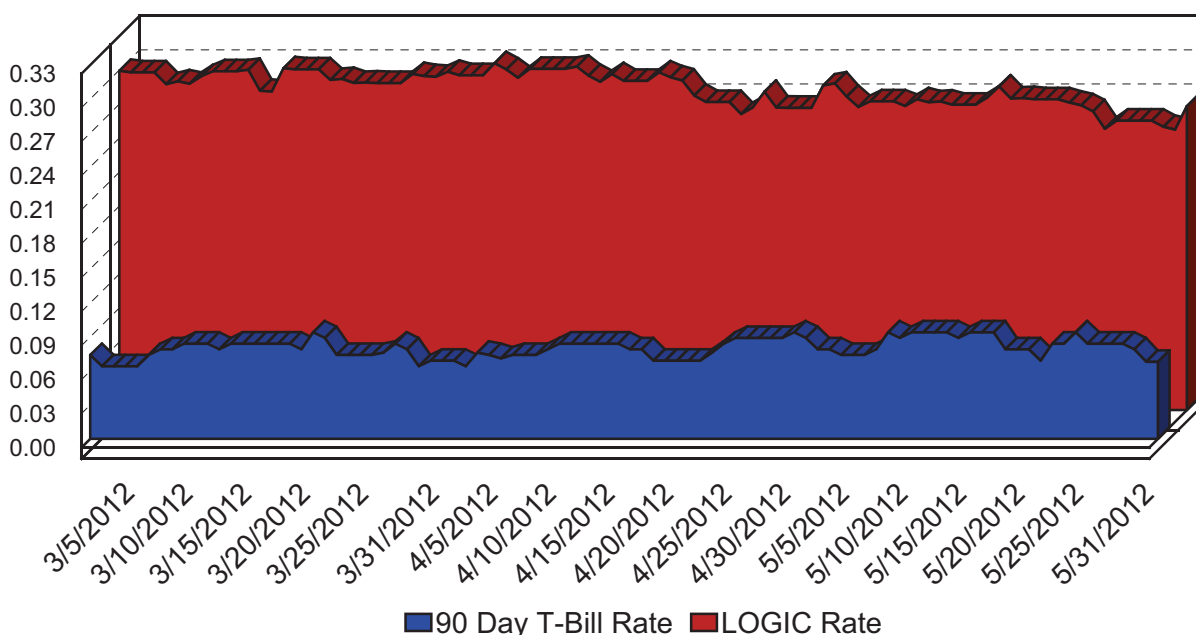
