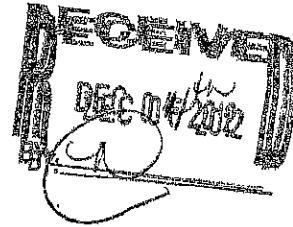

Sheriff Wright:

On November 13, 2012, the Civil Service Commission received your retraction notice dated October 30, 2012. After reviewing our records, it was noted that you offered the commission three separate exemption designation lists dated June 21, 2012 and two separate letters on September 20, 2012. In review, it was determined that said exemption designations were offered to Chief Deputy Brady, Majors Clements and Leach, Captains Becker, Burger, Colunga, Patton, Pokluda, Riendeau, Soland, Giendening and Rowland.

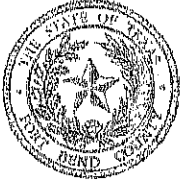
It is the commissions understanding that all the individuals offered exemptions have formally rejected the offer and have subsequently requested to remain as "Classified Employees" as defined in Exhibit A of the Rules and Regulations of the Civil Service Commission Version 1.4, dated October 17, 2012. Your letter dated October 30, 2012, further advises the commission that you retract all previous designations to anyone offered such exemptions.
