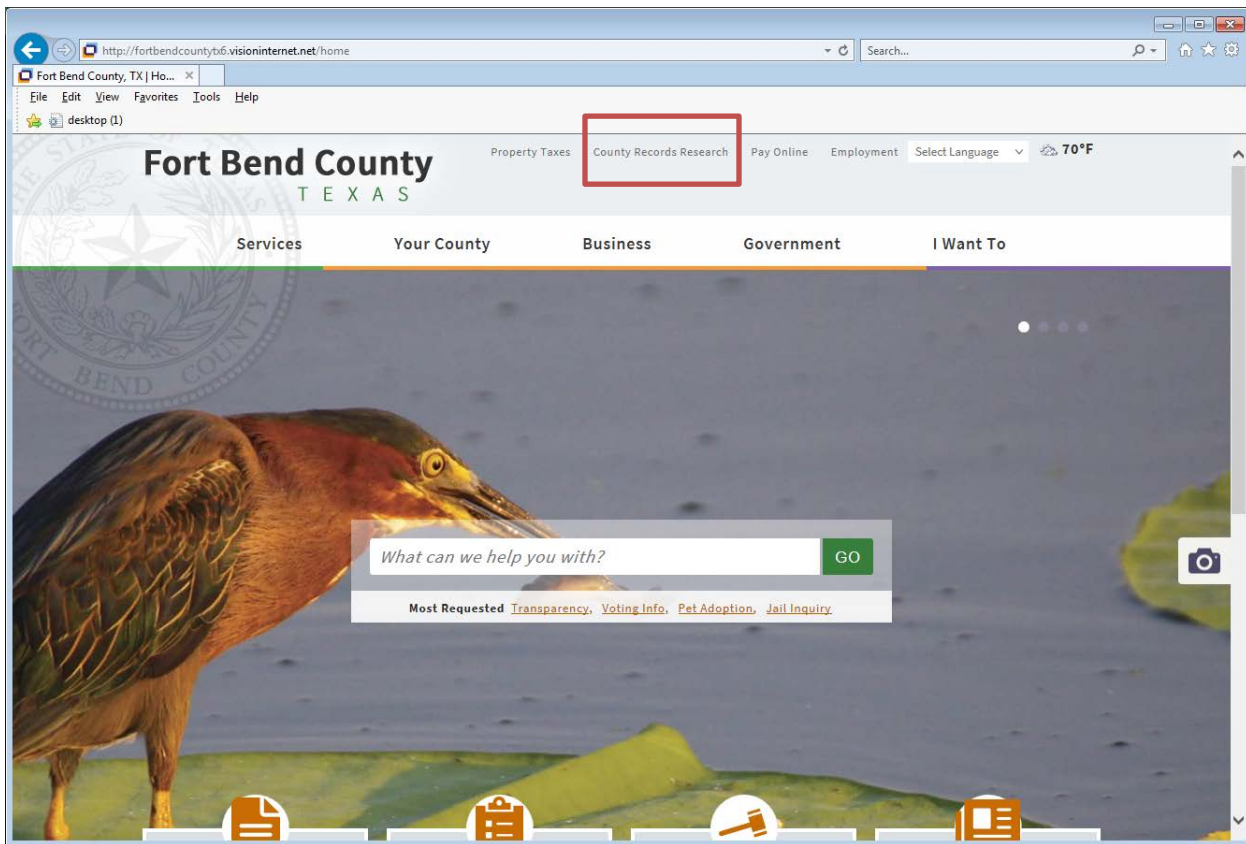


Instructions for Conducting a Misdemeanor *BOND* Search:

County Clerk Misdemeanor Free Standing Bonds

I. Main Fort Bend County Page

Go to: <https://www.fortbendcountytexas.gov/> and select “Criminal Records Research.” You will be directed to **Search Databases**.



II. Search Databases

Select **Misdemeanor**, located in **Court Records** section. You will be directed to **Case Records**.





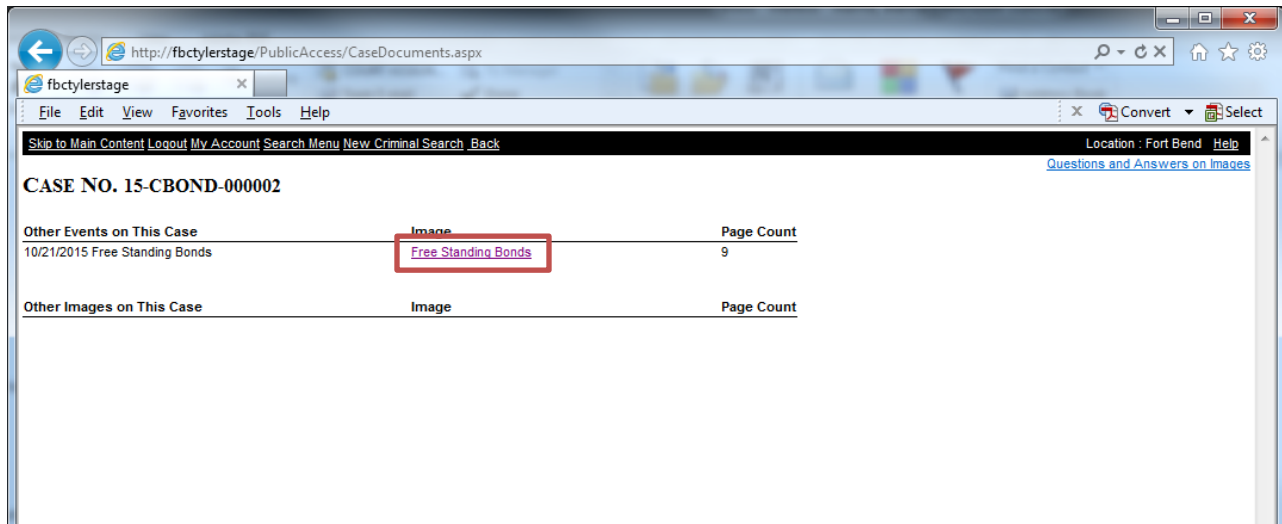
