## STATE AND COUNTY LICENSES FACILITIES PERMITS

**EFFECTIVE 2/22/2022**

The following fees are hereby established for obtaining permits from the Fort Bend County Fire Marshal's Office. Acceptable forms of payment are paper checks or money orders (made out to Fort Bend County). Fees will be paid prior to the start of the particular process for which the fee is charged. All fees paid to the Fort Bend County Fire Marshal's Office are non-refundable. A submittal is not considered complete until all required documentation, including payment, is received. The total fee for commercial building permits is made up from three separate fees; the plan review fee, the building permit and inspection fee, and the final inspection and Certificate of Compliance fee.

<b>Re-Inspection:</b> Re-inspection fee for State or County licensed Inspection will be same amount of the original permit paid prior to scheduling for a re-inspection. This fee will also be assessed for failure to show up for a scheduled fire inspection without prior notice or if a scheduled fire inspection is not canceled within 1/2 business day of the scheduled time and date. -

<b>Hospitals</b> Fee covers the application and review of the required documents and the initial inspection. All other requirements for application involving building and fire code regulations are separate permit application and process.		<b>\$200</b>		
<b>Life Safety Inspection Required by State Licensing Agency</b> This covers any inspection request for business needing an inspection for a state or county license.		<b>\$150</b>		
<b>Foster Home, Licensed/ Adoption</b> The application paperwork covers review of the required documents and the initial inspection. All other requirements for application involving building and fire code regulations are separate permit application and process.		<b>No Fee</b>
