## FIREWORKS - PERMIT APPLICATION EFFECTIVE 2/22/2022

The following fees are hereby established for obtaining permits from the Fort Bend County Fire Marshal's Office. Acceptable forms of payment are paper checks or money orders (made out to Fort Bend County). Fees will be paid prior to the start of the particular process for which the fee is charged. All fees paid to the Fort Bend County Fire Marshal's Office are non-refundable. A submittal is not considered complete until all required documentation, including payment, is received.

<b>New Permit for Calendar Year</b>	<b>Second Firework Season permit (No fee if same calendar year)</b>			
<b>Re-Inspection:</b>	Re-inspection fee will be paid prior to re-scheduling next inspection. The fee also covers failure to show up for a scheduled fire inspection without prior notice or if a scheduled fire, inspection is not canceled within 1/2-business day of the scheduled time and date. <b>-\$250</b>

	<b>Fireworks Stand (Annual Permit)</b> This fee covers the reviewing of State Permit and location of the stand. Less than 25,000 sq. ft.	<b>\$100</b>		
	<b>Fireworks stand (Annual Permit)</b> This fee covers the reviewing of State Permit and location of the stand. 25,000sq ft. to 100,000sq. ft.	<b>\$200</b>		
	<b>Firework Stand (Annual Permit)</b> This fee covers the reviewing of State Permit and location of the stand. More than 100,000 sq. ft.	<b>\$300</b>		
	<b>Fireworks Display Show</b> The fee is for the review of a proposed pyrotechnics or flame effect display, inspection of the proposed display site, and to verify the Pyrotechnician or Flame Effect Operators' license. This fee is applicable for any public or private fireworks display utilizing any class of regulated fireworks or flame effects devices (including "cold spark" effects). The fee does not include the fees for a Fire Watch that may be required by the Fire Marshal.	<b>\$200</b>		
	<b>Indoor Firework Stand</b> This fee covers plan review, inspections, and witnessing of the acceptance test for commercial paint/spray/mixing booth fire suppression systems.	<b>\$250</b>		
	<b>Work without Permit (Firework stand open without permit)</b> 3 X Regular Permit Fee	<b>\$****</b>		

Firework permit is required for the manufacture, storage, handling, sale or use of any quantity of explosives, explosive materials, fireworks or pyrotechnic special effects within the scope of 2021 International Fire Code Chapter 56. These fees do not include new buildings or locations that could fall under the Building Permit process needing a Certificate of Compliance from the Fire Marshal's Office.

All requirements for this permit must follow Fort Bend County's adopted fire code and Texas Local Government Code 233 and the annual inspection for both indoor and/or outdoor retail fireworks sites are to ensure compliance with the county's adopted fire code and state statutes in compliance with Texas Occupations Code 254. These fees are only charged once per calendar year for each retail fireworks site. This permit expires on January 31st to align with the State Retail Fireworks Permit. (No permits for retail accepted the month of January)
