

ORDER CALLING DIRECTORS ELECTION

BE IT ORDERED BY THE BOARD OF DIRECTORS OF GRAND LAKES MUNICIPAL UTILITY DISTRICT NO. 2 THAT:

Section 1: An election (the "Election") shall be held on the 7th day of May, 2022 ("Election Day"). At the Election there shall be submitted to the duly qualified resident voters of the aforesaid district (the "District") the matter of electing two (2) directors to the Board of Directors (the "Board") of the District.

Section 2: All qualified voters of the District shall be entitled to vote in the Election.

Section 3: The District hereby adopts by number, as its precincts for purposes of the Election, those election precincts established by Fort Bend County pursuant to Chapter 42, Texas Election Code, that overlap the District in whole or in part.

Section 4: The District has entered, or will hereafter enter, into written agreement(s) with Fort Bend County, Texas, for election services and for the purpose of conducting a joint election with other participating political subdivisions located, in whole or in part, in Fort Bend County, Texas, pursuant to Chapter 31 and Chapter 271, Texas Election Code (the "Joint Election Agreement"). The form(s) of the Joint Election Agreement are hereby approved in all respects. The President of the Board is hereby authorized to execute the Joint Election Agreement on behalf of the District. Any prior execution of the Joint Election Agreement by the President of the Board is hereby ratified and approved in all respects.

Section 5: As authorized by Chapter 31 and Chapter 271 of the Texas Election Code, and pursuant to the Joint Election Agreement, the Election shall be conducted by Fort Bend County, Texas. The District hereby appoints John Oldham, Fort Bend County Elections Administrator, to perform or to supervise the performance of any and all of the duties and responsibilities related to the conduct of the Election, as further specified in the Joint Election Agreement.

Section 6: As authorized by Chapter 31 and Chapter 271 of the Texas Election Code, and pursuant to the terms of the Joint Election Agreement, the District hereby appoints John Oldham, Fort Bend County Elections Administrator, as the Early Voting Clerk for the Election. Early voting by personal appearance for the eligible voters of the District shall be conducted at the locations and on the days and during the times set forth on Exhibit "A" attached hereto. Unless otherwise indicated on Exhibit "A", 4520 Reading Road, Rosenberg, Texas 77471 is hereby designated as the main early voting polling place. Applications for voting by mail shall be addressed to the Early Voting Clerk. The official mailing address and contact information of the Early Voting Clerk are as follows:

Section 7: Any eligible voter of the District may vote by personal appearance on Election Day, at the polling locations set forth on Exhibit "B" attached hereto. Voting by personal appearance on Election Day shall be conducted between the hours of 7:00 a.m. and 7:00 p.m., except as provided by Sections 41.032 and 41.033, Texas Election Code.

Section 8: Kris Eddlemon is hereby appointed as the District's designated election agent (the "Election Agent") to perform election duties required pursuant to the provisions of Section 31.123, Texas Election Code, and Section 49.109, Texas Water Code. The duration of appointment of such Election Agent shall be from the date hereof until a successor is appointed, and the office hours of such Election Agent shall be from 9:00 a.m. to 5:00 p.m. daily, except Saturdays, Sundays or official state holidays. True and correct copies of all documents and materials pertaining to the Election shall be maintained on file in the office of Election Agent at 1300 Post Oak Boulevard, Suite 2400, Houston, Harris County, Texas 77056, open to inspection by the public or any person interested therein.

Section 9: Written application to have a person's name printed on the ballot as a candidate for the office of director of the District must be received by the Election Agent on or after January 19, 2022, but not later than 5:00 p.m. on February 18, 2022. Declarations of write-in candidacy must be received by the Election Agent not later than 5:00 p.m. on February 22, 2022.

No person's name shall be placed on the ballot unless he or she: is eighteen (18) years of age or older as of May 7, 2022; is a citizen of the United States; is a resident of the State of Texas; either owns land subject to taxation in the District or is a qualified voter within the District; has not been determined mentally incompetent by a final judgment of a court; has not been convicted of a felony from which he or she has not been pardoned or otherwise released from the resulting disabilities; has filed a loyalty affidavit with the Secretary of the Board or the Election Agent; and is not otherwise disqualified from holding such office. The Secretary of the Board and the Election Agent are authorized to review filings by candidates and determine the qualifications of candidates for office. Any person not satisfied with said officer's ruling shall be authorized to appeal the decision to the Board.

Blank applications, declarations of write-in candidacy and copies of this Order may be obtained from the Election Agent.

Section 10: When the number of candidates exceeds the number of offices to be filled, the order in which the names of the candidates are to be printed on the ballot shall be determined by a drawing to be conducted by the Election Agent, who shall post notice in the District's office, at least seventy-two (72) hours prior to the scheduled time of the drawing, of the date, hour and place of the drawing, and shall also mail or e-mail notice of the date, hour and place of the drawing to each candidate, at the address or e-mail address, as applicable, stated on the candidate's application for a place on the ballot, not later than the fourth (4th) day before the day of the drawing. Each

candidate involved in the drawing, or his or her designated representative, shall have the right to be present and to observe the drawing.

Section 11: Pursuant to Sections 123.001 and 61.012 of the Texas Election Code, as amended, the District hereby adopts for use at the Election the Election Systems & Software EVS 6020 Voting System, consisting of the ExpressVote Ballot Marking Device, ExpressTouch Electronic Tabulation Device, DS-200 Precinct Tabulator, and DE-450 Central Scanner, for voting or early voting by personal appearance, as same has been certified by the Texas Secretary of State as an accessible direct recording electronic voting system. In addition, pursuant to Sections 123.006, 63.011 and 125.006, Texas Election code, the District authorizes the use of paper ballots to the extent necessary in connection with balloting by mail, provisional balloting, or in the event that an emergency prevents the use of the aforesaid direct recording electronic voting systems.

Ballots shall conform to the requirements of the Texas Election Code and be prepared and made available to voters in the English and Spanish languages.

Ballots shall have printed thereon the names of the candidates for the office of director. A qualified voter may vote for any two (2) or fewer persons for the office of director.

Section 12: This Order shall constitute the order for the calling of the Election and shall also constitute notice of the Election. The Election Agent is hereby authorized and directed to (i) deliver notice of the Election to the County Clerk and Voter Registrar of Fort Bend County, Texas, and/or the Elections Administrator of Fort Bend County, Texas, as applicable, not later than sixty (60) days before Election Day, and (ii) cause notice of the Election to be given by posting copies of this Order at a public place in each election precinct that is in the jurisdiction of the District, with said postings to be completed not later than twenty-one (21) days before Election Day (unless said day is a Saturday, Sunday or official state holiday and in which case it shall be posted on the next regular business day). Additionally, the Election Agent is hereby authorized and directed to cause this Order to be posted on the District's website (www.grandlakesmud2.com), during the twenty-one (21) days before Election Day. In all such instances, copies of this Order shall be posted in the English and Spanish languages. Further, the Election Agent is hereby authorized and directed, to the extent applicable and if possible, to cause a notice to be posted at the entrance of the polling place for the District's previous election, which notice shall state that the polling location has changed and shall provide the location of the new polling place, all in accordance with applicable law.

Section 13: The Election shall be held and conducted and returns made to this Board in accordance with the laws of the State of Texas, including but not limited to, applicable provisions of the Texas Election Code and the Texas Water Code.

Section 14: The Board officially finds, determines and declares that this Order was reviewed, considered and adopted at a meeting of the Board beginning at 11:00 a.m., Houston, Texas time on January 17, 2022, and that a sufficient written notice of the date, hour, place and subject of this meeting was posted at the District's administrative office and at a place readily accessible and convenient to the public within the District and was timely furnished to the County Clerk of Fort Bend County, Texas, for posting on a bulletin board located at a place convenient to the public in the Fort Bend County Courthouse for the time prescribed by law preceding this

meeting, as required by the Open Meetings Law, Chapter 551, Texas Government Code, and Section 49.063, Texas Water Code, and that this meeting has been open to the public, as required by law, at all times during which this Order and the subject matter hereof has been discussed, considered and acted upon. The Board further ratifies, approves and confirms such written notice and the contents and posting thereof.


Section 15: The Board hereby reserves the right to amend or supplement this Order as deemed necessary and appropriate. The Board further reserves the right to cancel the Election if and as allowed in accordance with the provisions of Chapter 2, Subchapter C, Texas Election Code.

Section 16: Unless expressly provided otherwise, all references herein to the Texas Election Code or to the Texas Water Code shall mean and refer to such laws as amended and in effect as of the date this Order is passed and adopted.

Section 17: The President or Vice-President and Secretary or Assistant Secretary of the Board and the Election Agent are each hereby authorized and directed to take any action necessary to carry out the provisions of this Order. Further, the Election Agent, with the consent of the President of the Board, shall be authorized to correct Exhibit "A" and Exhibit "B" attached hereto to reflect any changes by Fort Bend County to the early voting polling information, including the main early voting polling place, and Election Day polling information set forth thereon, without need for amendment of this Order by the Board.



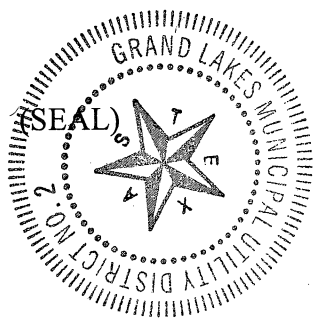

Sección 1 Se celebrará una elección (la "Elección") el 7 de mayo de 2022 ("Día de Elección"). En la Elección se presentará a los votantes residentes debidamente habilitados del mencionado distrito (el "Distrito") el asunto de elegir dos (2) directores para la Junta Directiva (la "Junta") del Distrito.

Sección 2: Todos los votantes habilitados del Distrito tendrán derecho de votar en la Elección.

Sección 3: Por la presente, el Distrito adopta por número, como sus precintos a los efectos de la Elección, aquellos precintos electorales establecidos por el Condado de Fort Bend en virtud del Capítulo 42 del Código Electoral de Texas, que se superpongan con el Distrito en forma total o parcial.

Por la presente, se ratifica y aprueba a todo efecto toda firma previa del Convenio de Elecciones Conjuntas por parte del Presidente de la Junta.

Sección 5: Como lo autorizan el Capítulo 31 y el Capítulo 271 del Código Electoral de Texas, y en virtud del Convenio de Elecciones Conjuntas, la Elección será celebrada por el Condado de Fort Bend, Texas. Por la presente, el Distrito designa a John Oldham, Fort Bend County Elections Administrator, para realizar o supervisar el cumplimiento con todas y cada una de las obligaciones y responsabilidades relacionadas con la celebración de la Elección según se especifique adicionalmente en el Convenio de Elecciones Conjuntas.

Sección 6: Como lo autorizan el Capítulo 31 y el Capítulo 271 del Código Electoral de Texas, y en virtud de los términos del Convenio de Elecciones Conjuntas, por la presente, el Distrito designa a John Oldham, Fort Bend County Elections Administrator, como Oficial de la Votación Anticipada de la Elección. No se colocará el nombre de ninguna persona en la boleta de votación a menos que: tenga dieciocho (18) años de edad o más para el 7 de mayo de 2022; sea ciudadano de Estados Unidos; sea residente del Estado de Texas; sea propietario de terreno sujeto a impuestos en el Distrito o sea un votante habilitado dentro del Distrito; no haya sido declarado mentalmente incompetente por el fallo de un tribunal; no haya sido condenado por un delito mayor del cual él o ella no haya sido indultado o librado de alguna otra forma de las discapacidades resultantes; haya presentado una declaración jurada de lealtad ante el Secretario de la Junta o ante el Agente Electoral; y no esté inhabilitado de alguna otra forma para ocupar dicho cargo. El Secretario de la Junta y el Agente Electoral están autorizados a revisar las postulaciones de los candidatos y a determinar los requisitos de los candidatos para ocupar el cargo. Toda persona que no esté conforme con la determinación de dicho funcionario estará autorizada a apelar la decisión ante la Junta.

El Agente Electoral puede proveer solicitudes en blanco, declaraciones de candidatura por escrito y copias de esta Orden.

Sección 10: Cuando el número de candidatos supera el número de cargos a ocupar, el orden en el cual aparecerán impresos los nombres de los candidatos en la boleta de votación será determinado por un sorteo realizado por el Agente Electoral, quien colocará un aviso en la oficina del Distrito, al menos setenta y dos (72) horas antes de la hora programada del sorteo, con la fecha, la hora y el lugar del sorteo y además enviará por correo o correo electrónico este aviso con la fecha, la hora y el lugar del sorteo a cada candidato, a la dirección o dirección de correo electrónico, según corresponda, indicada en la solicitud del candidato de un lugar en la boleta de votación, a más tardar el cuarto (4.^{to}) día antes del día del sorteo. Cada candidato que participe del sorteo, o su representante designado, tendrá derecho a estar presente y observar el sorteo.

Sección 11 En virtud de las Secciones 123.001 y 61.012 del Código Electoral de Texas y sus enmiendas, por la presente, el Distrito adopta para uso en la Elección el Election Systems & Software EVS 6020 Voting System, formado por el ExpressVote Ballot Marking Device, ExpressTouch Electronic Tabulation Device, DS-200 Precinct Tabulator, y DE-450 Central Scanner, para la votación o la votación anticipada en persona, según ha sido certificado por la Secretaría del Estado de Texas como un sistema de votación electrónica de registro directo y fácil acceso. Además, en virtud de las Secciones 123.006, 63.011 y 125.006 del Código Electoral de Texas, el Distrito autoriza el uso de boletas de votación de papel en la medida necesaria en relación con la votación por correo, para los votos provisionales, o en el caso de que una emergencia impida el uso de los mencionados sistemas de votación electrónica de registro directo.

Las boletas de votación cumplirán con los requisitos del Código Electoral de Texas y se prepararán y estarán disponibles para los votantes en los idiomas inglés y español.

Las boletas tendrán impreso los nombres de los candidatos para el cargo de director. Los votantes habilitados pueden votar por cualesquiera dos (2) personas o menos para el cargo de director.

Sección 12: Esta Orden constituirá la orden para convocar la Elección y constituirá también el aviso de la Elección. Por la presente, se autoriza e instruye al Agente Electoral a (i) que dé aviso de la Elección al Secretario del Condado y Registrador de Votantes del Condado de Fort Bend, Texas, y/o Administrador de Elecciones del Condado de Fort Bend, Texas, según corresponda, no más tarde de sesenta (60) días antes del Día de Elección y (ii) dé aviso de la Elección mediante la colocación de copias de esta Orden en un lugar público en cada precinto electoral dentro de la jurisdicción del Distrito, colocaciones que deben completarse a más tardar veintiún (21) días antes del Día de Elección (a menos que ese día sea sábado, domingo o feriado oficial del estado, en cuyo caso se colocará el siguiente día laborable común). Además, por la presente, se autoriza e instruye al Agente Electoral a hacer que esta Orden se coloque en el sitio web del Distrito (www.grandlakesmud2.com), durante veintiún (21) días antes del Día de Elección. En todos los casos, las copias de esta Orden deberán colocarse en inglés y español. Además, por la presente, se autoriza e instruye al Agente Electoral, en la medida que corresponda y de ser posible, a colocar un aviso en la entrada del lugar de votación de la elección anterior del Distrito, en el que se indique que el lugar de votación ha cambiado y se proporcione la ubicación del nuevo lugar de votación, todo en conformidad con la ley aplicable.

Sección 13: La Elección se celebrará y realizará, y se dará el dictamen de los resultados a esta Junta en conformidad con las leyes del Estado de Texas, incluidas a título enunciativo pero

no limitativo, las disposiciones aplicables del Código Electoral de Texas y del Código de Agua de Texas.

Sección 14: La Junta oficialmente halla, determina y declara que esta Orden fue revisada, considerada y adoptada en una asamblea de la Junta que comenzó a las 11:00 a.m., hora de Houston, Texas el 17 de enero de 2022 y que se colocó un aviso escrito suficiente de la fecha, el horario, el lugar y el asunto de esta asamblea en la oficina administrativa del Distrito y en un lugar de fácil acceso y cómodo para el público dentro del Distrito y que fue entregado oportunamente al Secretario del Condado del Condado de Fort Bend, Texas, para colocación en un tablero de anuncios ubicado en un lugar cómodo para el público en el Tribunal del Condado de Fort Bend por el periodo prescrito por ley precedente a esta asamblea, como lo requiere la Ley de Asambleas Públicas, Capítulo 551 del Código de Gobierno de Texas y la Sección 49.063 del Código de Agua de Texas, y que esta asamblea ha estado abierta al público, como lo exige la ley, en todo momento durante el cual se ha debatido, considerado y actuado en relación a esta Orden y el asunto de la misma.
