

AFFIDAVIT FOR EXEMPTION FROM JURY DUTY
FOR INABILITY TO COMPREHEND ENGLISH

Government Code Section 62.109 allows for a permanent exemption or a temporary exemption from jury service based upon a person's inability to comprehend the English language. The exemption may be granted by the District Clerk/District Judge once an affidavit is received from the Applicant/Affiant. The Applicant/Affiant must bring this completed affidavit along with their interpreter to the District Clerk's Office for submission. The Applicant/Affiant will be notified if the request is approved or denied.
