FORT BEND County is recognized as one of the leading counties in its reporting, uses of funds and programs developed to respond to the direct public health and economic impacts of COVID-19.

MPACT Strategic Consulting has been an essential and trusted partner of Fort Bend County and its local municipalities, non-profits and residents since 2019.


MPACT, since Day 1 of the emergency shut-down Executive Order, has provided technical assistance, program design, program launch, subrecipeint monitoring and financial oversight for over 100 COVID-19 projects and grant awards initiated and approved by the Court and local entities.

TIMELINE OF EVENTS





Rental / Mortgage Utilities (CARES/ERA/ARPA)



- ✓ Over \$46.5 Million in direct financial assistance
 - \$42.5 Million in Rental and Mortgage payments
 - \$4.5 Million in Utility payments
- ✓ Over 15,000 applicants to program
- ✓ Over 9,080 individual County residents received assistance
- ✓ Over 1,500 Evictions avoided
 - ✓ Over \$3 million in evictions cases adjudicated.
 - ✓ JP Court #2 assistance was \$2.5 million



Small Business Assistance Programs (CARES/ARPA)



- ✓ Over \$48 Million in direct assistance allocated
- √ \$15,000 Average Grant Award
- ✓ Over 4,500 Grants provided (total of grants and regrants)
- ✓ Over 2,961 business assisted
- ✓ Over 14,000 employee jobs protected
- ✓ Over 119 new hires eligible for Incentive Payments

MPACT has assisted in administering over \$92 Million in Direct Assistance Payments to FBC Residents and Businesses



Local Government and Subrecipeint Reimbursement



- ✓ Over \$14,471,108 in direct reimbursement assistance
- ✓ Approximately \$20,159,862.64 in CARES Act Other Category (ISDs, Uncompensated Care, Boys/Girls Club, YMCA) reimbursement reviewed and approved to date
- ✓ Approximately \$17,011,315.91 in CARES Act Local Government reimbursement reviewed and approved to date

✓ CDBG-CV

- Approximately 1,361 Rent and Utility Assistance Payments
- Approximately \$1,197,733 in total assistance

✓ Childcare Voucher Program

- \$715,000 Total Grant Awarded
- 737 Total Children Assisted (Vouchers Issued)

✓ We All Eat - Food Distribution Program

- \$4.1M in total benefits to FBC restaurants and families impacting food insecurity and nutrition.
- **572,726** Meals Served
- 1,980 Unique Household Assisted
- 3,577 Total Applicants




MPACT has audited and approved local reimbursements over \$100M that comply with CARES ACT requirements







Fort Bend County Assistance Programs Dashboard


















ARPA / ERA vs CARES Act

There are some key difference in CARES Act vs ERA and ARPA that impacted how the programs could be implemented

- ❖ Prioritizes use of funds to Low- and Moderate-Income (LMI) communities (80%LMI or Below).
- Providing services to populations, households, or geographic areas disproportionately impacted by the pandemic.
- ❖ Aid provided to tourism, travel, and hospitality industries
- Non-Profits (similar to Small Businesses) can now be funded through the County's allocation as long as they meet eligibility criteria.
- Vaccine and "Back to Work" Incentives are allowable.
- Revenue Loss due to the impact of COVID-19 can be allocated to local governments
- Investments in Broadband, Water and Sewer have been approved.

Program Snapshots

FORT BEND COUNTY ENTREPRENEUR PROGRAM

Highlights/Major Accomplishments

- > 95% of all small businesses that participated in the program are still operating
- > On schedule to give out more than \$475,000 in small business grants
- ➤ Recruited a diverse make up of business participants including Veterans, Women-Owned, LGTBQ Owned and Minority Owned.
- ➤ Orchestrated the first ever Fort Bend County Business Accelerator graduation for over **95** businesses at the Landmark Community Center.
- ➤ Obtained bi-partisan support of the program through 2020-2021.



 \$2.5 million dollars alone to evictions that have been filed and prevented


 Partnered with All five JP Courts to process applicants prior to judgement


