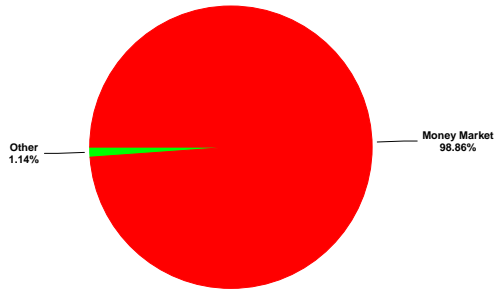

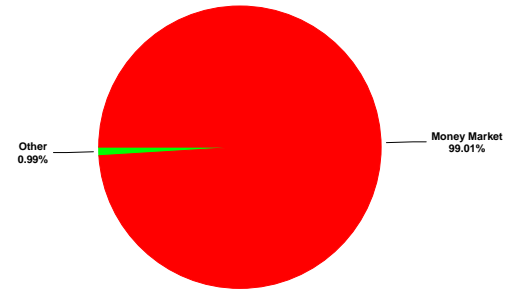

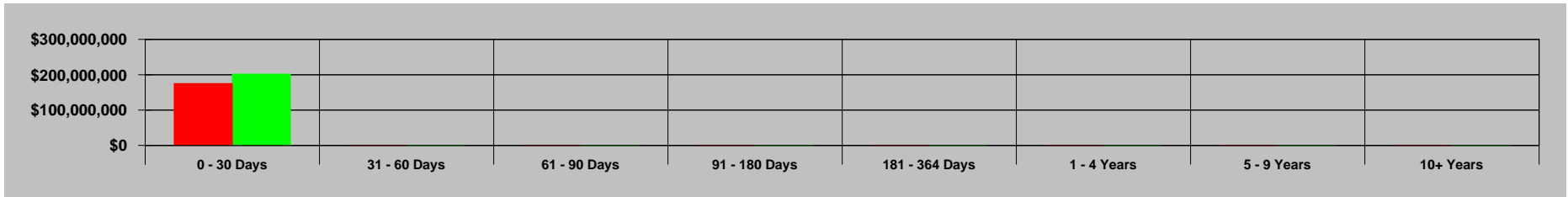
Portfolio Composition - 01/31/12



Portfolio Composition - 02/29/12

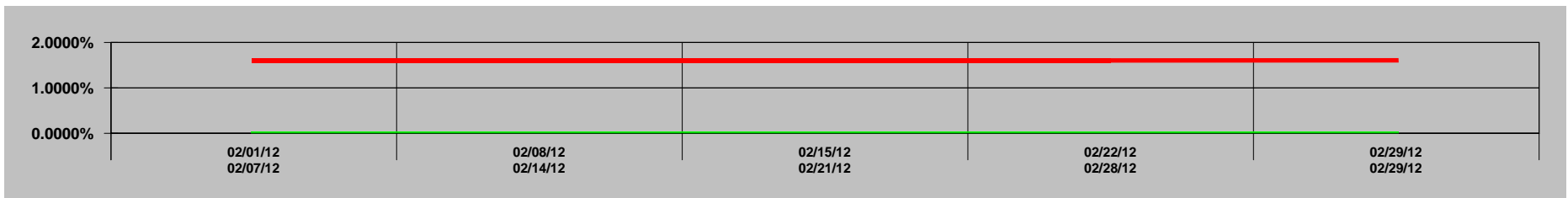


Maturity Aging - 01/31/12 vs 02/29/12

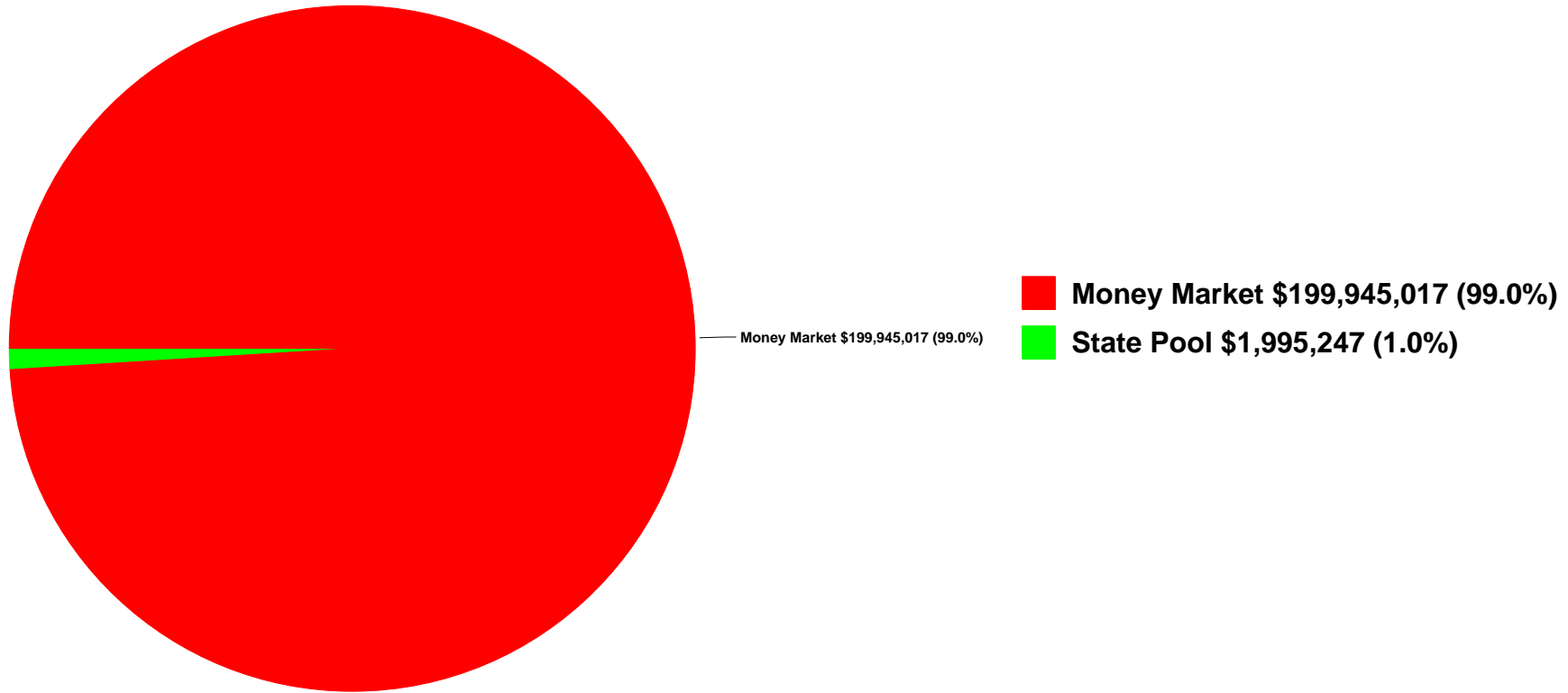

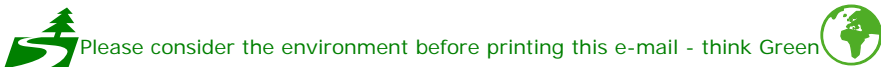

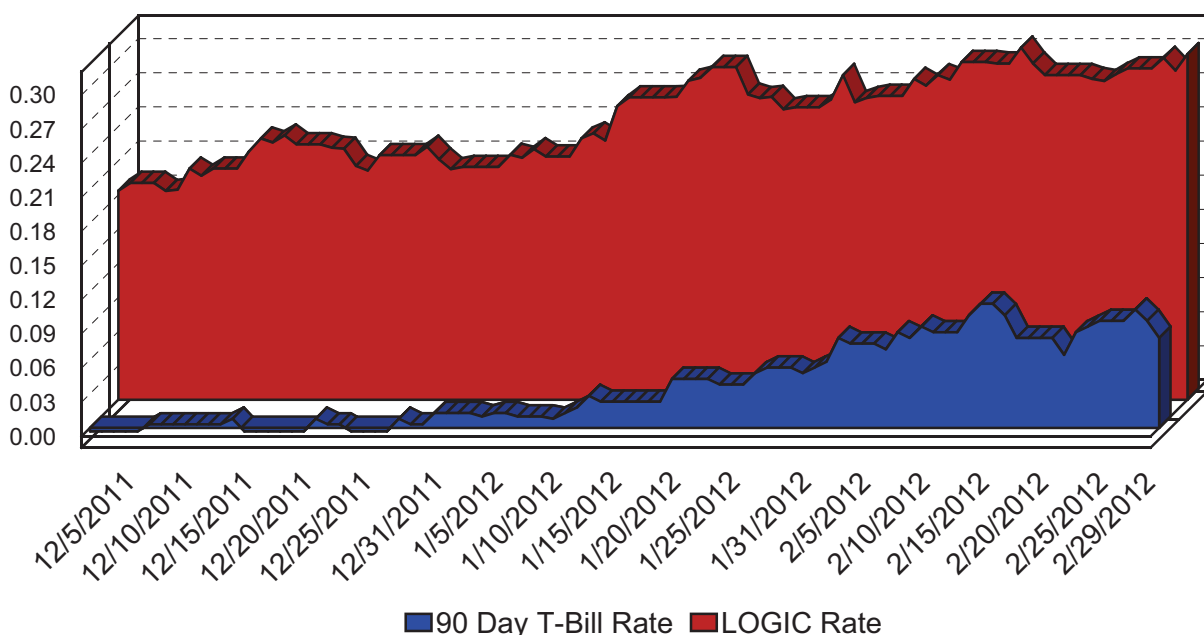
