

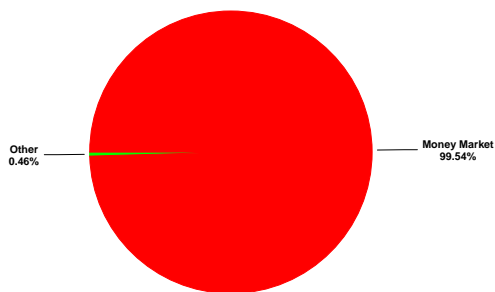

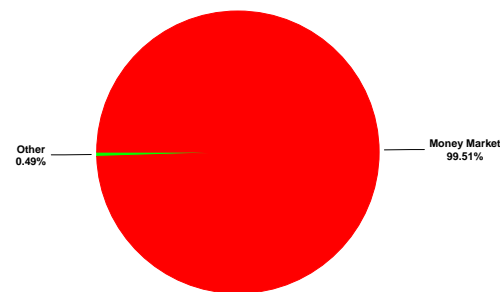

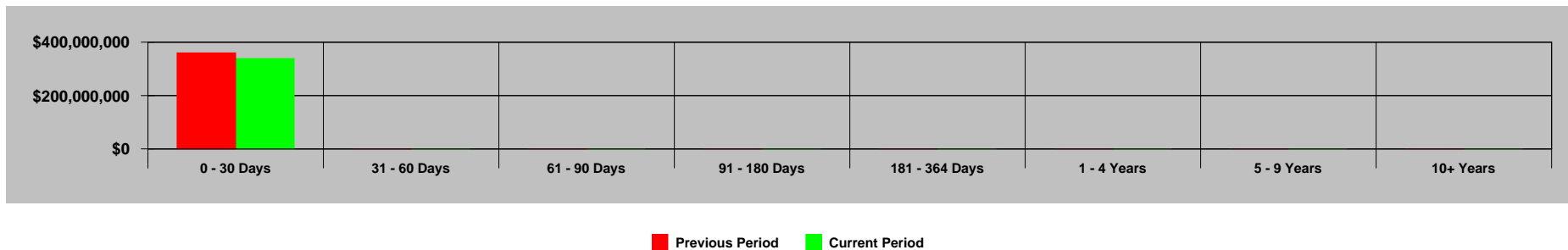
Portfolio Composition - 08/31/12



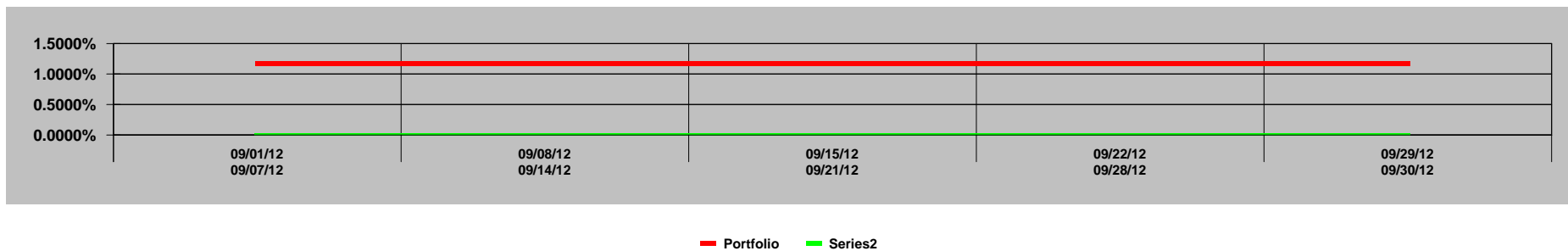
Portfolio Composition - 09/30/12

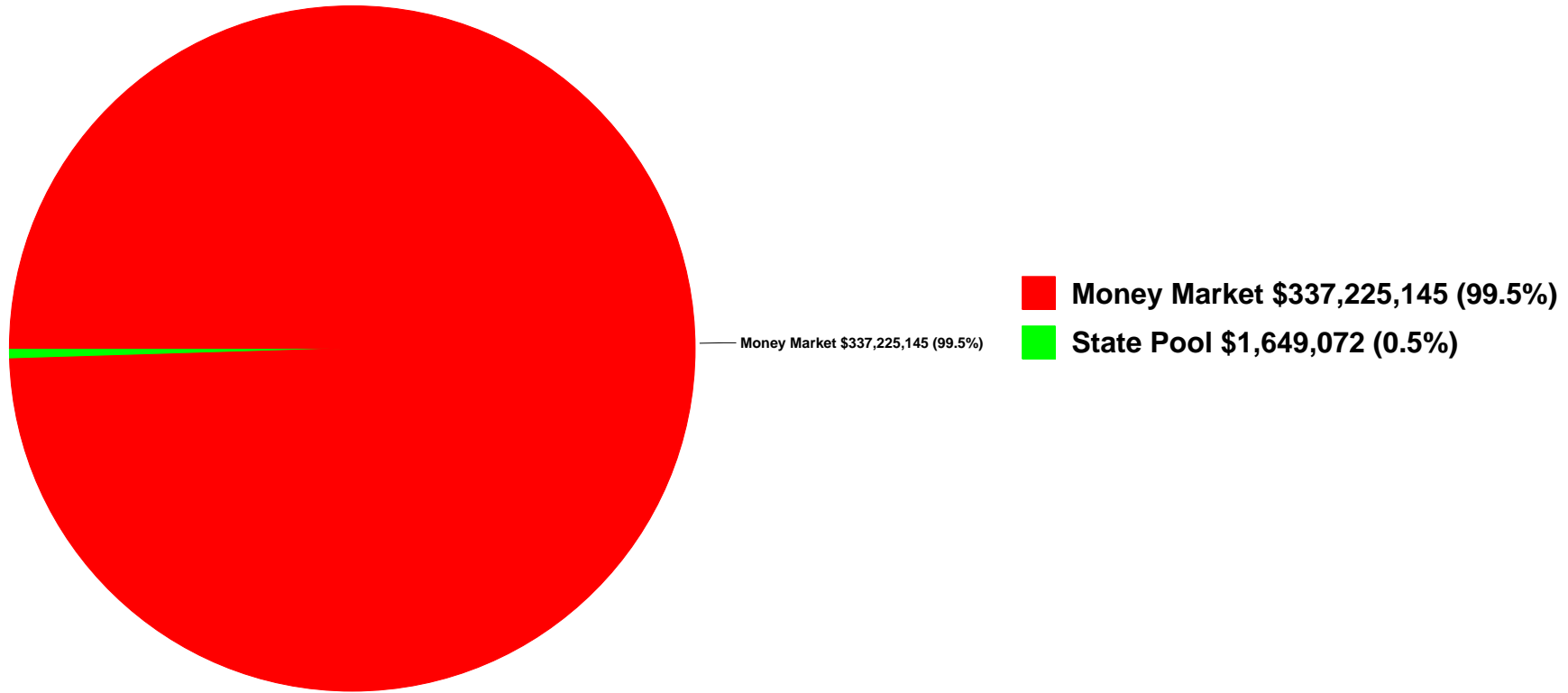

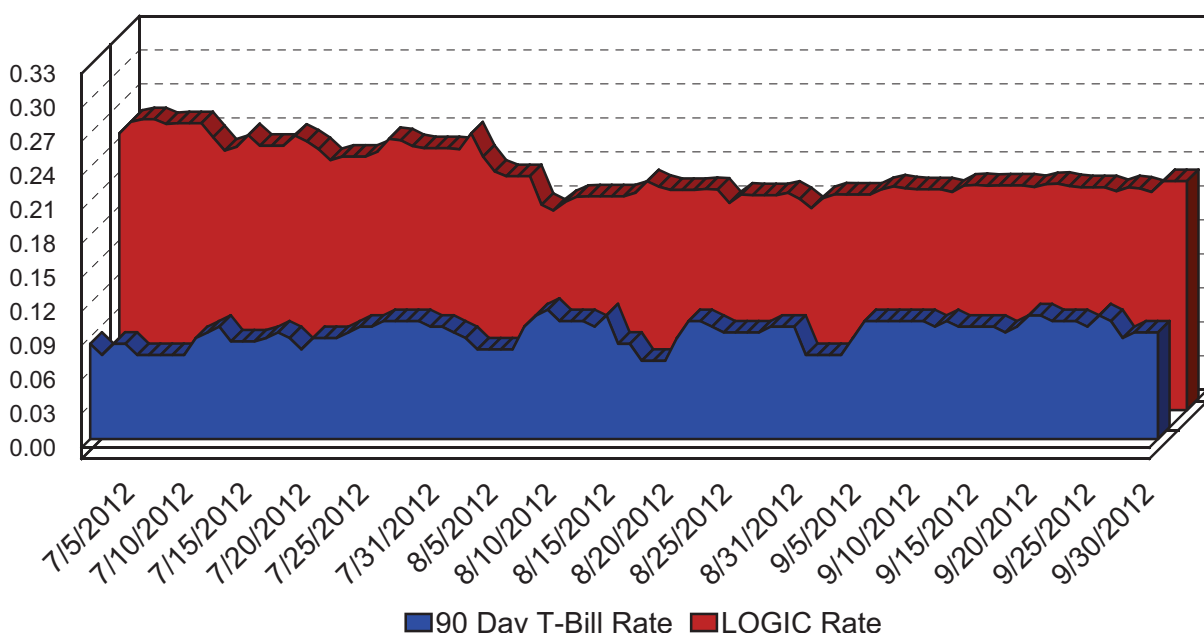
