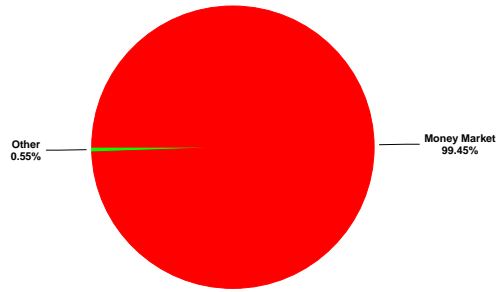

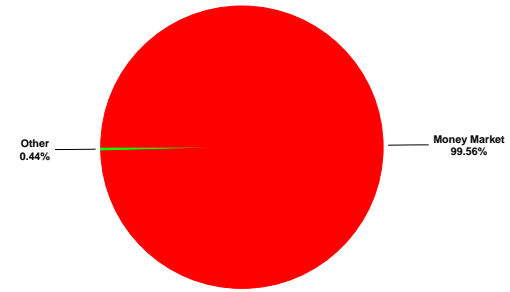

Portfolio Composition - 01/31/13

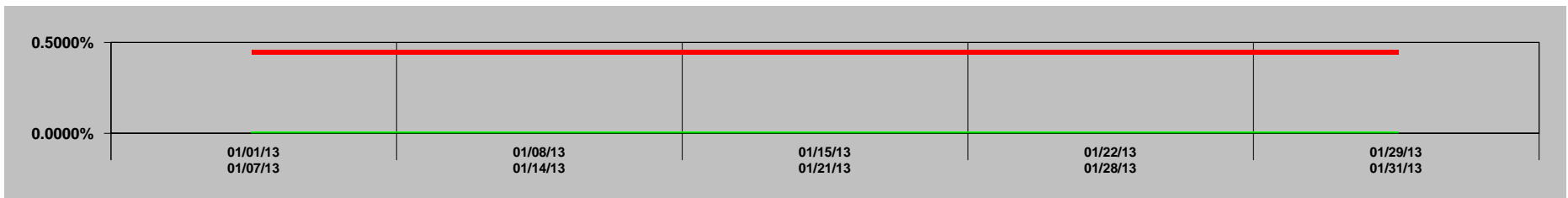


Maturity Aging - 12/31/12 vs 01/31/13

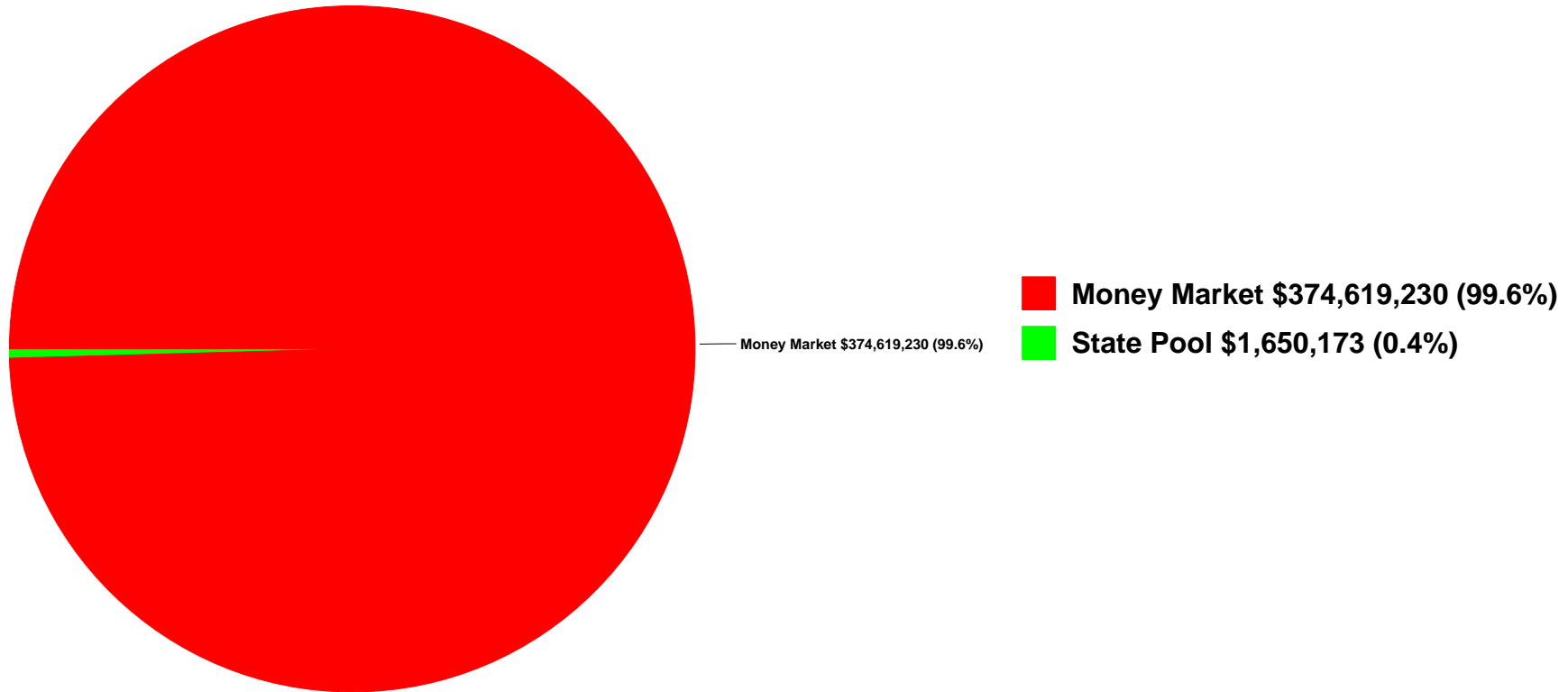

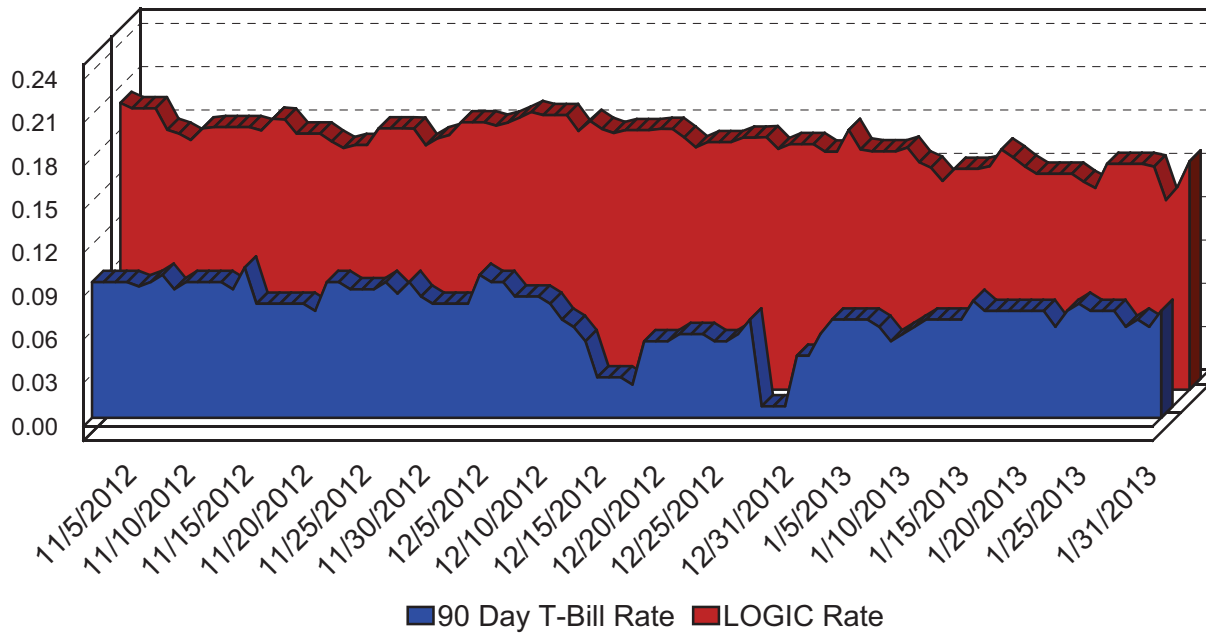
