

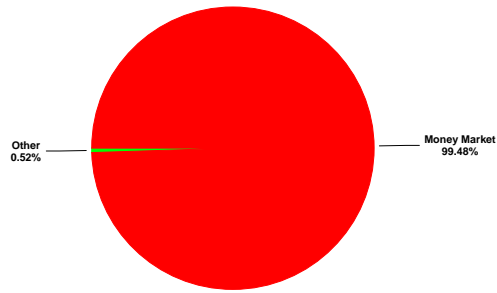

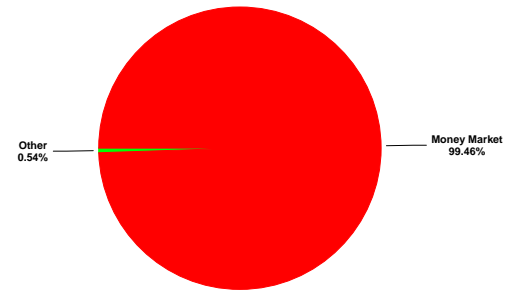

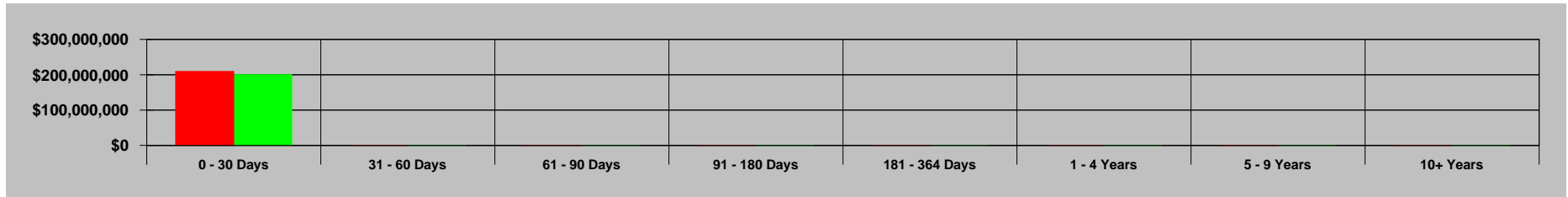
Portfolio Composition - 10/31/13



Portfolio Composition - 11/30/13

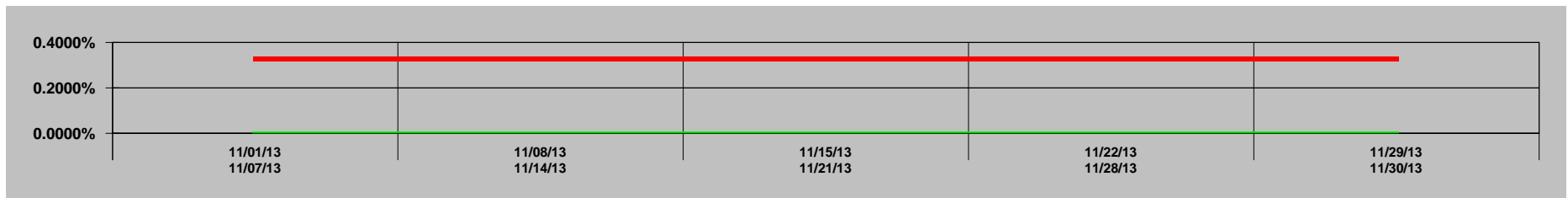


Maturity Aging - 10/31/13 vs 11/30/13

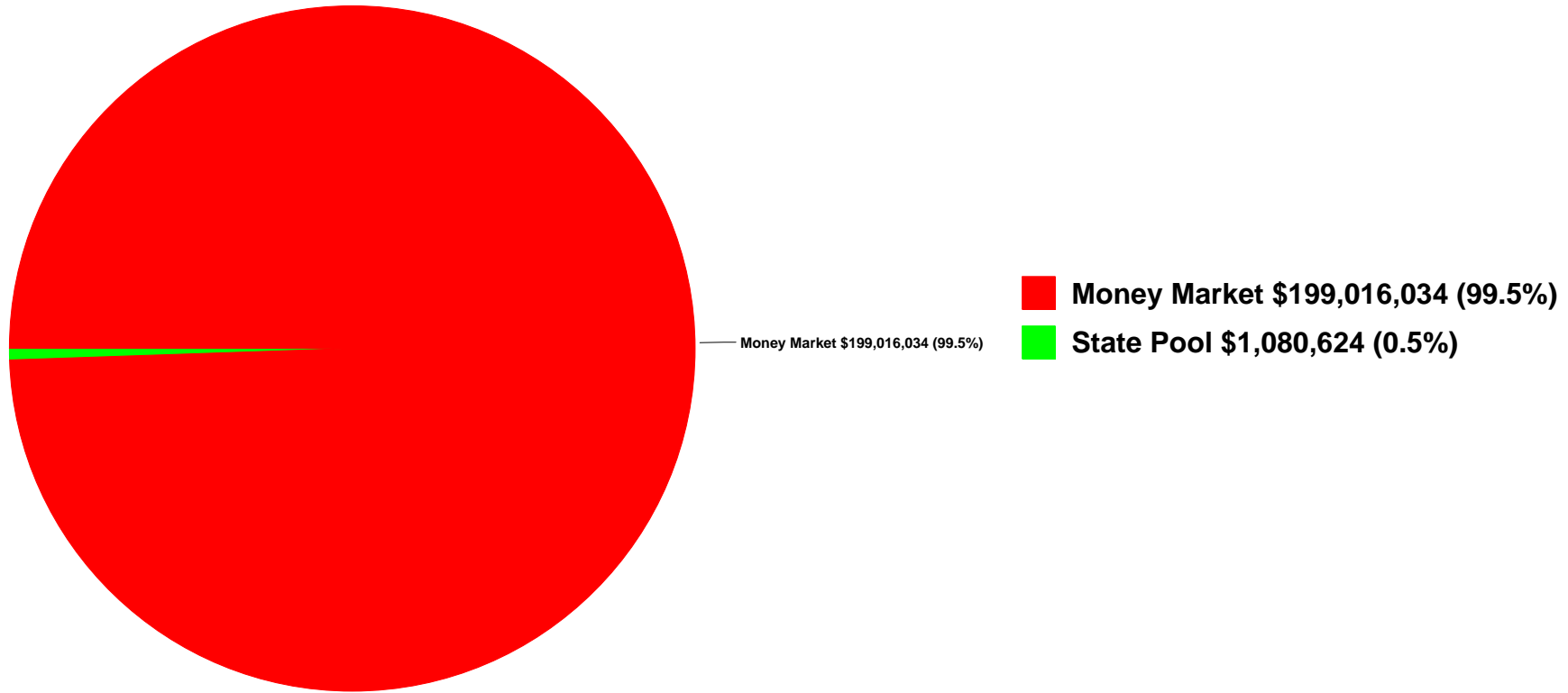

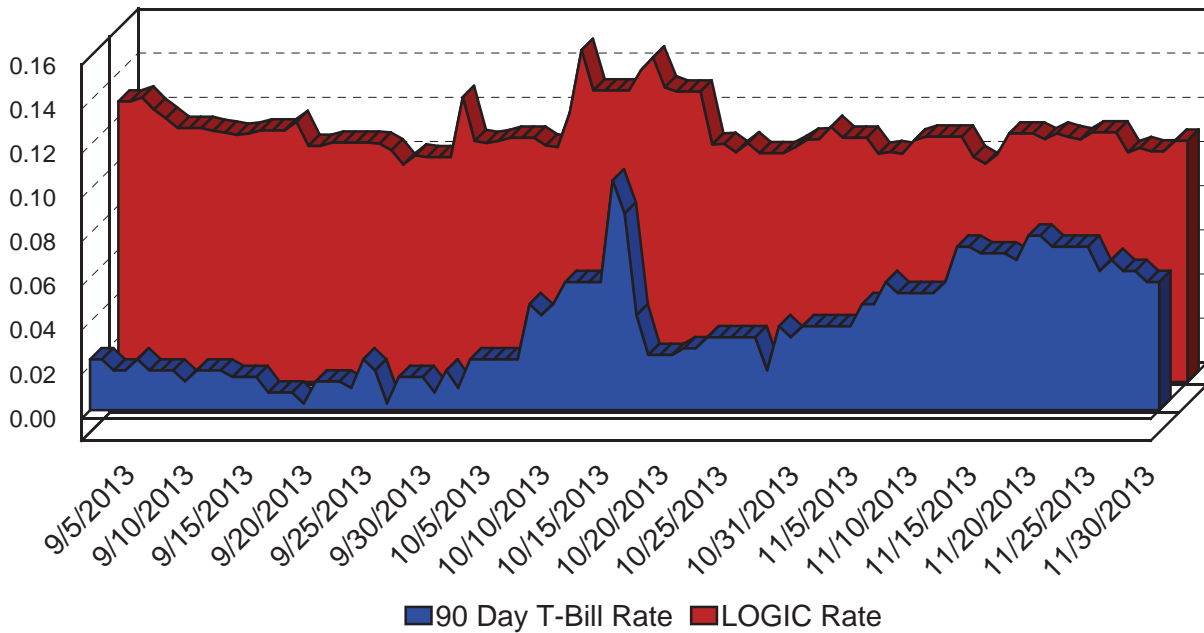
