Components of the Summer Learning Program include:

- Interactive learning blocks in STEM, reading and fine arts, dance & drama
- Awesome field trips to local attractions-museums, sporting games, parks, nature centers, colleges & universities
- Community Service Engagement-club care, garden projects, health & career fairs
- Exhibition Week-quiz bowls, talent shows, and science fairs

April Deemed National County Government Month

Every year doing the month of April, we celebrate National County Government Month. The significance of the month-long celebration was to raise awareness about the functions of county government and give the public a better understanding of how county government operates.

So in celebration of National County Government Month, we focused on a particular aspect of county government that is important to Fort Bend County and many other counties across the nation.

ATTEN-TION! Fort Bend County recognizes the sacrifices that our veterans make to protect our country and is proud to serve them once they come back home. The Fort Bend County Veterans Service Office actively promotes the rights of veterans and dependents of the United States Armed Forces and ensures they receive the entitlements they deserve for the sacrifices they endured.

Services offered include:

While driving through the county, have you ever noticed new county buildings, roads, bridges, schools and many other infrastructures? Most of these items are financed through tax-exempt municipal bonds.

These bonds are the most important tool in the U.S. for financing investment in schools, roads, water and sewer systems, airports, bridges and other vital infrastructure. State and local governments financed more than \$1.65 trillion of infrastructure investment over the last decade 2003-2012) through the taxexempt bond market according to a joint report-Protecting Bonds to Save Infrastructure and Jobs –issued by NACo (National Association of Counties), NLC (National League of Cities), and USCM (U.S. Conference of Mayors). Ninety (90%) percent of infrastructure municipal bonds financing went to schools, hospitals, water, sewer facilities, public power utilities, roads and mass transit over the last 10 years. In 2012 alone, more than 6,600 tax-exempt municipal bonds financed more than \$179 billion worth of infrastructure projects across the country.

So next time you see a new county building being erected, or a new roadway, school or hospital, these vital infrastructure projects are financed through the taxexempt municipal bonds.

- Inform veterans, dependents and survivors about benefits from the Department of Veterans Affairs.
- Home visits to the elderly and disabled.
- Completion of various VA forms
- Explanation of Federal Benefits
- Explanation of State of Texas Benefits

According to the Veterans Service Office, there are several documents the veteran and spouse should obtain and keep in a safe place when applying for benefits through the VA:

- Original Discharge or DD-214. If you have the original it is recommended that you have it recorded at the County Clerk's Office.
- Original or certified copy of your marriage license issued by the County Clerk's Office.
- Divorce decree/death record of prior marriage(s) for self or current spouse. If these documents are not available, it is recommended that you record these important dates.
- Birth certificates of children or adoption decree
- Social Security numbers for you, your spouse and children.
