  - c. proof of SR-22 form.
2. An information copy of the Petition is to be delivered to Criminal District Attorney in Fort Bend County at time of filing, along with Petitioner's date of birth and Texas Driver's license number.
3. Attorney for Defendant/Petitioner is to prepare conformed copies of Petition and Order to be certified by clerk.

5. A certified copy of Defendant/Petitioner Petition for an occupational license with all exhibits attached hereto
6. A certified copy of this Order
