As of January 13, 2022, a [Joint Policy Agreement](#) has been put in place to continue making online court records available only to attorneys and other officers of the court through the implemented Secure Access Site. You may continue to contact the County Clerk's office to obtain access to the Fort Bend County Clerk's Secure Access Site.

The images that you may copy off of this site have not been certified as being true and correct copies of the instruments filed and recorded with the Fort Bend County Clerk's Office.

For **certified copies**, fees are \$1.00 per page and \$5.00 per document certification fee. Vital record copy fees vary. See our [Fees](#) page for more information.

For **certified plat copies**, fees are \$10.00 per page and \$5.00 per document certification fee.

Select “Misdemeanor”

[Misdemeanor](#) Search

Class A & B Misdemeanors such as driving while intoxicated (DWI), theft, assault, and possession of marijuana as well as Class C appeals from the Justice of the Peace and the municipal courts from 1983 forward.

Select “Criminal Case Records”



This will take you to “**Criminal Case Records.**”

On the Criminal Case Records page, you will have to choose various criteria as the basis for your search.

You can search by **Case Number**, **Party Name**, **Attorney** or **Date the case was filed**. When you have entered the necessary information, click on “**Search**”
