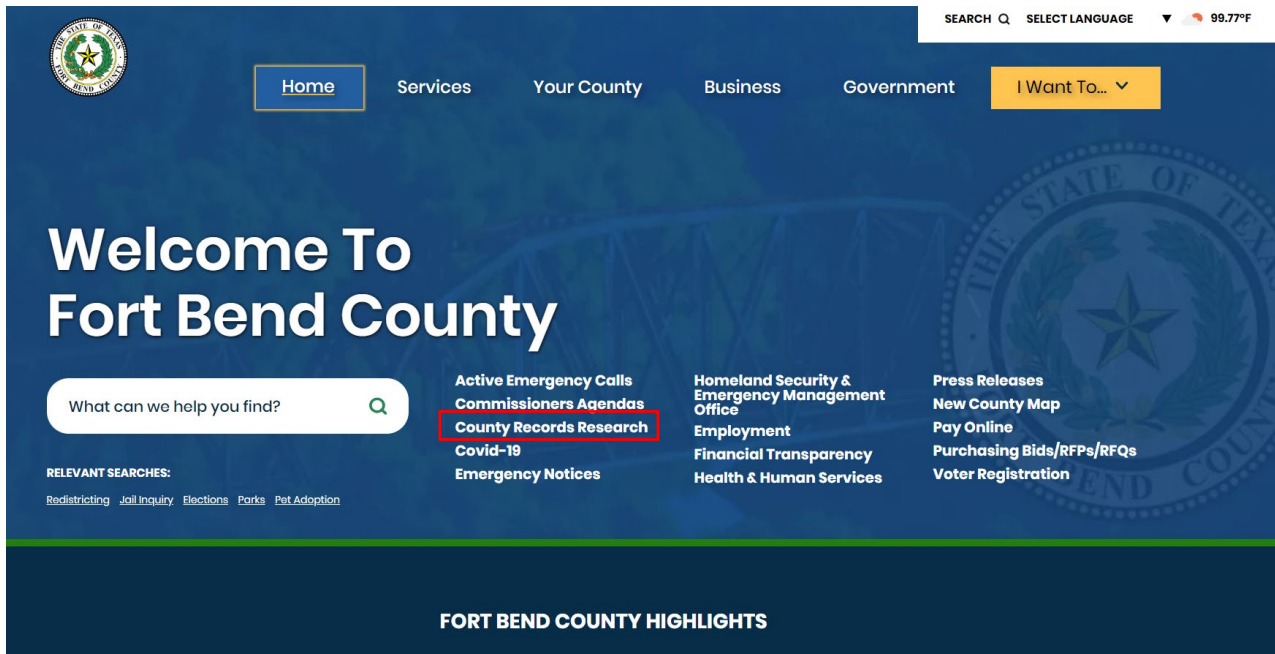
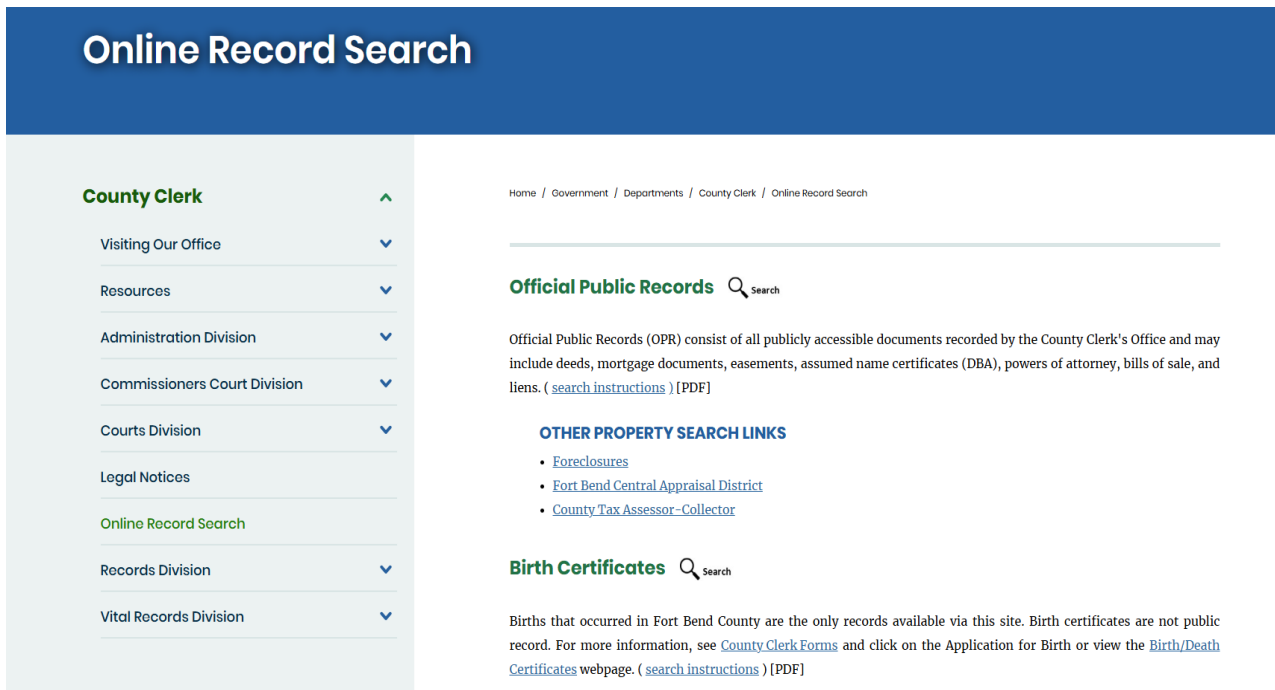


Instructions for Conducting a Misdemeanor Unfiled Case *BOND* Search:

The most accurate results will be obtained by searching using the **“On or After”** and **“On or Before”** date fields along with the Case Type: **“Misdemeanor Unfiled Cases.”**

When you have entered the necessary information, click on **“Search”**
