

**AFFIDAVIT FOR EXEMPTION FROM JURY DUTY  
FOR PHYSICAL OR MENTAL IMPAIRMENT**

Government Code Section 62.109 allows for a permanent exemption or a temporary exemption from jury service based upon a person's physical or mental impairment. The exemption may be granted by the District Clerk/District Judge once an affidavit accompanied by a physician's statement is received from the Applicant/Affiant. The Applicant/Affiant must submit the completed affidavit and the physician statement to the District Clerk's Office. The Applicant/Affiant will be notified if the request is approved or denied.

Instructions:

- The applicant may request that an exemption be withdrawn by filing a signed request for withdrawal with the District Clerk's Office of Fort Bend County, Texas.
