

ORDINANCE NO. 3124-01

AN ORDINANCE OF THE CITY OF KATY, TEXAS, DECLARING DAN SMITH, CANDIDATE FOR COUNCILMEMBER WARD A AND GINA HICKS, CANDIDATE FOR COUNCILMEMBER WARD B, RESPECTIVELY, UNOPPOSED FOR ELECTION TO OFFICE; CANCELLING THE MAY 4, 2024, REGULAR CITY OFFICERS' ELECTION; DECLARING SAID CANDIDATES ELECTED.

Whereas, the City Secretary has certified that Dan Smith, candidate for Councilmember Ward A, and Gina Hicks, candidate for Councilmember Ward B, respectively, are unopposed in the May 4, 2024, Regular City Officers' Election, and

Whereas, the Texas Election Code provides that an election may be cancelled if each candidate whose name appears on the ballot is unopposed, the election is one in which a declaration of write-in candidacy is required, and no proposition is on the ballot, NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KATY, TEXAS:

I.

That the City Council finds that the matters set out in the preamble to this ordinance are true and correct and are made a part of this ordinance.

II.

That the City Secretary has certified that each candidate whose name appears on the ballot is unopposed, the election is one in which a declaration of write-in candidacy is required, and no proposition is on the ballot.

III.

The Regular City Officers' Election scheduled for May 4, 2024, in accordance with Section 2.053(a) of the Texas Election Code is cancelled.

IV.

The following candidates having been certified as unopposed are hereby elected as follows:

Dan Smith - Councilmember Ward A

Gina Hicks - Councilmember Ward B


V.


