

ORDER DECLARING UNOPPOSED
CANDIDATES ELECTED TO OFFICE

WHEREAS, Coats Rose, P.C., the attorney for Grand Mission Municipal Utility District No. 1 (the "District"), is the authority responsible for having the official ballot prepared for the District's 4 May 2024 directors election (the "election"); and

WHEREAS, pursuant to the provisions of Section 2.052, Texas Election Code, as amended, Coats Rose, P.C. has certified in writing to the Board of Directors of the District that the candidates to be listed on the ballot for the election are unopposed, i.e., only one candidate's name will appear on the ballot for each open position and no candidate's name will be placed on a list of write-in candidates for the office of director of the District; and

WHEREAS, pursuant to the provisions of Section 2.053, Texas Election Code, as amended, the Board of Directors of the District has the authority to declare unopposed candidates to be elected to office; Now, Therefore,

BE IT ORDERED BY THE BOARD OF DIRECTORS OF GRAND MISSION MUNICIPAL UTILITY DISTRICT NO. 1 THAT:

Section 1: The Board of Directors of the District hereby declares the following unopposed candidates to be elected to the office of director of the District:

Darrell A. Hawthorne
Vincente M. Salazar III
Syed Hasan

The candidates declared elected to office shall serve until the biennial directors election in the year 2028, or until their successors have been duly elected or appointed and have qualified.

Section 2: Each candidate declared elected to office under this Order shall enter into the duties of his/her office and shall begin to serve his/her term of office after 4 May 2024 and upon posting bond in the amount of \$10,000, upon taking the constitutional oath of office, and upon acceptance of the bond and oath of office by the District's Board of Directors.

Section 3: Pursuant to the provisions of Section 2.053(b), Texas Election Code, as amended, the election will not be held. A copy of this Order will be posted on election day at each polling place that would have been used in the election.

Section 4: The President and Secretary of the District's Board of Directors and Coats Rose, P.C. are hereby authorized and directed to take any action necessary to carry out the provisions of this Order.

EN VISTA DE QUE Coats Rose, P.C., abogado del Distrito de Servicios Públicos Municipales Nro. 2 de Grand Mission (el "Distrito"), es la autoridad responsable de hacer preparar la boleta oficial de votación para la elección de directores del Distrito (la "elección") del 4 de mayo de 2024; y

EN VISTA DE QUE en conformidad con las disposiciones de la Sección 2.052 del Código Electoral de Texas, según enmendado, Coats Rose, P.C. ha certificado por escrito a la Junta Directiva del Distrito que los candidatos a ser puestos en la boleta de votación de la elección no tienen oponentes, es decir, en la boleta de votación aparecerá el nombre de un solo candidato para cada una de las posiciones abiertas, y no aparecerá el nombre de ningún candidato en la lista de candidatos escritos para el cargo de director del Distrito; y
