

**ORDINANCE NO. 2335**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SUGAR LAND, TEXAS, DECLARING UNOPPOSED CANDIDATES IN THE MAY 4, 2024 ELECTION AND CANCELING THE ELECTION FOR SINGLE MEMBER DISTRICTS TWO, THREE AND FOUR OF THE CITY COUNCIL OF THE CITY OF SUGARLAND.**

WHEREAS, by Ordinance No. 2332, the City Council called for an election on May 4, 2024, to elect council members for the City’s four-single member districts; and

WHEREAS, the time for filing as a candidate for the May 4, 2024, council election has passed; and

WHEREAS, Section 2.051 of the Election Code provides that a municipality may cancel an election for council members if each candidate whose name is to appear on the ballot is unopposed and no proposition is to appear on the ballot; and

WHEREAS, as required by law, the City Secretary has delivered a written certification to the City Council certifying that the candidates for election to the City’s single-member council districts two, three, and four are unopposed; NOW, THEREFORE;

**BE IT ORDAINED BY THE CITY COUNCIL  
OF THE CITY OF SUGAR LAND, TEXAS:**

**Section 1.** That the election called for May 4, 2024, to elect council members to single-member council districts two, three, and four is cancelled.


**Section 2.** That the following unopposed candidates have been certified as unopposed and are declared elected:

**Section 3.** That a copy of this ordinance will be posted on Election Day at each polling place that would have been used in the election, as required by the Election Code.


**Section 4.** That a certification of election will be issued to the unopposed candidates in the same manner and at the same time as provided for a candidate elected at the election, as required by the Election Code.


