In the case of a Terminations, Suspensions or Demotions - the employee who wishes to appeal must file the appeal directly with the Sheriff, in writing within ten (10) working days of the action. The Sheriff will have 30 working days to respond to the appeal. If the employee is not pleased with the outcome, the employee may file an appeal to the Civil Service Commission. The appeal must be filed within ten (10) working days of the Sheriff's action or inaction. There will be no exceptions to this policy.

All other appeals, the employee must first follow the grievance procedures as noted in chapter 5 of the Civil Service Rules and Regulations. Any grievance must be filed initially with your immediate supervisor within 10 working days of the action or inaction. Any appeal to the commission must be filed within 10 working days of the action or inaction from the Sheriff.
