## DEPARTMENT PROFILE

### About the Fort Bend County Sheriff's Office

The Fort Bend County Sheriff's Office was founded in 1837 and is the largest and most diverse law enforcement agency in Fort Bend County. The Sheriff's Office has 917 employees, including 615 sworn peace officers and 22 reserve volunteer deputies dedicated to protecting and serving nearly 900,000 Fort Bend County residents. Among the 10 fastest-growing counties in the nation, Fort Bend covers 885 square miles and includes 21 unincorporated communities.

### Mission

It is the mission of persons employed by the Sheriff's Office of Fort Bend County to protect the lives, property, and rights of all people in this County. In accomplishing this mission, Sheriff's Office employees shall be, at all times, courteous, impartial, and diligent. In the execution of their duties, they shall be guided by those constitutional and legal principles, which are the foundation of the United States of America and the State of Texas.



# MESSAGE FROM SHERIFF ERIC FAGAN

The year 2022 began with a determination to surpass the previous years' accomplishments. I believe we have raised the bar within the Sheriff's Office by working as a team to keep our community safe.

Since I took office as Sheriff of Fort Bend County, I pledged to keep our community safe, but also to take care of our personnel within the department.

I am pleased to inform that the greatest accomplishment, long overdue, was compensating Sheriff's Office personnel by ensuring their pay and benefits are competitive with surrounding Houston-area law enforcement agencies. FBCSO personnel is now compensated at or above the midpoint for their positions. This would not have been possible without the assistance of the Fort Bend County Human Resources Department. The Segal 2022 pay study, contracted by the county, contributed to determining the midpoint salary calculations.

Given the fiscal impact of the \$19.0 million pay package on the County's budget, it became critical for the Sheriff's Office to compete well for local, state, and federal grant opportunities. The Sheriff's Office grant writers rose to the challenge by exceeding \$5.1 million in grant award funding for personnel, technology, equipment, and new programs.


Mental health and quality services have been among the cornerstones of my policing approach. I am pleased to inform that the Sheriff's Office received a \$349,000 grant award from the Bureau of Justice for placing mental health professionals in our Communications Center. For the next two years, Texana Center professionals will work alongside our call-takers to provide immediate assistance to persons in a mental crisis by identifying appropriate services and referrals and de-escalating situations. This initiative will expedite the proper service and save lives.

The Fort Bend County Sheriff's Foundation launched in 2022 to assist the department in providing funds to better equip our deputies and fellow employees with the latest training, technology, and equipment. The foundation held its first annual gala, which was a success. The gala raised funds for the Annual Police Officer Memorial, first aid kits for the Patrol Division, recruitment efforts, and support for the Juvenile Justice Advisory Council (JJAC). JJAC was established in efforts to bridge the gap between the youth and law enforcement.

Fort Bend County is one of the fastest-growing counties in the state of Texas and is recognized as one of the most diverse and safest counties in the nation with over 125 languages spoken. I feel extremely blessed to be the Sheriff of this great County. We have accomplished so much in the last two years, but there is much more we must do. We must be proactive using the latest technology and training to combat crimes such as Human Trafficking, Gangs, and Narcotics. We must continue building partnerships with local, state, and federal agencies in this fight against crime.

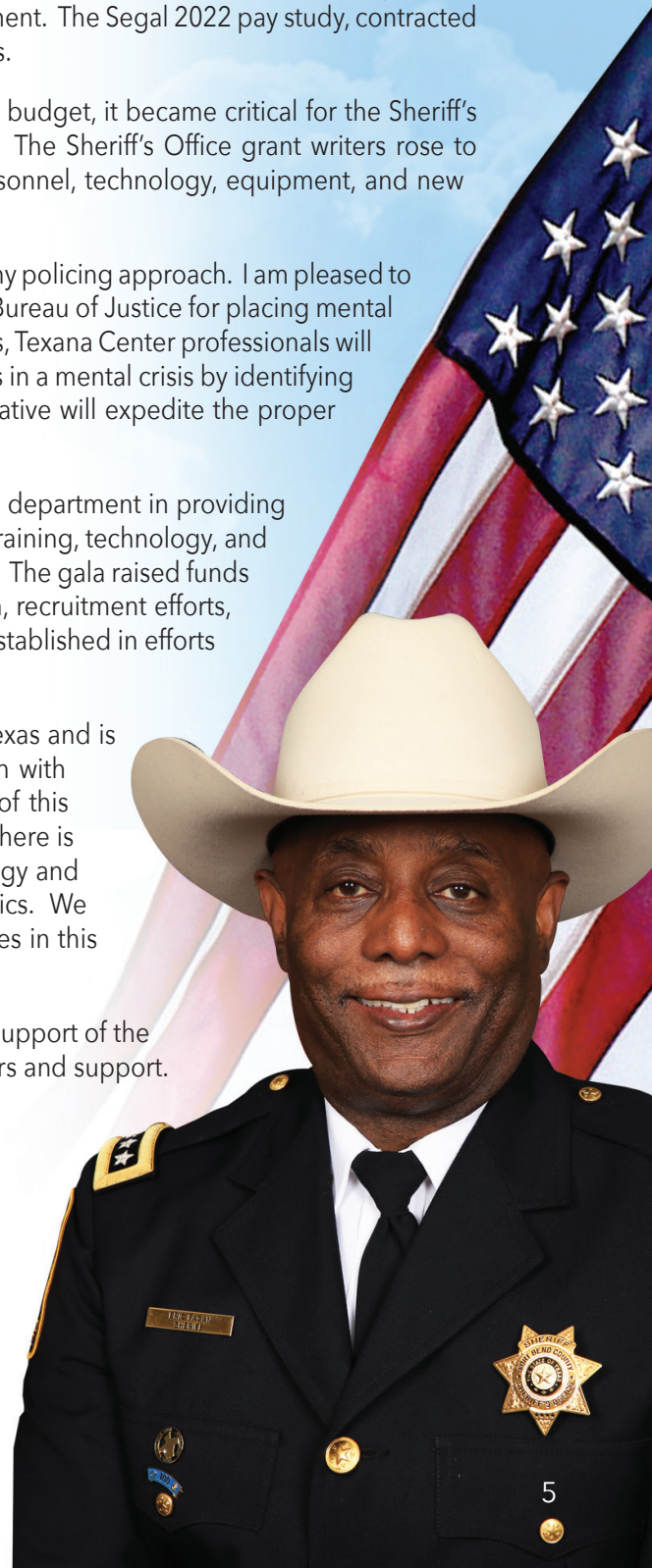

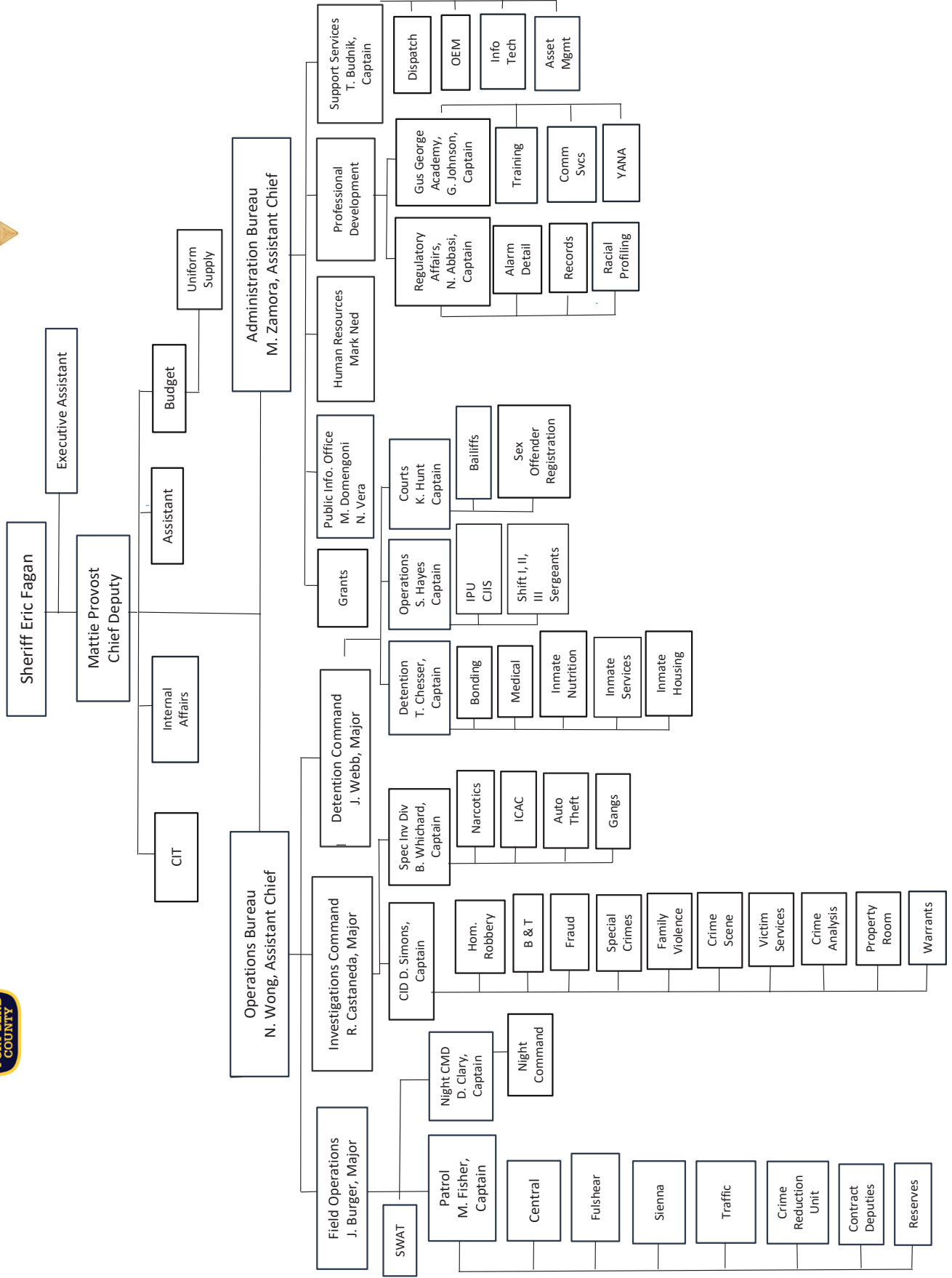

# ADMINISTRATION BUREAU

The Administration Bureau is under the command of Assistant Chief Deputy Manuel Zamora, Ph.D. The bureau consists of the Public Information Office, the Support Services Division, the Gus George Regional Law Enforcement Academy, the Regulatory Affairs Division, Human Resources, and Grants.

## Public Information Office

The Public Information Office (PIO) works closely with the Sheriff's Executive Command to provide clear, concise, and up-to-date newsworthy information to the public. The PIO serves as the liaison between the Sheriff's Office and the community including the news media. The office is managed by Public Information Officer Nereyda Vera.

The PIO responds to public information requests, assists with recruitment efforts, and composes press releases and public service announcements, including safety messages during emergencies. The office also develops media relations with local and state outlets and coordinates press conferences for the release of public information.

In 2022, numerous events were covered including the Fort Bend Peace Officer Memorial, the Fort Bend County Parade and Rodeo, National Night Out, Promotion & Awards Ceremonies, and Trunk or Treat.

## Human Resources

The Human Resources (HR) Section is led by Mark Ned. HR supports over 890 personnel daily. In a competitive environment, the office focuses on strategic outcomes to attract, employ, develop, and retain talent.

### HR Accomplishments

- 45 Texas Commission on Law Enforcement (TCOLE) Secure Share Investigations
- 131 FMLA applications
- 15 retirement requests

The Sheriff's Office Recruitment Team collaborates with Human Resources to identify qualified and skilled applicants. The team is led by Deputy Frank Davis who organizes and promotes Sheriff's Office hiring events and opportunities in the Houston-Galveston area as well as other municipalities each year.

In 2022, the team attended 26 career fairs and visited 35 police academies and high school law enforcement classes. The team gathered over 800 potential applicants, of which 406 completed the employee application and 85 candidates were employed by the Sheriff's Office.

# Grants

The Grants section of the Sheriff's Office is led by Dr. Elizabeth Signorotti. The office is responsible for identifying equipment, technology, personnel, and other resources needed to advance Sheriff's Office initiatives.

In 2022, the Sheriff's Office achieved a milestone - over \$5.1 million in equipment, technology, and program funding. The table below summarizes successful competitive and non-competitive grant awards.

## Support Services Division

*Telecommunications Officers*

The Support Services Division is under the command of Captain Tiffaney Budnik. The Division consists of the Communications Center, Information Technology, as well as Fleet and Asset Management.

### Communications Center

The Fort Bend County Sheriff's Office Communications Center is the third largest communications center in the Houston-Galveston Area. The center is the primary Public Safety Answering Point (PSAP) for unincorporated Fort Bend County and serves as the primary dispatch center for 12 law enforcement agencies including Fort Bend County EMS and eight fire departments. It is also the after-hours point of contact for various county entities including animal control, the medical examiner, assistant district attorney on-call investigators and attorneys, Road and Bridge, TXDOT, and livestock deputies. In 2022, the Communications Center processed 488,024 calls, which included police, fire, medical emergencies and non-emergency situations.

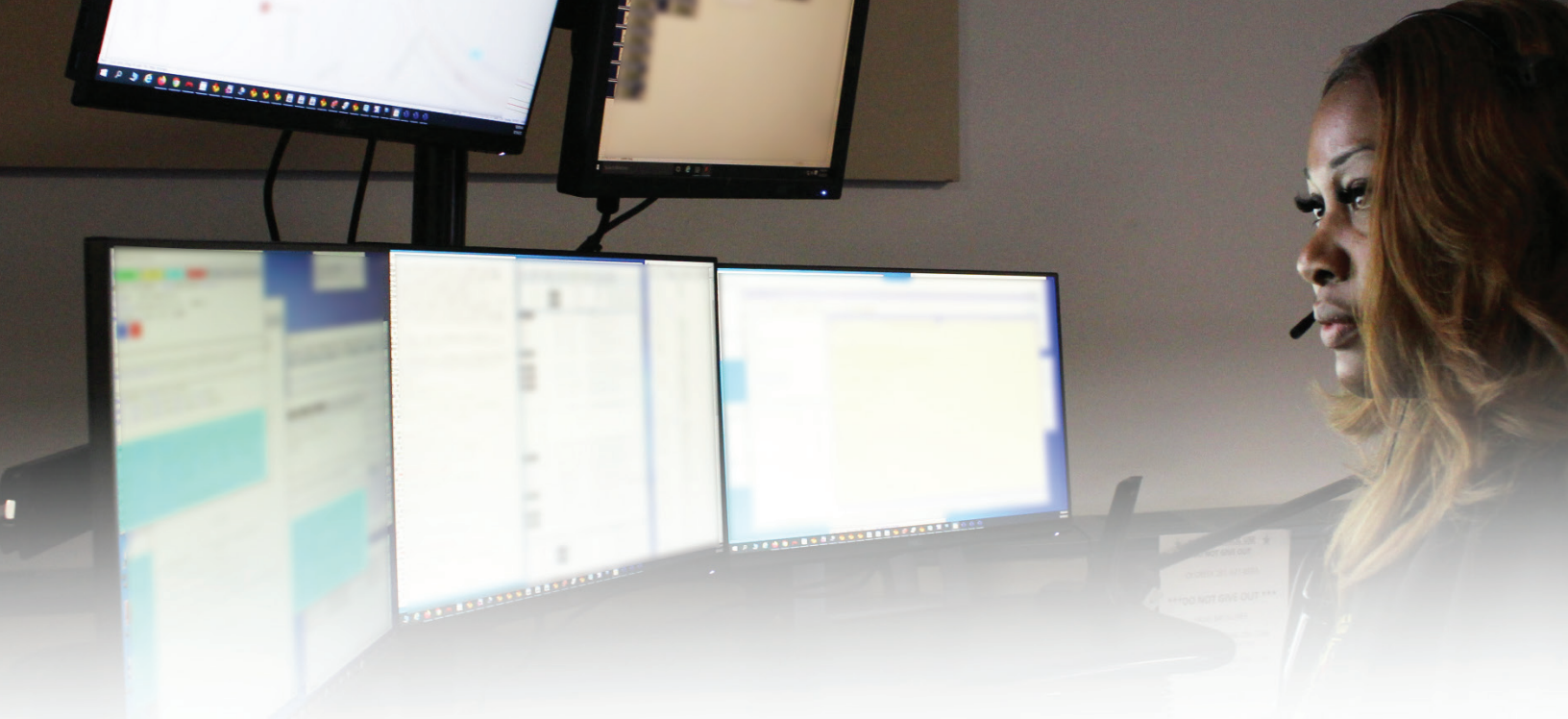

On November 17, 2022, the Sheriff's Office received a 9-1-1 call from a person advising he had been shot. Shortly after, another call was received from a female crying for help.

Though a location was not given by either caller, dispatchers used 9-1-1 mapping and cell location information to identify the call was made at the George Ranch High School campus. The location was pinned closely located at the rear of the school between the auditorium and field house.

The Sheriff's Office Communications Center began dispatching law enforcement units to the school and managed the total response of over 40 police officers, SWAT, and air support. During initial dispatch, the Communications Center also assigned ambulances and fire department personnel to the call. Air medical was also placed on standby.

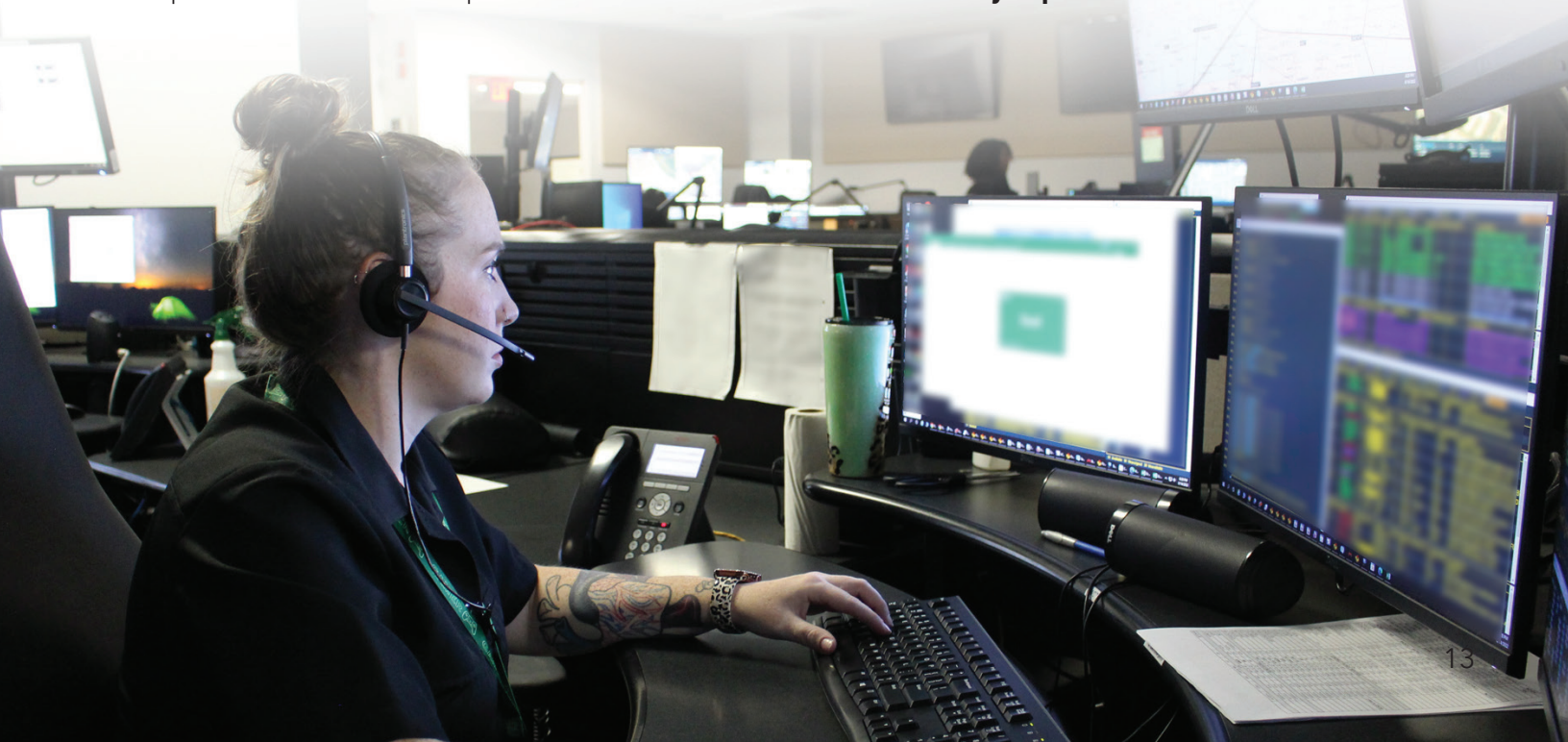
As the event evolved it became clear that the call was likely a prank. However, in our best efforts to save lives, the FBCSO Communications Center handled this call as though it was an active event and enabled investigating units to identify and charge all persons involved in the hoax active shooter call.



Police radio operators within the center are responsible for dispatching patrol officers to calls for service and recording self-initiated activities reported by all field operations personnel and investigators. Radio operators are also responsible for monitoring various programs, such as the License Plate Recognition (LPR) system and communicating alerts to the Patrol division. The center received 600 LPR hits for the year 2022.

In 2022, communications personnel entered, modified, and supplemented 8,164 Texas Crime Information Center (TCIC) and National Crime Information Center (NCIC) records. In addition, communications personnel cleared or canceled 5,877 records, and processed 150 requests for HAZMAT.

The 9-1-1 network provider for the Sheriff's Office region, Greater Harris County 9-1-1, established a quality performance standard that 95% of all 9-1-1 calls must be answered within 10 seconds or less. Despite staffing challenges, the FBCSO Communications Center not only met the standard, but exceeded it at a 96% response rate, finishing the last few weeks of 2022 at an astounding rate of 97%. The results are a testament to the hard work and commitment of our dispatchers and our leadership. **See index for Communications Productivity Report and Call Volume Statistics.**





## Information Technology

The Information Technology section provides support for the Sheriff's Office. In 2022, the Communications Specialists, in coordination with County IT, accomplished upgrading the Sheriff's Office Cisco project for an internal phone system as well as collaborating with the vendor, Axon, for the installment of the Patrol Division body worn cameras and F3 in-car cameras.

## Emergency Management

Captain Budnik is the liaison between the Sheriff's Office and the Fort Bend County Office of Emergency Management (OEM) in pre-planning and coordinating responses to critical incidents and severe weather events that require Level III activation.

## Fleet / Asset Management

The Fleet and Asset Management section maintains a total of 400 vehicles in the Sheriff's Office, including all-terrain vehicles (ATVs), a high-water rescue vehicle, mobile command vehicles, and helicopters. The office also catalogues, tracks, and accounts for over 3,500 items utilized by the Sheriff's Office.

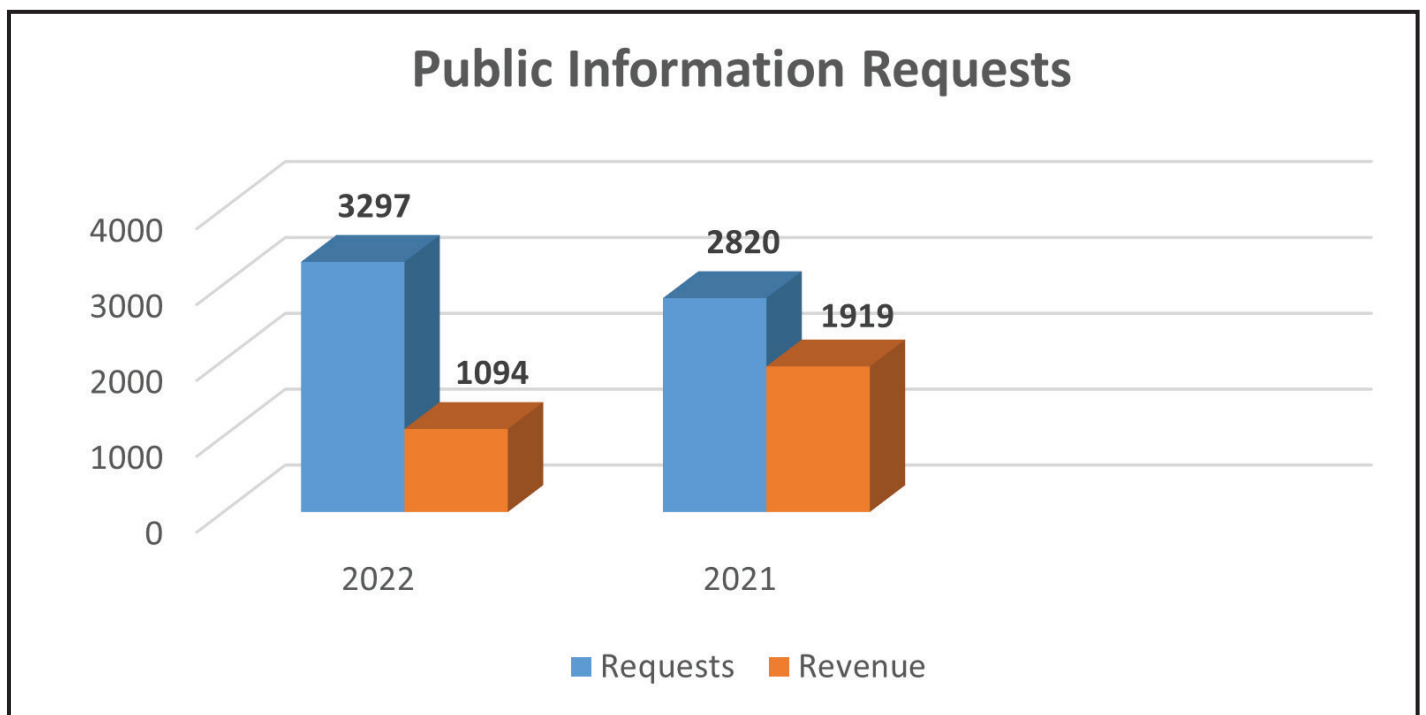


# Regulatory Affairs Division

The Regulatory Affairs Division is under the command of Captain Nasir Abbasi. The division manages Records and the Alarm and Game Room Details section within the Sheriff's Office.

## Records

The Records Division collects, processes, and protects all criminal and detention records filed within this division and maintains accurate and complete records of information reported to regulatory agencies. Records provides services to the general public on a daily basis to include criminal history checks, copies of offense reports, crash report information, assisting with fingerprinting information and payment, referring the public to Patrol Intake Deputy or Communications to file offense reports, and other general matters.



## Alarm Detail and False Prevention Unit

The Alarm Detail and False Prevention Unit (AD & FPU) is responsible for the compliance and enforcement of the alarm regulations set forth by Texas Local Government Code 233.092 as adopted by the Fort Bend County Commissioners Court. The Unit works in collaboration with the Communications Center and Patrol Division, ensuring all residences and businesses owning and operating an alarm system are treated with utmost professionalism while working to bring them to compliance with state and county laws and regulations.

## Gus George Law Enforcement Academy

The Gus George Law Enforcement Academy (GGLEA) is under the command of Captain Gregory Johnson. The division consists of the Training Unit, Community Services, as well as the You Are Not Alone Program.

### Training Unit

Academy instructors provide regional law enforcement training to Fort Bend County and surrounding area police agency personnel with Texas Commission on Law Enforcement (TCOLE) classes. This includes the Basic Peace Officer Course (BPOC). In 2022, the academy successfully completed its 44th annual full-time police academy. GGLEA serves as a Test Site for Peace Officer, Telecommunications Officer, and Detention Officer TCOLE licensing examinations.

The unit also hosts the Advanced Law Enforcement Rapid Response Active Attack Incident Response (ALERRT AAIR) courses throughout the year and has successfully trained over 200 first responders since 2021. It is one of the largest classes of its type provided in the Houston-Galveston Area.

The course prepares agency personnel to respond to active attack/shooter events and rapid casualty evacuation incidents safely and effectively through the Rescue Task Force (RFT) model concept.

## Community Services

The Community Services Section of the Sheriff's Office includes the Kids & Cops Unit and the Crime Prevention Unit.

### Kids & Cops

The Kids & Cops deputies develop and maintain positive and trusting relationships between law enforcement and the youth of Fort Bend County. The program is designed to reduce the likelihood of juvenile delinquency by providing children with opportunities to interact and gain a better understanding of policing and community service. These relationships and opportunities created for the community by Kids & Cops such as summer camps and school presentations increase the likelihood that juvenile citizens will engage in future civic responsibility and positive behavior.

In 2022, the unit completed its 25th annual Kids & Cops Summer Camp program and implemented the first annual Blue Santa program.

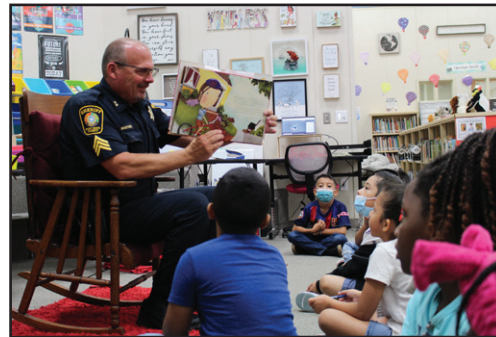

## Crime Prevention

Crime prevention is a collaborative effort to help safeguard the residents of Fort Bend County against criminal activity in their lives, homes, and businesses. Deputies within the unit provide safety presentations to civic groups, business entities, and residential communities. These deputies also attend Homeowners Association meetings to provide crime statistics and insights on how to reduce vulnerability to property crimes. The unit conducts residential and commercial risk assessments as well as overseeing the vacation/house watch program and child passenger safety seat inspections.

### Crime Prevention Accomplishments

- Property checks: 647
- Traffic/parking complaints: 22 neighborhoods
- Safety courses: 420 citizens reached
- National Night Out: 1,139 residential venues visited
- Inspected/installed car seats: 91

The unit coordinates the annual Citizens Police Academy (CPA) and invites members of the community who wish to learn about local law enforcement operations. There were 24 adult students who graduated from the CPA in 2022.

## You Are Not Alone

The You Are Not Alone Program (YANA) is managed by Senior Services coordinator, Michael Kahlenberg. YANA is a program designed to assist senior citizens and individuals with disabilities in Fort Bend County who live alone. YANA volunteers conduct daily phone calls and perform welfare checks on its members. Other services include changing light bulbs and batteries, checking smoke alarms, and providing necessities such as water when needed.

## Project Lifesaver Program

The Project Lifesaver Program was established under the YANA program and is a free resource to safely locate individuals with cognitive disabilities, such as autism, dementia, Alzheimer's, or traumatic brain injury, who have a history of wandering.

In 2022, the FBCSO Project Lifesaver Program, along with the Harris County Sheriff's Office, successfully trained the Katy ISD Police Department on how to conduct searches using locative technology, allowing us to respond faster to those who may elope in Fort Bend, Harris and/or Waller County. This will allow a faster response in assisting Katy ISD's tri-county campuses.

## Crisis Intervention Team

The Crisis Intervention Team is under the command of Chief Deputy Mattie Provost and managed by Lieutenant Jerome Ellis. CIT is a specialized policing unit trained in mental health crisis response and de-escalation. The team assists the patrol division and surrounding agencies, performs mental health follow-ups, and collaborates with the Fort Bend County Behavioral Health Services and director, Dr. Connie Almeida.

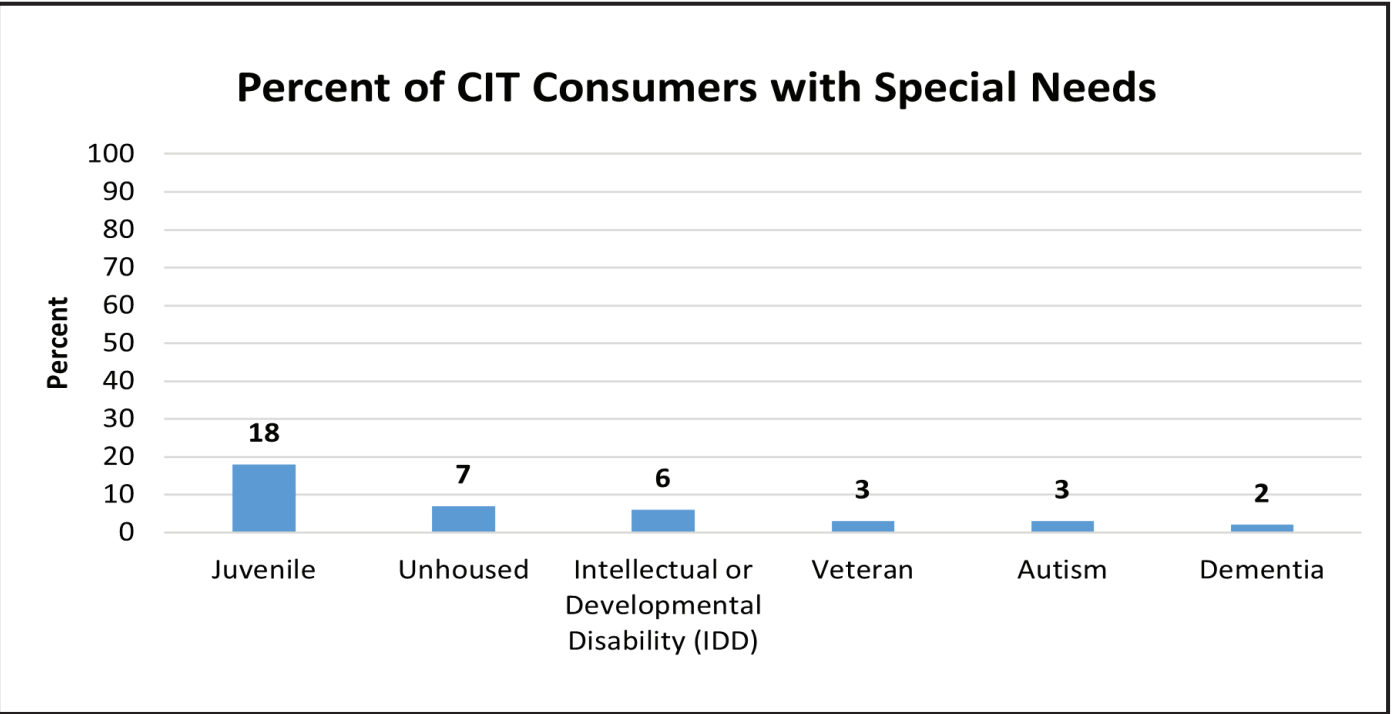
The team oversees the initiatives within the Fort Bend County Community Collaborative Program for Justice-Involved and At-Risk Youth with MI (mental illness) or CMISA (co-occurring mental illness and substance abuse). In 2021, CIT restored the Critical Incident and Stress Management (CISM) team to assist first responders in the Sheriff's Office.

CIT operates 24 hours a day, 7 days a week. Primary delivery methods are through specially trained and vetted deputies who possess the capabilities to effectively diminish crisis situations and provide appropriate emergency services. 2022 marked the first complete calendar year of the collaboration with the mental health center, Texana, in which trained mental health providers ride with Sheriff's Office CIT members in the patrol vehicles when responding to calls for service.

In 2022, Fort Bend County Sheriff's Office received a total of 6,119 calls for service that referenced mental health concerns or prompted a need for a crisis response. Of those calls for service, CIT was instrumental in responding to 3,198 calls. CIT made contact with a total of 1,996 mental health consumers. Of these contacts, 1,593 unique consumers received crisis intervention and/or follow-up services by CIT. Subsequently, a total of 98 encounters resulted in jail-diversions. Texana Mobile Crisis Outreach Team responded/accompanied CIT to several calls for service and completed 183 safety plans. Ultimately, 943 Emergency Detention Orders were completed by CIT.

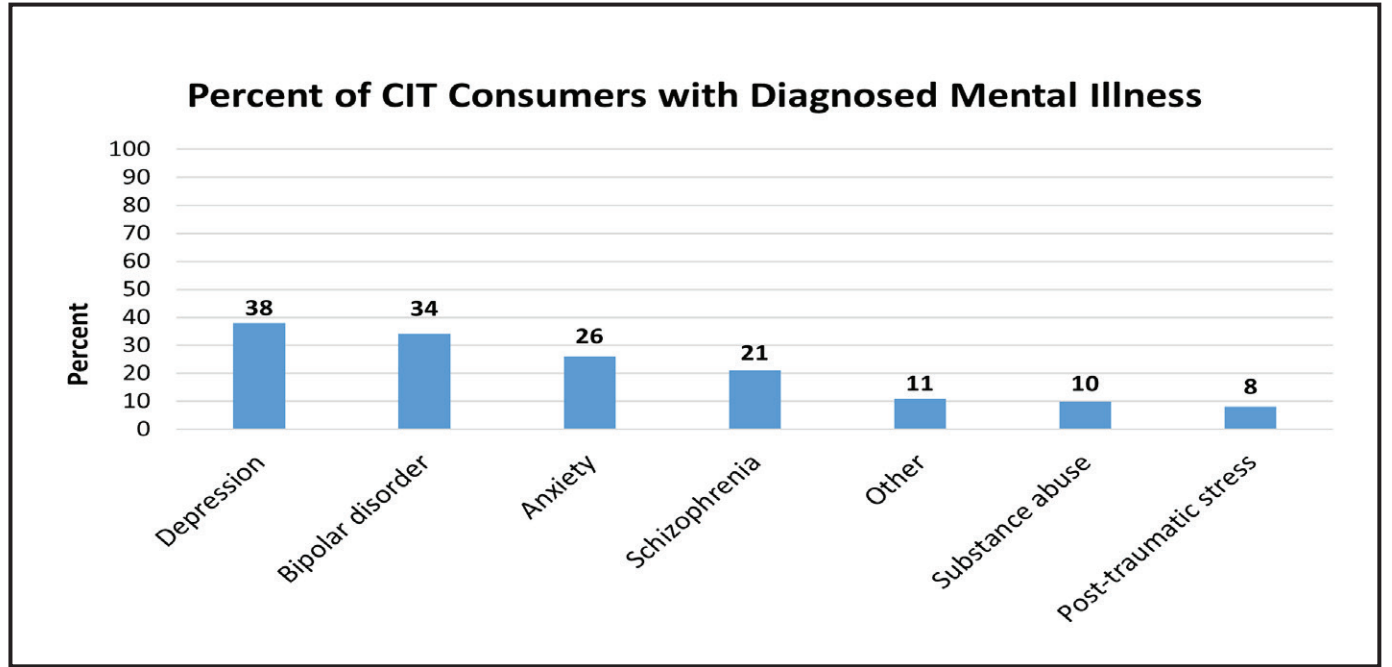
### Special Needs

A small percent of CIT consumers presented with special needs, including: 363 (18%) juvenile, 147 (7%) unhoused, 116 (6%) intellectual/developmental disabilities, 68 (3%) autism, 56 (3%) veteran, and 34 (2%) dementia.



### Mental Illness

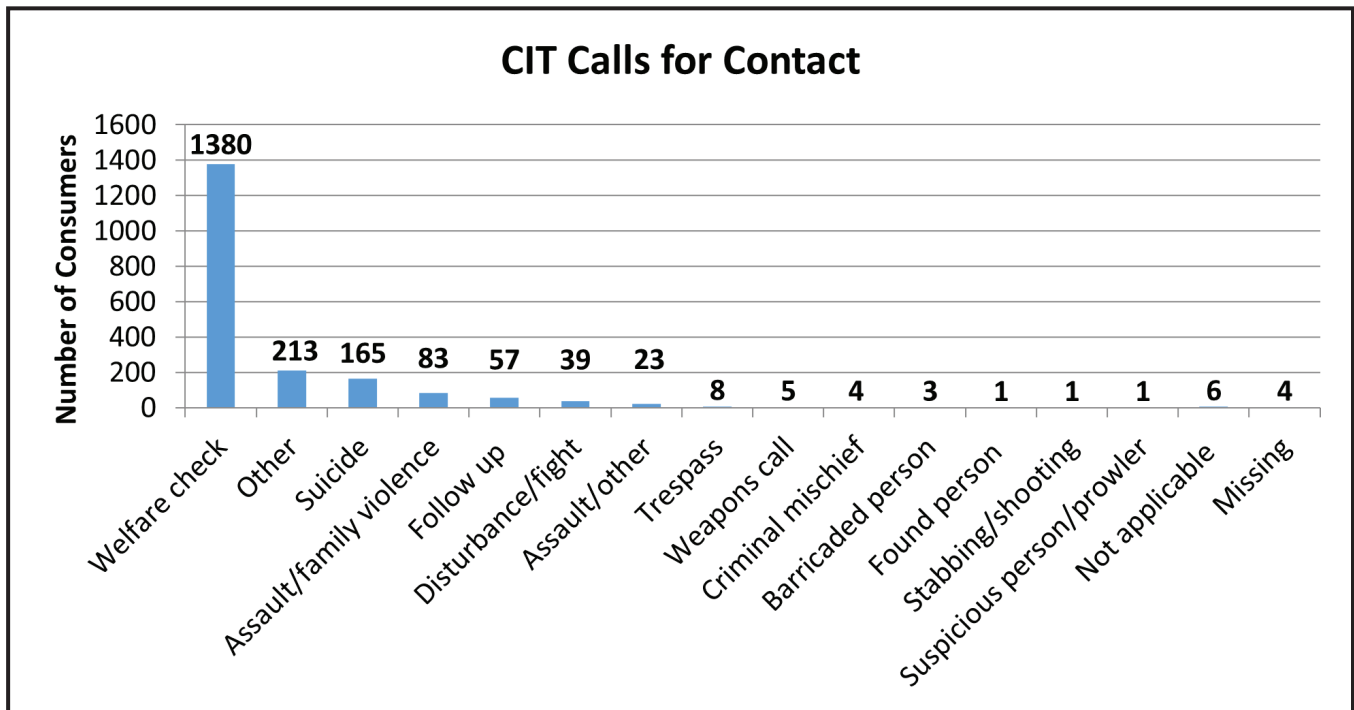
CIT consumers also presented with various mental health needs, including: 753 (38%) depression, 670 (34%) bipolar disorder, 509 (26%) anxiety, 420 (21%) schizophrenia, 219 (11%) other, 197 (10%) substance abuse, and 159 (8%) post-traumatic stress disorder. Approximately 45% of CIT contacts involved consumers with more than one mental illness.





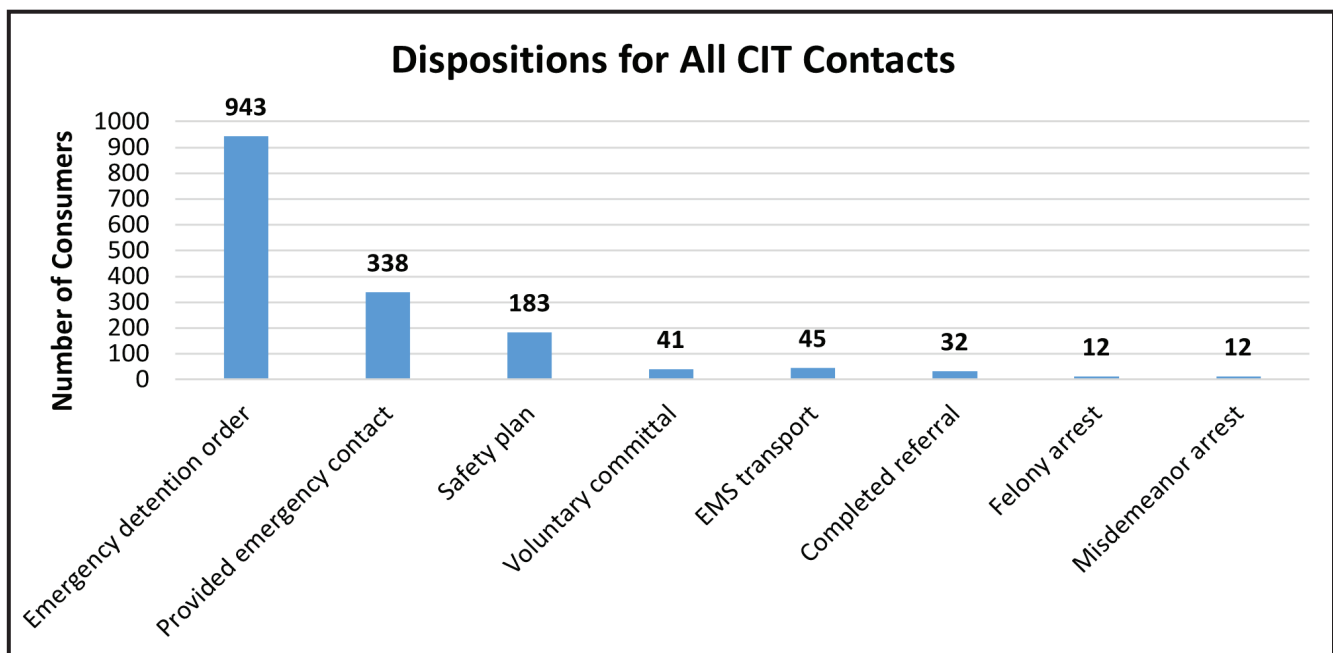
## Calls for Contact

The majority of CIT calls for contact, 69%, were a result of a welfare check, 8% were a result of suicide, 11% were classified as "other," 4% were a result of assault-family violence, and 3% were a result of follow-up.



## Dispositions

Of all CIT contacts, the following dispositions were most common: 943 emergency detention order, 338 provided emergency contact, and 183 safety plan.



# OPERATIONS BUREAU

The Operations Bureau is under the command of Assistant Chief Deputy Norman Wong. The bureau consists of Field Operations, Investigations Command, and the Detention Command.

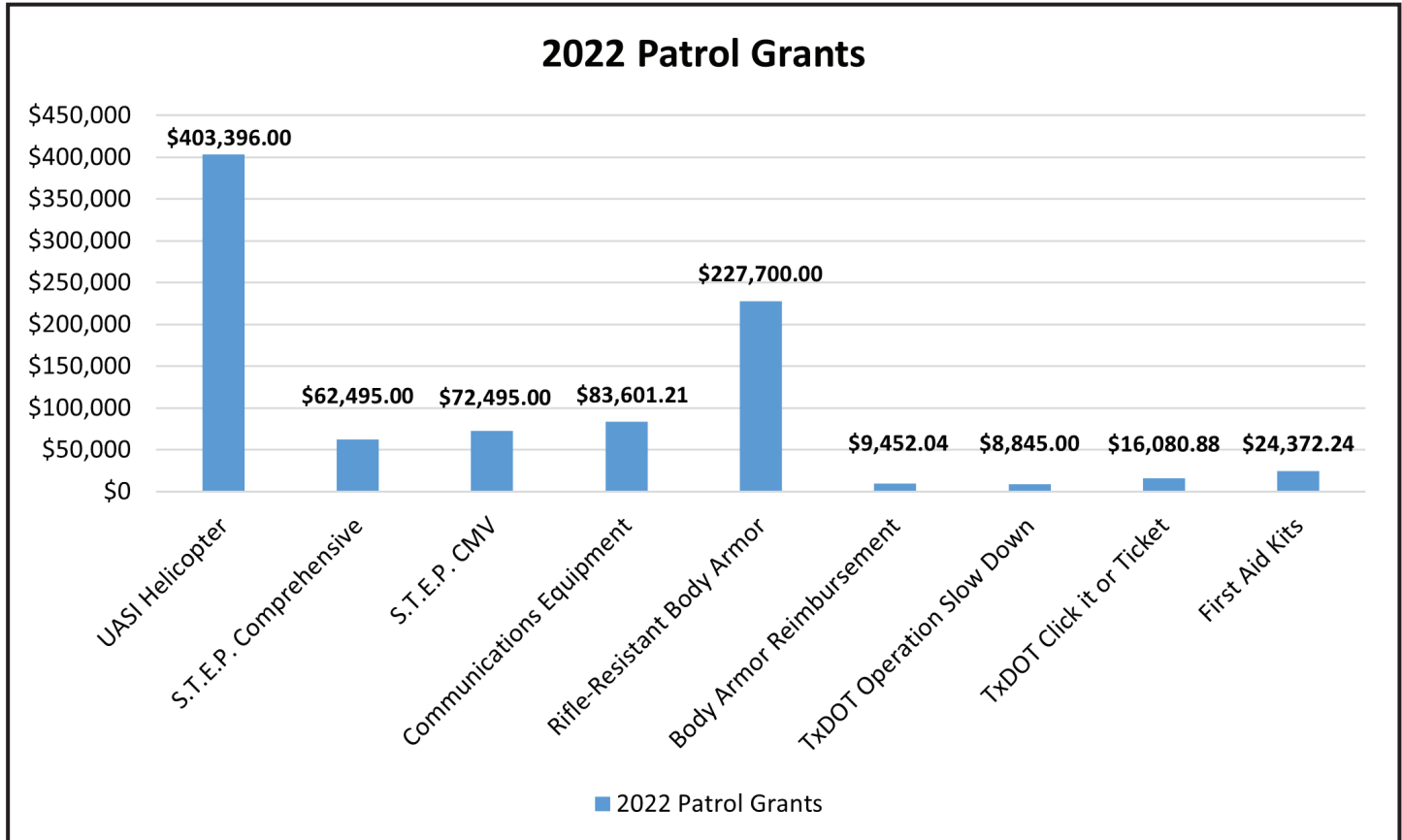
## Field Operations

Field Operations is under the command of Major James Burger and managed by Patrol Captain Michael Fisher and Night Command Captain David Clary.

## Patrol Division

Patrol deputies respond to emergency and non-emergency calls for service from the public and other first responder agencies. Patrol deputies handled the following traffic-related incidents in 2022:

- Traffic complaints: 298
- Failure to stop and give information: 395
- Failure to stop and render aid: 21
- Motor vehicle crashes involving injury: 426
- Motor vehicle crashes involving non-injury: 554
- Fatalities investigated: 26





## Traffic Unit

The Traffic Enforcement Unit investigates vehicle crashes, enforces traffic laws, handles traffic complaints, and conducts school zone enforcement.

The Fort Bend County Sheriff's Office crash investigators completed the following training courses to enhance their investigation of fatal and non-fatal crashes:

- Intermediate Collision Investigation
- Advanced Collision Investigation
- Collision Reconstruction
- Advanced Transportation Code Training
- Vehicle Paper License Plate Fraud Training

## Air Support Unit

The Air Support Unit consists of Tactical Flight Officers who assist the Sheriff's Office during distress and in-progress calls, active shooter events, automobile and foot pursuits, missing persons searches, as well as providing regional assistance to other law enforcement and fire agencies.

The Sheriff's Office possesses two helicopters named Raven 8 (N218FB) and Raven 9 (N259FB). In 2022, both units were rebranded to the latest standards of the Sheriff's Office. The rebranding consists of a more visible color scheme and updated graphics. Additional updates for the N218FB and the N259FB include Skytrax aircraft avoidance system, L3 camera, and two Garmin 275 flight gauges installed by Temple Avionics. The N218FB also received the Churchill 700 series mapping system.

The upgrades now equip the aircrafts with the latest technology necessary for deployment in less-than-optimal conditions, when images, such as thermal, are needed, as well as to locate submerged vessels.

## Unmanned Aircraft System (UAS) Program

The Drone Program supports the Patrol Division with deployment at various calls for service, including search and rescue missions, monitoring crowd control, surveillance of active shooter events, as well as monitoring and evaluating severe weather conditions. The program is managed by Deputy David Craven. **See index for UAS Operations Log.**

The unit consists of 17 pilots that are FAA Part 107 licensed.

The program uses software that allows the Sheriff's Office scene commanders the ability to live stream video footage from various scenes and multiple drones in real-time. The program is equipped with the following: three Mavic Pro Platinum drones, the Matric 210 with thermal imagery, and the addition of the Autel drone that is also capable of thermal imagery and the Lecia RTK.

### Autel Evo II Pro Drone:

Equipped with a camera capable of taking 6k resolution pictures and video, the drone is utilized in creating a scale scene map using photogrammetry. A flight path is programmed in the drone which enables it to fly autonomously over a scene and capture photos that are later used to construct the scale scene map.

### Lecia Real Time Kinematics:

A survey-style equipment that utilizes GPS. The RTK and its GPS receiver take in the normal signals from the Global Navigation Satellite Systems along with a correction stream to achieve a 1cm positional accuracy. The RTK is used in scene mapping to apply precise GPS location. The RTK is used both as standalone equipment for scene mapping and in conjunction with the Autel Eco II Pro Drone.

Collectively, these new devices enable investigators to reconstruct accurate crash scenes to identify factors that contributed to the crash along with specific details with respect to speed, direction, and positioning.

## SWAT

The Fort Bend Regional Special Weapons and Tactics (SWAT) team is a designated section of the Sheriff's Office whose members are tested, trained, and assigned to resolve critical incidents involving a threat to public safety using tactical resolutions. SWAT operations enable the safe apprehension of violent offenders, safe entry and control over scenes involving armed fugitives, and dynamic entry into dangerous scenes.

In 2022, four new members joined the team. SWAT conducted 22 operations including Armed Barricaded Subjects and High- Risk Search and Arrest Warrants. The team received new ballistic helmets, ballistic plates, and new helmet mounted communication devices.

## Crime Reduction Unit

The Crime Reduction Unit assists the Patrol Division in surveilling hot spot areas throughout the jurisdiction in efforts to reduce crime. Deputies deploy during peak offense time periods and identify criminal suspects when offense details are determined by crime analysis algorithms.

In 2022, the unit assisted the Fort Bend County District Attorney's Office with Operation MARGO (Multi-Agency Reinforcement Gang Operation). They also assisted the DA with Human Trafficking operations that resulted in multiple arrests for Promotion and Compelling of Prostitution. CRU assisted the CID Burglary and Theft unit with burglary operations that resulted in several suspects being identified and captured.

CRU attended several criminal interdiction trainings that were of great benefit in the arrests and contraband seizures the unit made throughout 2022.

The team assisted the George Ranch High School Law Enforcement SKILLS program with preparing for the SKILLS USA Competition. The building clearing team from George Ranch High School took 2nd place in the competition.

## Dive Team

The Sheriff's Office is a member of the Federal Emergency Management Agency Type 3 Dive Team. This regional asset is composed of Sheriff's deputies and Northeast Fort Bend County Fire Department divers who work and train together.

The team is under the command of the NEFBCFD Fire Chief, Travis Baxter. They hold quarterly training throughout the year to assist in calls for service in the region. The team uses an underwater remote operations vehicle, or ROV, for rapid deployments.

In 2022, The Sheriff's Office and the NEFBCFD entered in a collaborative agreement to store an FBCSO airboat in their facility. The Sheriff's Office will remain the owner of the airboat, which will be a shared vessel in the partnership to better deploy across the county.

## Reserves

Reserve volunteer deputies assist the Fort Bend County Sheriff's Office with special events and functions throughout the county where extra deputies are needed to augment on-duty units. There are currently 22 Reserves deputies dedicated to the Sheriff's Office. Reserve deputies include Fort Bend County residents who may work in a different field during the workweek who are certified by the Texas Commission on Law Enforcement and hold their licenses through the FBCSO.

## Take Me Home Program

The Take Me Home Program is under the Patrol Division and managed by Sgt. Matthew Hricko. The families of individuals with a cognitive impairment or a disability, and who are prone to wander, may register their family member by providing emergency contact information, which is entered into a database. In the event of an emergency, law enforcement officers may use the database to locate a missing individual or identify an individual if they are not able to communicate due to their disability.



In 2022, the program had 138 dependents registered and 352 law enforcement officers registered as searchers.

## Criminal Investigations Division

The Criminal Investigations Division is under the command of Major Rudy Castaneda and managed by Captain Dalia Simons.

There are five investigative units within the division. Investigators within CID manage over 20,000 case assignments annually. The tables below describe caseloads and number of cases managed.

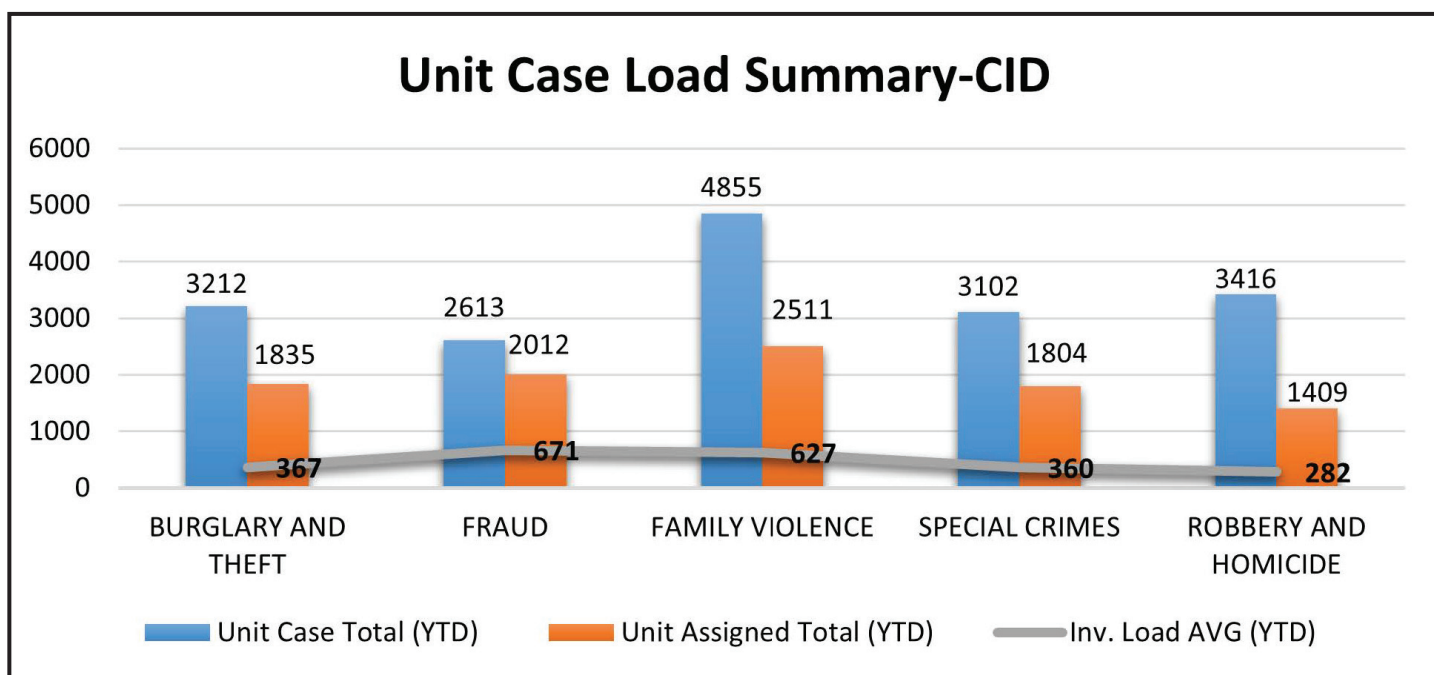

Investigative support units include Warrants and Crime Scene Investigators. The Warrants Unit is responsible for the apprehension of fugitives in addition to prisoner transports and out of state extraditions. The Crime Scene Unit is charged with the collection, retention, and processing of scene evidence.

Additional supporting personnel include the Crime Victim's Liaison and the Crime Analyst who assist in identifying crime trends, analyzing data, and completing mandated reporting to state and federal agencies.

The support units provide a valuable service to investigators by assisting with the processing of evidence, transportation of fugitives to and from various county detention facilities, and advocating and assisting crime victims, witnesses, and their families.

### **Homicide Case Study**

On December 12, 2020, at approximately 8:00 pm, Sheriff's deputies were dispatched to a double homicide investigation at the 300 Block of Broadmore Drive in Fresno, Texas. The victims were two brothers aged 15 and 17.

Investigators assigned to the Robbery/Homicide Unit took the lead by collecting and reviewing evidence, canvassing the area, and conducting interviews.

In April of 2022, detectives found breakthrough evidence leading to the identification of those responsible for the murders. The investigators' commitment, drive, and determination in this investigation led to the identification of all four murder suspects involved. Within 11 days of the suspects being identified, all four were placed in custody for Murder.

### **Cold Case Study**

On January 11, 2017, the Sheriff's deputies were dispatched to the 9300 block of FM 762 in Richmond, Texas regarding a vehicle fire. While extinguishing the fire, human remains were found inside the vehicle. Investigators attempted to identify the remains with minimal information and concluded the victim was a young mother of two.

In November of 2021, FBCSO Robbery/Homicide investigators were assigned to this challenging case to find those responsible. In December of 2022, a major break in the case developed with the assistance of the Texas Rangers, which resulted in an arrest warrant for Murder being obtained for the suspect. The team effort in identifying this suspect was a defining moment in this investigation.



### **Special Crimes Case Study**

On March 22, 2022, at approximately 2:45 pm, the Fort Bend County Sheriff's Office conducted an investigation of a sexual assault at a park located at the 4000 block of West Teal Estates Circle in Fresno, Texas. This incident occurred in broad daylight by an unknown suspect.

The crime scene was processed, evidence collected, and the area was canvassed. After further investigation, the suspect was successfully identified and arrested.

### **Burglary and Theft Case Study**

In July of 2022, investigators assigned to the Burglary and Theft unit coordinated an Organized Retail Theft Operation alongside Homeland Security Agents and Home Depot Investigators. Ultimately, two suspects were identified and apprehended for their involvement in an illegal fencing operation in Fort Bend County. Stolen property with an estimated value of \$50,130.00 and over \$100,000.00 in cash was seized during this operation.

## **Special Investigations Division**

The Special Investigations Division is under the command of Major Rudy Castaneda and managed by Captain Brad Whichard. The Special Investigations Division is composed of four units skilled at conducting proactive investigations.

### **Fort Bend County Narcotics Task Force**

The Fort Bend County Narcotics Task Force (FBCNTF) focuses on those engaging in offenses involving illicit narcotics on all levels and areas of Fort Bend County, inclusive of neighborhoods, schools, businesses, and thoroughfares.

The multi-agency task force is part of Houston High Intensity Drug Trafficking Area (HIDTRA) and is responsible for the disruption, dismantling, and prosecution of all narcotics trafficking organizations or individuals involved in the manufacture, transportation, distribution, sale and/or use of all illicit narcotics in or being transported through Fort Bend County.

In 2022, the Narcotics Task Force seized 623 kilograms (1,373 pounds) of illicit narcotics, over \$2.1 million in currency linked to narcotics trafficking, as well as 50 firearms from suspects involved in the trafficking of narcotics in Fort Bend County. Additionally, the task force conducted over 225 investigations, resulting in 110 arrests and the filing of 244 criminal charges against suspected offenders.

### **Case Study 1**

On November 15, 2022, the FBCNTF along with members of Fort Bend County Regional SWAT executed a search warrant at a residence in the 6300 block of Columbia Falls in Katy, Texas. The search resulted in the recovery of over 50 pounds of fentanyl that was prepared to be made into tablet form for distribution. Task Force investigators also recovered commercial equipment designed for the specific purpose of making pills, marijuana, ecstasy tablets, and three firearms, one of which was reported as stolen.

The suspect was taken into custody without incident. He was charged with multiple felony offenses, including two counts of Manufacture/Delivery of Controlled Substance, three counts of Unlawful Possession of a Firearm by a Felon, and Theft of Firearm. The quantity of fentanyl recovered in this case is capable of making in excess of 325,000 tablets of this deadly narcotic. The Sheriff's Office, in partnership with participating agencies of the task force, continue to focus on removing illicit narcotics and those who peddle them from our community.

### **Case Study 2**

Sheriff's Office investigators with the FBCNTF, in conjunction with Fort Bend County Precinct 4 Constable's Office, intercepted information of a murder-for-hire scheme involving a subject living in the Townewest area of Sugar Land. The suspect in this case is alleged to have solicited a third party to assassinate an area resident over a contractual dispute. The ensuing investigation resulted in the issuance of an arrest warrant for the suspect, who was taken into custody without incident at his residence, and charged with Conspiracy to Commit Murder, which is a second-degree felony. This investigation is ongoing and may result in a charge enhancement to Solicitation of Capital Murder, which is a first-degree felony.



## Auto Theft Unit

The Auto Theft Unit is responsible for the investigation of all stolen vehicles, organized theft rings, recovered vehicles, abandoned vehicles, and 68A Inspections, which is an inspection conducted by a law enforcement officer to verify the identity of a vehicle for registration purposes.

The unit also investigates criminal offenses associated with Auto Thefts, Unauthorized Use of Motor Vehicles, Burglary of Motor Vehicles, and vehicle-related Criminal Mischief. In 2022, the unit investigated over 3,000 cases.

In 2022, members of the Auto Theft Unit collaborated with the Pearland Police Department upon discovery that a major catalytic converter theft ring was using property located in Fort Bend County to conceal large quantities of catalytic converters. This resulted in the recovery of thousands of pounds of stolen catalytic converters and the arrest of five Pearland area residents.

## Gangs Unit

The Gang Unit pursues violent gangs through sustained, proactive, and coordinated investigations to obtain prosecutions on violations such as Racketeering, Drug Conspiracy, and Firearms. Investigations conducted in 2022 included Solicitation of Capital Murder, Murder, Human Trafficking and Narcotics Trafficking related offenses.

The unit, along with investigators in the pro-active Special Investigation Division, partnered with the Fort Bend County District Attorney's Office and law enforcement agencies in the county and state to focus on locations known to be frequented by gang members. This initiative spanned from January through March and resulted in more than 90 arrests and/or criminal charge filings.

# Detention Division

The Detention Division is under the command of Major Jacob Webb and managed by Detention Administration Captain Tim Chesser and Detention Operations Captain Sam Hayes.

The Fort Bend County Jail is comprised of three connected sections within the jail, totaling 1,783 beds with a holding cell capacity of 90. The sections include the newer East Tower, the West Tower, and the Old Jail. The average daily inmate population is approximately 770, including inmates from other counties.

The jail is inspected annually by the Texas Commission on Jail Standards. In April of 2022, the Fort Bend County Jail passed state inspection.

The Old Jail is under renovation and set to open in 2023.

The Fort Bend County Jail is a PREA (Prison Rape Elimination Act) facility. The mission of PREA is to eradicate prisoner rape in all types of correctional facilities. The Fort Bend County Jail became a PREA-certified facility in 2013. FBCSO was the first jail in the State of Texas to attain this certification. All detention staff attend PREA certification training when they are hired, and they are required to complete annual recertification. The division has deployed several new body scanners that detect metal in various places in the jail. It also utilizes the scanners during cell and housing unit searches. This helps maintain the safety and security of the facility and helps to combat the introduction of contraband.

The jail has onsite medical areas where inmates receive medical care as needed. Services available include dialysis, X-rays, and mental health support. In 2022, the division began conducting emergency first aid training for all employees who work in the jail and the courthouse, including the use of tourniquets. Recently, the jail added psychiatric technicians to its mental health program. This brings security, mental health, and the medical team together to better identify the specific mental health needs of the population.

In 2022, the division restored various inmate programs after being suspended during the COVID-19 pandemic. The division collaborated with its food vendor, Aramark, to provide an educational program known as "In2Work." The program gives inmates the opportunity to learn skills related to the food service industry. Upon completion, the inmate receives a certificate. Aramark then assists the inmate in finding a job in the food service industry upon release from custody.

In December of 2022, the FBCSO collaborated with Fort Bend County Behavioral Health for a program known as Children for Incarcerated Parents. The FBCSO Detention personnel and chaplains gathered gifts for the children of incarcerated family members. This event allowed inmates to write a personal note to their children, which was included in the delivery of gifts to the child. The children were allowed to have a virtual visit with their incarcerated parent through the Video Visitation program. This brought many children and their parents joy during the holiday season.

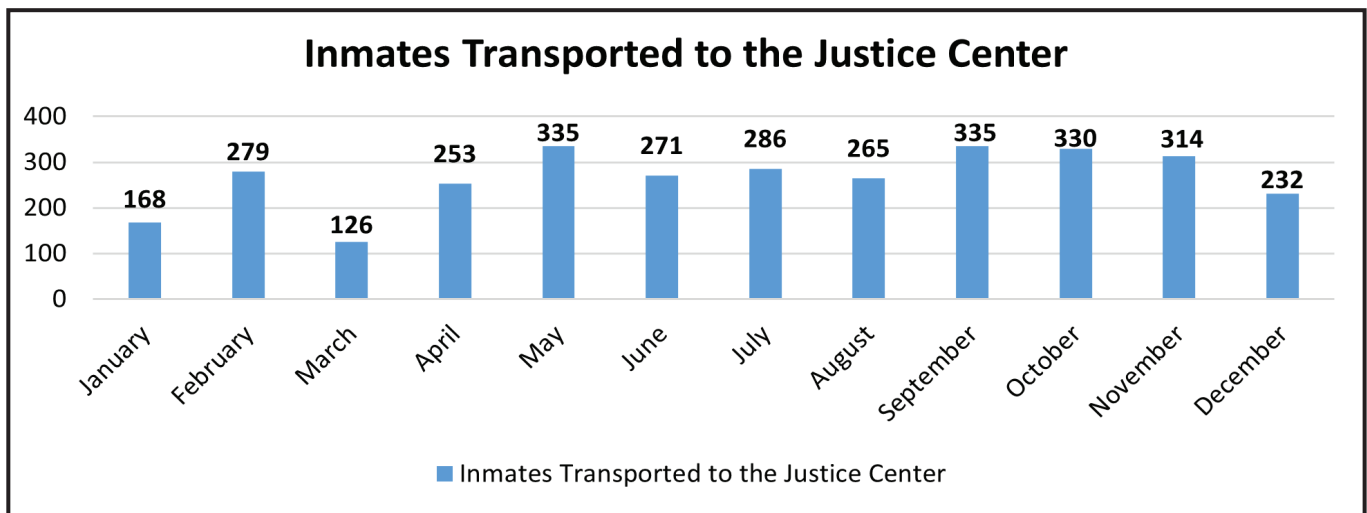

# Courts Division

The Courts Division is under the command of Captain Kevin Hunt. The Division includes Sheriff's deputies also known as bailiffs who secure the safety of the Fort Bend County Justice Center.

The Courts Division is also responsible for ensuring the safety of all courtroom work groups, including judges, prosecuting attorneys, witnesses, and others. Thus, court personnel are responsible for assisting in the orderly operations of the courts in Fort Bend County as well as the processing of detained persons and management of defendants.

There are 26 courts within the Justice Center. The Division also oversees sex offender registration in Fort Bend County.

In 2022, the Division completed 473 arrests within the courtroom and 212,695 people were screened upon entering the center. The Division completed 29 reports including risk-management, Use of Force, Texas Court Security incident reports and offense reports.

Throughout the year, the Division welcomes students from local schools to tour the center.

This Sheriff's Office initiative came to life in 2022, bringing together law enforcement agencies, school districts, and state representatives to collaborate and be prepared in the event of a crisis.

For 2023, our goals include department staffing growth, adding new technology to enhance operations, building collaborative relationships, and bridging the gap between law enforcement and the community.

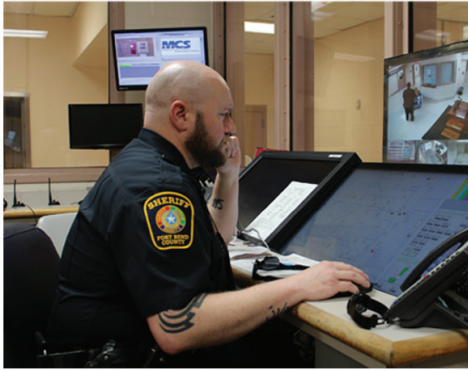
