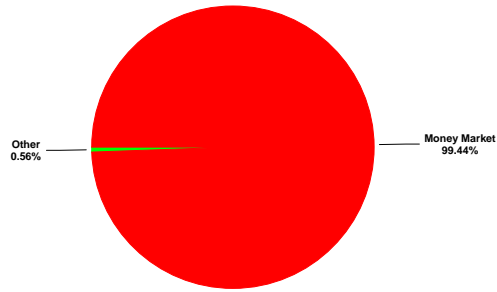

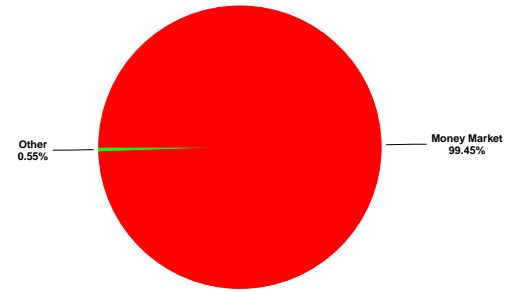

Portfolio Composition - 12/31/12

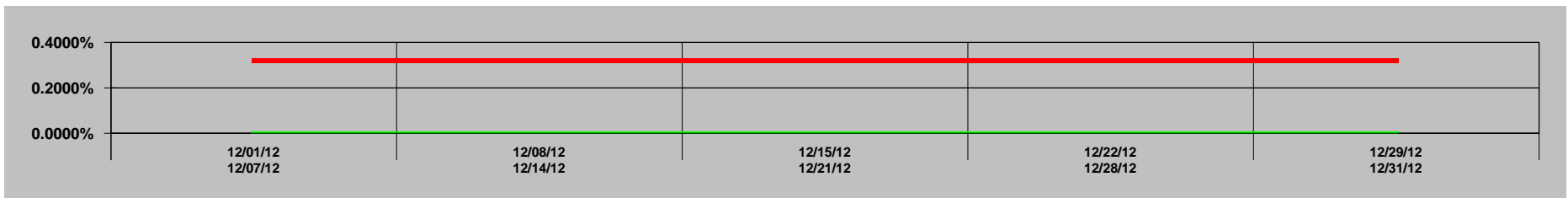


Maturity Aging - 11/30/12 vs 12/31/12

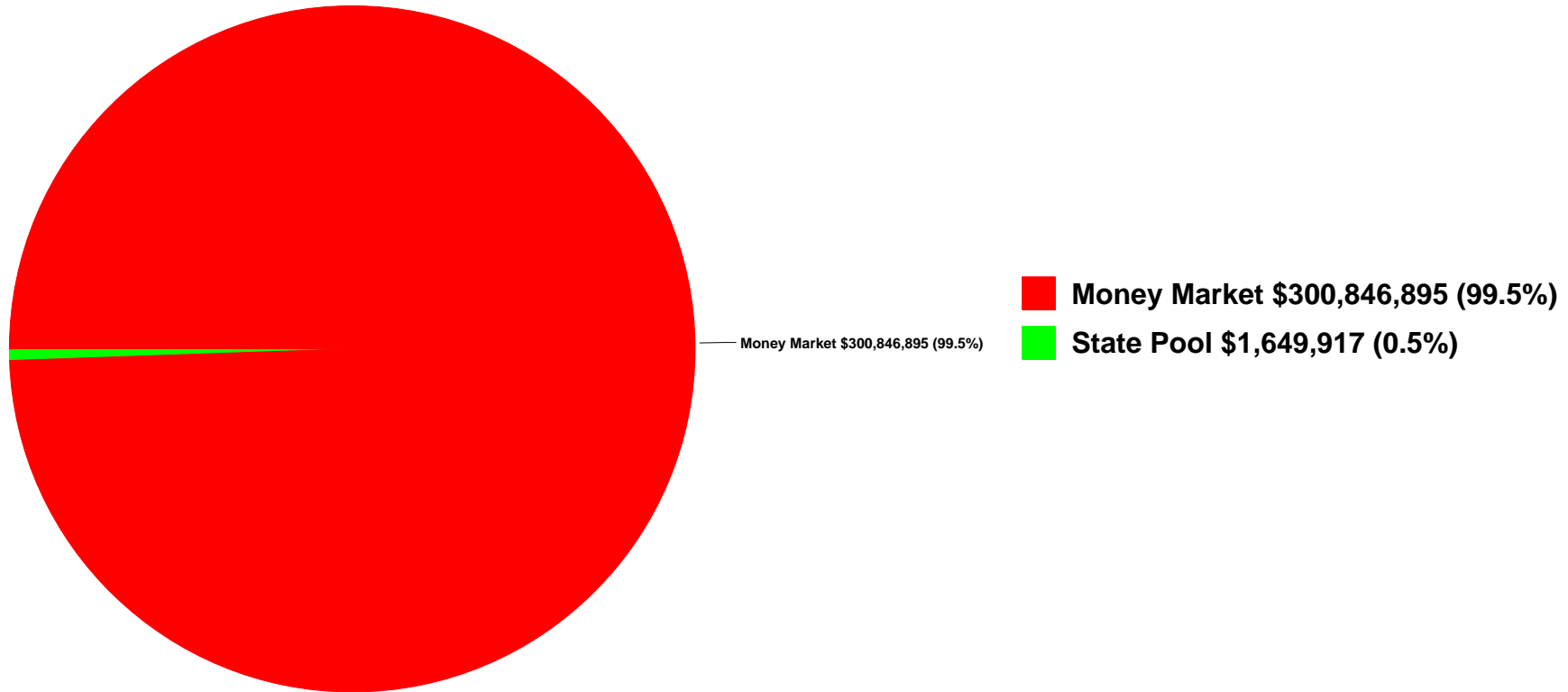

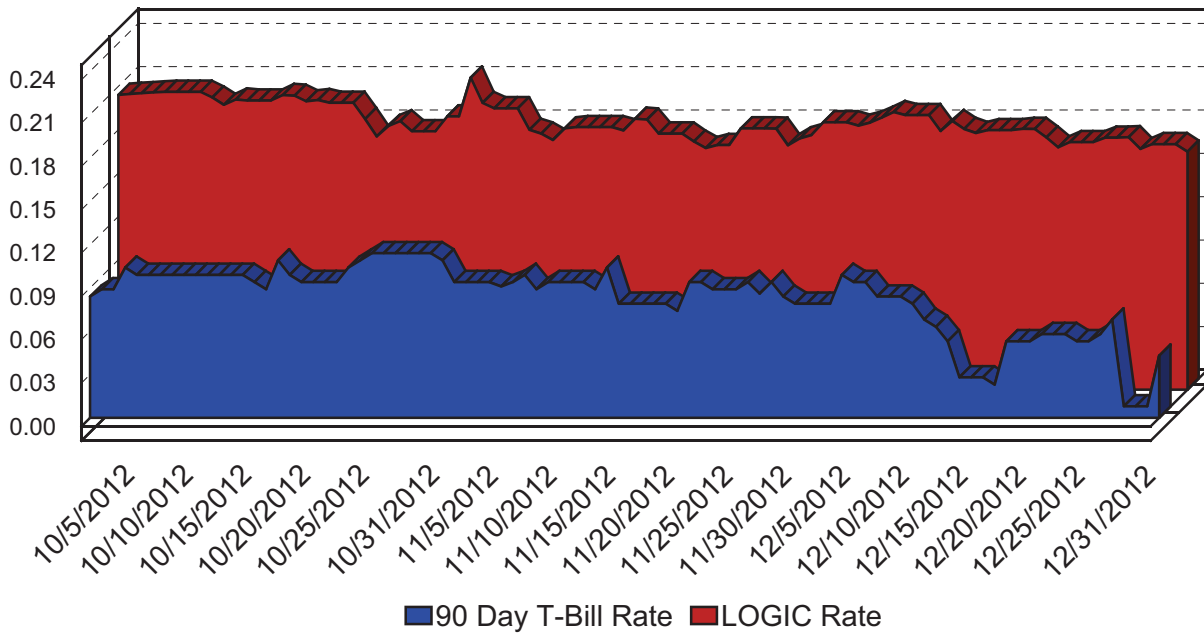
