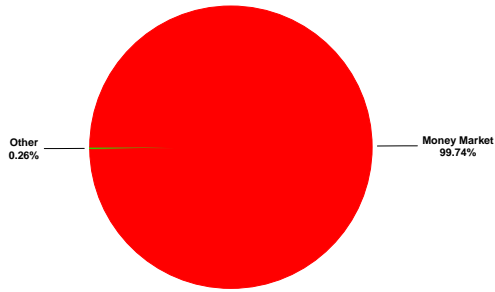

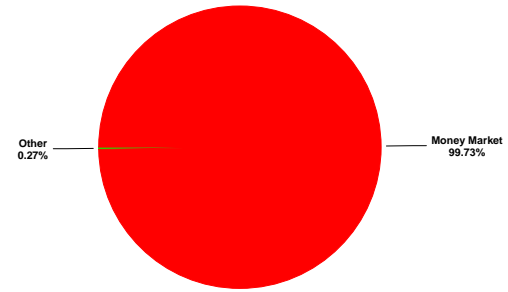

Portfolio Composition - 08/31/15

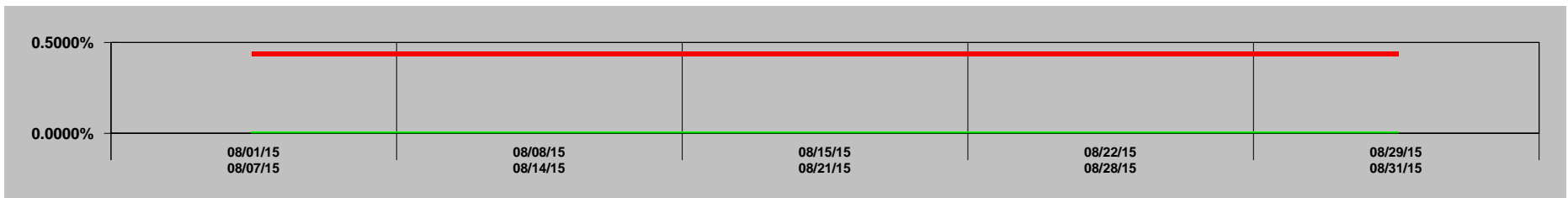


Maturity Aging - 07/31/15 vs 08/31/15

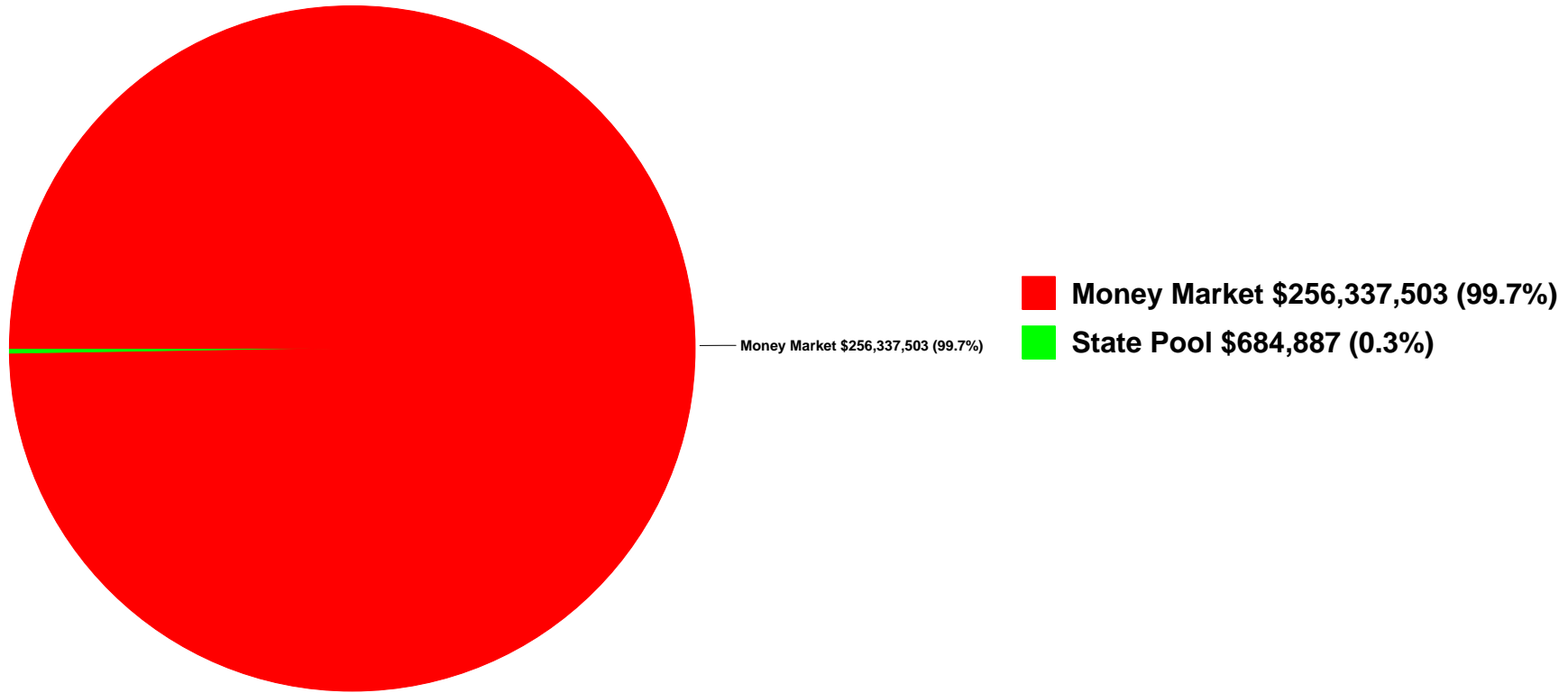

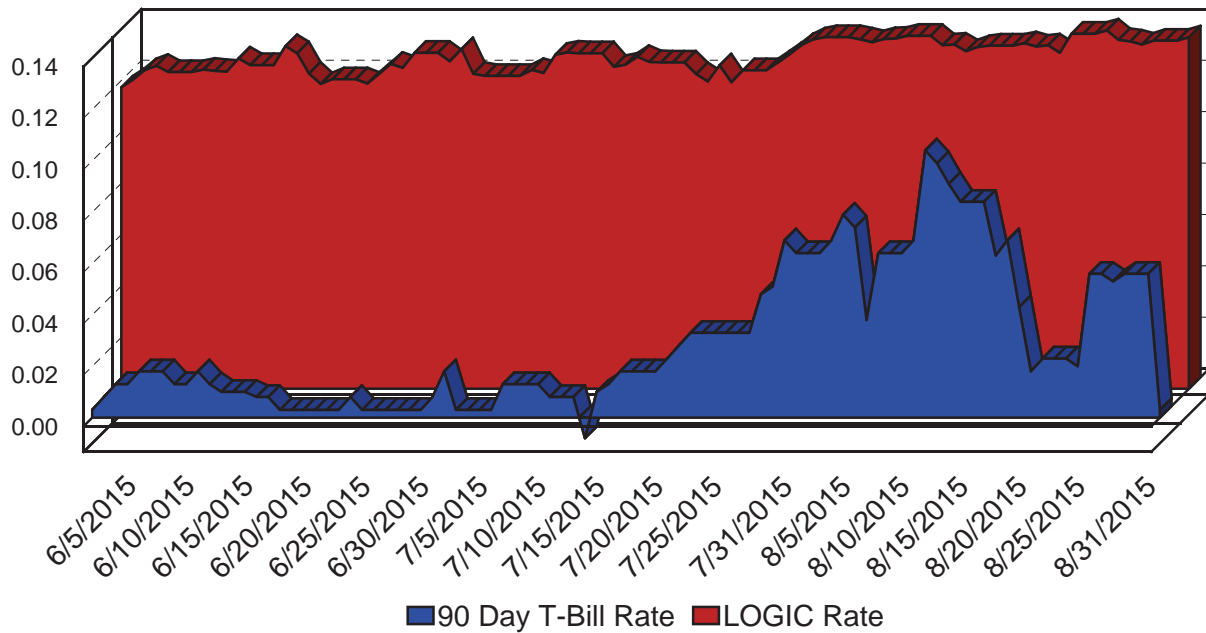
