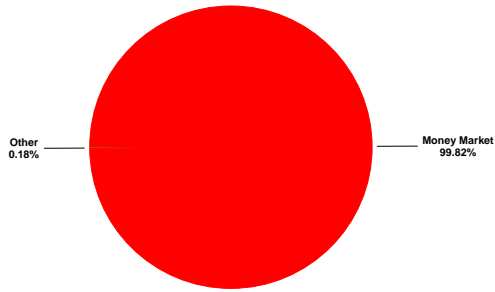

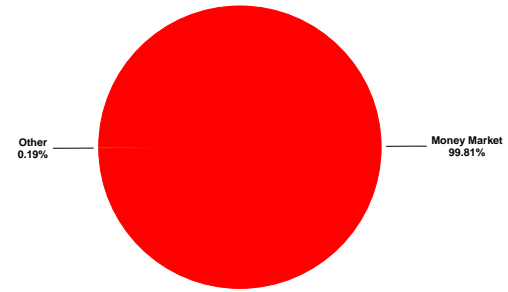

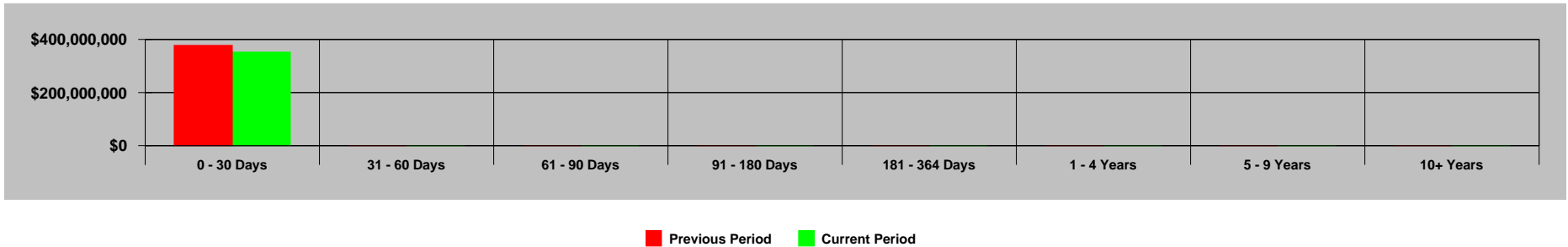
### Portfolio Composition - 03/31/16



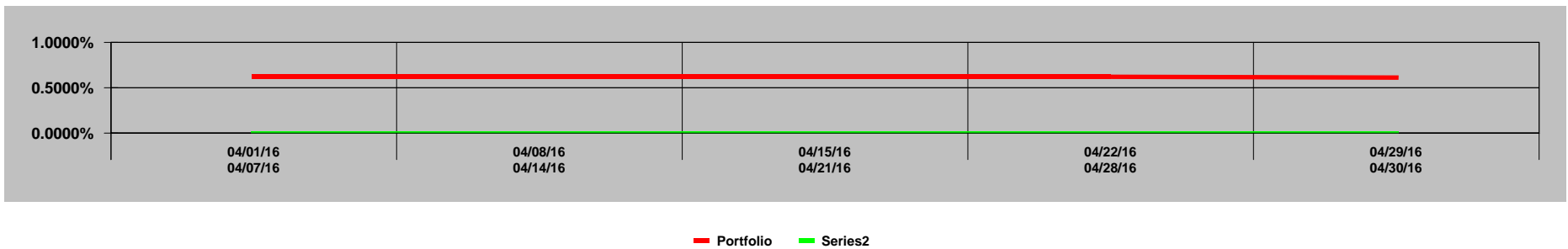
### Portfolio Composition - 04/30/16
